Re: Pazaruvaj.com As A Search Option In Firefox

Dear Zoltán:

Mozilla Corporation ("Mozilla") distributes the Mozilla Firefox browser ("Firefox") directly and indirectly throughout the world. In the interest of our mutual users, Mozilla has the ability to offer Pazaruvaj.com as a search option within one or more versions of Firefox. This would mean that a Firefox user would be able to select Pazaruvaj.com to do a search from one or more search access points within the Firefox browser.

This letter is to confirm the following:

- 1. Mozilla has the right, but not the obligation, to offer Pazaruvaj.com as a search option within one or more versions of Firefox. If Mozilla does decide to offer Pazaruvaj.com in one or more versions of Firefox, this will be done by Mozilla incorporating a search plug-in that incorporates a url and trademark/logo (together favicon, "URL & Favicon") to be provided by Provider.
- 2. Within thirty (30) days after signing this letter, Provider will provide Mozilla with the URL & Favicon. After receipt, Mozilla may incorporate the URL & Favicon in one or more versions of Firefox as elected by Mozilla. If Provider desires to have Mozilla include meta data to indicate searches are from Firefox, Mozilla may incorporate such meta data.
- 3. As between the parties, Mozilla is solely responsible for Firefox, and Provider is solely responsible for Pazaruvaj.com and the URL & Favicon and any meta data provided.
- 4. Provider confirms to Mozilla that it has the necessary rights to authorize Mozilla to offer Pazaruvaj.com as a search option, including the URL & Favicon and meta data, within Firefox as set forth in this letter.
- 5. Either party may terminate this letter at any time, with or without cause, upon at least ninety (90) days prior written notice by sending such notice to the applicable address set forth in this letter (as such address may be changed by either party). Upon termination, Mozilla will remove Pazaruvaj.com from all future builds of Firefox; provided, that Provider understands that any versions of Firefox previously distributed may still have Pazaruvaj.com unless and until the end user updates Firefox to a subsequent version of Firefox without Pazaruvaj.com.
