To whom it may concern,

This is to confirm that LSTI¹ has audited the CAs of British Telecommunications plc as stated in the table here-below.

The audit was performed as an initial full audit at British Telecommunications' location in *United Kingdom*. It took place from 25/06/2018 until 28/06/2018 and covered the period from 25/06/2017 to 28/06/2018. The next assessment has to be carried out before the next 28/06/2020 to maintain the eIDAS² conformity. The audit was performed according to the European Standards *"ETSI EN 319 411-1, V1.1.1 (2016-02)" and "ETSI EN 319 401, V2.1.1 (2016-02)"* considering the requirements of the *"ETSI EN 319 403, V2.2.2 (2015-08)"*. Only the subset of requirements that concern the certificate operations (Managed PKI service Provider) as been audited.
