The audit was performed as full annual audit at the TSP's location in *United Kingdom*. It took place from 06/17/2019 until 06/21/2019 and covered the period 06/28/2018 to 06/21/2019.

The audit was performed as a full audit and has been documented in a specific report.

The next assessment has to be successfully carry out before 06/21/2021 in order to issue a new audit attestation letter as stated in the corresponding certificates issued by LSTI.

The audit was performed according to the European Standards "ETSI EN 319 401 V2.2.1 (2018-04)" and "ETSI EN 319 411-1, V1.2.2 (2018-04)" and "Baseline Requirements, version 1.6.5" considering the requirements of the "ETSI EN 319 403, V2.2.2 (2015-08)" for the Trust Service Provider Conformity Assessment. Only the subset of requirements that concern the certificate operations (Managed PKI service Provider) as been audited.
