Evaluation Details

Our engagement included a full evaluation which took place between 2019-01-14 and 2019-01-23 at the following premises of ADACOM SA.

- 25, Kreontos Str. 10442 Athens – Greece (Seat/DR site)
- 190 Syngrou Str. 17671 Athens – Greece (Main operations)

The evaluation covered the period from 2017-06-01 until 2018-01-30 (period-of-time). It was performed according to the European Standards “ETSI EN 319 411-1, V1.1.1 (2016-02)” and “ETSI EN 319 401 v2.1.1 (2016-02)” as well as the applicable CA/B Forum “Baseline Requirements, version 1.5.5” and “Mozilla Root Store Policy, version 2.5” requirements.
