Unqualified Opinion (Period of Time)
Independent Auditor's Report

To the Management of SwissSign AG

We have examined that SwissSign AG, ("SwissSign") management's assertion during the period July 16, 2009 through June 30, 2010 for its Certification Authority (CA) operations in Glattbrugg, Switzerland has:

- Disclosed its EV Certificate life cycle management practices and procedures, including its commitment to provide EV Certificates in conformity with the CA/Browser Forum Guidelines, and provided such services in accordance with its disclosed practices.
- Maintained effective controls to provide reasonable assurance that:
 - EV Subscriber information was properly collected, authenticated (for the registration activities performed by SwissSign) and verified, and
 - The integrity of keys and EV certificates it manages is established and protected throughout their life cycles,

in accordance with the WebTrust for Certification Authorities – Extended Validation Audit Criteria. WebTrust for Certification Authorities - Extended Validation Criteria.

This assertion is the responsibility of SwissSign's management. Our responsibility is to express an opinion based on our examination.

Our examination was conducted in accordance with International Assurance Engagement Standards and, accordingly, included

- (1) obtaining an understanding of SwissSign EV certificate life cycle management practices and procedures, including its relevant controls over the issuance, renewal and revocation of EV certificates,
- (2) selectively testing transactions executed in accordance with disclosed EV certificate life cycle management practices,
- (3) testing and evaluating the operating effectiveness of the controls, and
- (4) performing such other procedures as we considered necessary in the circumstances.

We believe that our examination provides a reasonable basis for our opinion.


In our opinion, SwissSign management's assertion, as referred to above, is fairly stated, in all material respects, in accordance with the WebTrust for Certification Authorities - Extended Validation Audit Criteria.

The relative effectiveness and significance of specific controls at SwissSign and their effect on assessments of control risk for subscribers and relying parties are dependent on their interaction with the controls, and other factors present at individual subscriber and relying party locations. We have performed no procedures to evaluate the effectiveness of controls at individual subscriber and relying party locations.


