Report of Independent Auditors

To the Management of Certsign SRL:

We have examined [management's assertion](#) that in providing its Certification Authority (CA) services known as certSIGN in Bucharest, Romania, as Root CA, during the period 15 September 2007 through 15 October 2008, Certsign SRL has:

- Disclosed its key and certificate life cycle management business and information privacy practices and provided such services in accordance with its disclosed practices as follows:

- Maintained effective controls to provide reasonable assurance that:
 - Subscriber information was properly authenticated for the registration activities performed by Certsign SRL;
 - The integrity of keys and certificates it managed was established and protected throughout their life cycles;
 - Subscriber and relying party information was restricted to authorized individuals and protected from uses not specified in the CA's business practice disclosure;
 - The continuity of key and certificate life cycle management operations was maintained, and
 - CA systems development, maintenance and operations were properly authorized and performed to maintain CA systems integrity,

based on the AICPA/CICA Trust Services [\[AICPA/CICA WebTrust for Certification Authorities Criteria\]](#) .

Certsign SRL management is responsible for its assertion.

Our responsibility is to express an opinion on management's assertion based on our examination.

Our examination did not extend to the controls of individual subscribers or relying party locations.

Note *: the document is not available to the general public using this specific name; Certsign includes the privacy policy as a distinct chapter in the Certification Practice Statement and also states on its website that the information owned by Certsign is obtained, saved and processed according to the Romanian Law of Protecting Personal Data (677/2001) and Processing Personal Data and Privacy Protection in Electronic Communication (506/2004)

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and, accordingly, included (1) obtaining an understanding of Certsign SRL key and certificate life cycle management business and information privacy practices and its controls over key and certificate integrity, over the authenticity and privacy of subscriber and relying party information, over the continuity of key and certificate life cycle management operations and over development, maintenance and operation of systems integrity; (2) selectively testing transactions executed in accordance with disclosed key and certificate life cycle management business and information privacy practices; (3) testing and evaluating the operating effectiveness of controls; and (4) performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.

In our opinion, Certsign SRL's management's assertions referred to above are fairly stated, in all material respects, based on the [AICPA/CICA WebTrust for Certification Authorities Criteria](#)

Because of inherent limitations in controls, error or fraud may occur and not be detected. Furthermore, the projection of any conclusions, based on our findings, to future periods is subject to the risk that the validity of such conclusions may be altered because of (1) changes made to the system or controls, (2) changes in processing requirements, (3) changes required because of the passage of time, or (4) degree of compliance with the policies and procedures.

The relative effectiveness and significance of specific controls at Certsign SRL and their effect on assessment of control risk for subscriber and relying parties are dependent on their interaction with the controls and other elements present at individual subscriber and relying party locations. We have not performed procedures to evaluate the effectiveness of controls at individual subscriber and relying party locations.

This report does not include any representation as to the quality of Certsign SRL's CA services beyond those covered by the WebTrust for Certification Authorities Criteria for the services known as certSIGN in Bucharest, Romania, or the suitability of any of Certsign SRL's services for any customer's intended purpose.

CERTSIGN SRL operates as a certification authority (CA). CERTSIGN, as a root CA, provides the following CA services:

- Subscriber registration
- Certificate renewal
- Certificate issuance
- Certificate distribution (using an online repository)
- Certificate revocation
- Certificate status information processing (using an online repository)

Management of CERTSIGN is responsible for establishing and maintaining effective controls over its CA operations, including CA business practices disclosure in its Certificate Practice Statements on its web site, www.certsign.ro, service integrity including key and certificate life cycle management controls, and CA environmental controls. These controls contain monitoring mechanisms, and actions are taken to correct deficiencies identified.

Management of CERTSIGN SRL acknowledges that there are inherent limitations in any controls, including the possibility of human error and the circumvention or overriding of controls. Consequently, even effective controls can provide only reasonable assurance with respect to CERTSIGN's CA operations. Furthermore, because of changes in conditions, the effectiveness of controls may vary over time.

Management has assessed the controls over its CA operations.

Based on that assessment, in CERTSIGN SRL management's opinion, while providing its CA services at Bucharest, Romania during the period from *September, 15, 2007* through *October, 15, 2008* CERTSIGN SRL:

- 1) Disclosed its key and certificate life cycle management business and information privacy practices and provided such services in accordance with its disclosed practices, described in the CPS that can be found at www.certsign.ro
- 2) Maintained effective controls to provide reasonable assurance that:
 - Subscriber information was properly authenticated for the registration activities performed by CERTSIGN srl

- The integrity of keys it managed was established and protected throughout their life cycles
- The integrity of certificates it managed was established and protected throughout their life cycles
- 3) Maintained effective controls to provide reasonable assurance that:
 - Subscriber and relying party information was restricted to authorized individuals and protected from usage not specified in the CA's business practices disclosure;
 - The continuity of key and certificate life cycle management operations was maintained; and
 - CA systems development, maintenance, and operations were properly authorized and performed to maintain CA systems integrity based on the AICPA/CICA WebTrust for Certification Authorities criteria -
