Report of Independent Accountants

To the Management of Start Commercial

We have examined the accompanying assertion by the management of Start Commercial Ltd. (hereafter: StartCom) that in generating the Root CA: StartCom Public Root on February 08, 2011 at the Eilat, Israel location, StartCom has maintained effective controls to provide reasonable assurance that the Root CA "StartCom Certification Authority G2" was protected in conformity with the StartCom Key Generation Procedures. These assertions are the responsibility of StartCom Management. Our responsibility is to express an opinion on management's assertion based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants, and accordingly, included (1) obtaining an understanding of StartCom's procedures and controls over generating the Root CA, (2) testing and evaluating the operating effectiveness of the controls, (3) discussing the Root CA key protect procedures described in the Root Key Generation Procedures being performed on February 08, 2011 and (4) performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.

Because of inherent limitations in controls, error or fraud may occur and not be detected. Furthermore, the projection of any conclusions, based on our findings, to future periods is subject to the risk that the validity of such conclusions may be altered because of changes made to the system or controls, the failure to make needed changes to the system or controls, or a deterioration in the degree of effectiveness of the controls.

In our opinion, StartCom management's assertion referred to above is fairly stated, in all material respects, as of February 08, 2011, based upon the criteria specified by management in Attachment A accompanying the report.
