<u>Report of Independent Accountants</u>

To the Management of Comsign Ltd.

We have audited the <u>assertion</u> by the management of Comsign Ltd (Comsign) that in ; providing its SSL Certification Authority (CA) services at the Atidim Teach Park, building #4 Tel-Aviv, Israel's location for the Root Key "Comsign Global Root CA" during the period from April 27, 2015 through April 26, 2016, Comsign has:

- Disclosed its Certificate practices and its commitment to provide SSL Certificates in conformity with the applicable CA Browser Forum Guideline.
- Maintained effective controls to provide reasonable assurance that:
 - Subscriber information was properly collected, authenticated (for the registration activities performed by Comsign) and verified;
 - The integrity of keys and certificates it manages was established and protected throughout their life cycles ;
 - Logical and physical access to CA systems and data was restricted to authorized individuals;
 - The continuity of key and certificate management operations was maintained; and
 - CA systems development, maintenance and operations were properly authorized and performed to maintain CA systems integrity.
