Hey Lori,  
In answer to your email from yesterday - pls see email I sent dated Jan 13 and my further explanation below.

The way I read the contract and the SOW A1 are valid until an active termination in writing by one of the parties.

These are the clauses (see below) that lead me to believe we are good for another year (2014) and do not need to execute anything further.

What I don't know how your new PO system fits into this and whether we need an updated PO# for SOW A1 for 2014? Leave that one up to you...

Contract:

"12.1 Term. This Agreement takes effect on the Effective Date and will continue until the earlier of: (i) the End Date in the currently applicable SOW or (ii) termination as provided below. Should the parties agree to enter into another SOW, this Agreement will be

considered to be in effect for the duration of that SOW."

SOW A1:

"• This SOW will auto-renew for another one year term unless one of the parties advises the other in writing that it does not wish to renew."

Let me know. We are fine under the current terms of the above contract and SOW to continue and will (like with the iPad project) provide draft SOWs if necessary for the projects of greater than \$5K.
