## INSTRUCTIONS TO BIDDERS

Before bidding, read the following instructions and comply with the terms and conditions as outlined below.

- 1. Bidder completes the front side of Bid Sheet.
  - .Type or print name, company, address, city, state, zip, and phone number in the space provided on the upper portion of the form.
  - .Type or print in the appropriate line(s) the bid amount(s) for the item(s) you are bidding on.
- 2. Vehicles may not pass State Inspection in All Counties in N.C.
- 3. Bidder has the responsibility to have the bid sheet in the SSPA warehouse location prior to the specified time and date of the bid opening. Bid sheets may be submitted as follows:
  - .Bidder places bid sheet in the bid box in the lobby of the SSPA warehouse.
  - .Bidder may mail bid sheet.
  - .Bidder may forward bid sheet by Express Mail provider.
  - .Bidder may FAX bid (Fax number 919-854-2275), however any faxed bid must include the bid document with a signature. Any bid that is faxed must be received no later than 1:00 p.m. on the bid opening date.
- 4. Bidder need not be present at bid opening.
  - .Bidder(s) awarded high bid(s) will be notified by mail of the award.
  - Bidder(s) may call beginning 9:00 a.m. on the day following bid opening day to ascertain high bids awarded.

## TERMS AND CONDITIONS OF SALES

- 1. The State of North Carolina, Department of Administration, State Surplus Property Agency reserves the right to reject any or all bids.
- 2. The description of property offered for sale has been compiled from available data, and there is no guarantee or warranty on the part of State Surplus Property Agency as to number, condition or quality, or that the property offered or a portion thereof may be withdrawn prior to the sale. Under no circumstances will a refund or adjustment be made on account of property not coming up to the standard expected, nor will failure to inspect be considered grounds for claim. All property is sold "As is" and "Where is" and any costs of weighing, packaging, crating, loading, or hauling shall be assumed by bidder unless otherwise indicated.
- 3. Bidders are invited and urged to inspect said property prior to submitting bids. Reasonable opportunity will be afforded for inspection up to the time for opening bids, but no labor will be furnished for such purposes. The Purchaser is to assume all liability for the property after award is made. The State will exercise its usual care for protection up to the time of removal, but will not be responsible for any loss or damage whatsoever.
- 4. All payments must be in the form of cashier's or certified check or money order. Payment in full for all property purchased must be made within fifteen (15) calendar days from the date of award, and all property purchased must be removed within fifteen (15) calendar days from the date of award. No property may be removed by the purchaser prior to full payment of the purchase price. The terms "bid opening date" and "date of award" are considered to be one and the same.
- 5. If purchaser fails to pay for the property within fifteen (15) calendar days from date of award, the property purchased will be promptly re-sold in such a manner as the State may elect and the defaulting purchaser charged with the loss to the State, if any, together with all expenses of the sale. If the purchaser does not remove the property purchased within fifteen (15) calendar days after date of award, State Surplus Property Agency reserves the right to retain the purchase price and resell the property a second time, keeping any and all proceeds obtained and placing bidder on default.
- 6. Certified/Cashier's checks or postal money orders, should be made payable to: State Surplus Property Agency. Payments may be made at the selling agency site if the site will accept payment. Customers must confirm in advance if payments are accepted at the respective sites.
- 7. State Surplus Property Agency reserves the right to require any bidder presently or previously in default to post a bond prior to bidding, or prior to consideration of his bid. Anyone in default is prohibited from bidding in anyone else's name or have someone else bid in the defaulted party's behalf.
- 8. No lump sum bids will be accepted. Bidders must bid on line items as such.
