# AMERICAN LEAGUE RULES 2009-10

The league will rotate early and late games with the National League every game day. Games will start promptly at 8:30 and 10:00 until changes are needed due to cold weather. Each team will play 2 games per week. It will be a 7 inning game with no mercy rule. This will count in the standings and should be recorded by circling the winning team on the schedule on the bulletin board. After the official game is finished, the teams can play additional innings to fill up the time slot. If a team cannot field at least 6 players it will forfeit the game and a win will be recorded for the other team. If both teams cannot field at least 6 players the game will not be recorded in the standings and a pickup game can be played using players off the fence, if necessary.

When a team(s) is short a player(s) they may select a LIKE CALIBER player from the idle American League team. There will be only 10 players in the field regardless of how many players are present. All players will be in the batting order. Each player on the starting game roster must play at least 5 innings in the field. If no outside umpire is available, participating teams will furnish umpire (s).

SSUSA rules will be followed unless otherwise specified.

1. Runners will be allowed from home plate only if the player being replaced is injured during the game being played.
2. All bats are allowed except Gray Miken
3. Balls will be 44 core 3.75 average.
4. Pitching Screen: The screen will be placed 18 inches to the left and 3 feet in front of the pitching rubber. (left for left handers). If the pitcher opts not to use the screen it will be turned parallel to a line from home plate to second base 18 inches left of the rubber.
5. CURSING; First offense gets a warning from the umpire; Second offense in the same game will result in ejection.
6. Team managers are responsible for the conduct of their players.
7. Limit of 5 runs per team per inning except unlimited in the last inning. If the game is not completed 10 minutes prior to the start of the next game, the inning in progress will be completed and the game is ended, even if the score is tied. If 1 team is ahead by 10 or more runs after the second to last inning, the losing team will bat again. If they catch up the other team gets their at bat.
8. Calling balls and strikes; On an adverse weather day, and with both managers agreeing, only strikes will be called and the umpire will be informed of this decision. If the weather improves, the umpire, with the agreement of both managers, may begin to call balls and strikes after any completed inning. If the managers cannot agree the umpire will make the decision.
9. Any foul tip caught by the catcher results in an out.
10. All protests and concerns must be directed to the Commissioner from managers only.
11. Any rule dispute or question on the field is to be handled by the umpire (s) and the respective managers. NO PLAYERS are to be involved other than the managers.
12. New players who join after the league starts will play 3 games on a team (s) as determined by the player placement committee which is made up of the managers and the commissioner.
13. LOCAL: A batted ball that hits the screen is a dead ball. (No pitch)
14. BATTER/RUNNER REACHING FIRST BASE • §8.3(1) • The Batter/Runner failing to touch the portion of the double bag extending into foul territory (orange portion) was previously at risk to be put out for failing to do so, but only by an appeal play. The rule is amended to make this the umpire's call without an appeal and now conforms to the similar treatment governed by §8.8(2) for CROSSING OR TOUCHING HOME PLATE/MAT, which is not an appeal play. Please note a runner can touch the white bag on a play at first base in order to avoid a collision without penalty. Generally this happens with a throw to 1st from foul territory or one that causes the fielder (1st baseman) to go into foul territory to retrieve an errant throw. A runner can touch either bag when there is no play at 1st base.
15. The four foot line in front of the batters box will be used. The batter may touch the line, but no part of his foot may be outside it. Any player who attempts to obliterate or erase the line will be called out.

## NATIONAL LEAGUE RULES 2009-10

The league will rotate early and late times with the American League. Each team will play 2 games per week. Games will be 7 innings (time permitting) with no mercy rule. Results will be recorded by circling the winning team on the schedule posted on the bulletin board.

SSUSA softball rules will apply except as specified below.

1. Cursing or belligerent behavior will result in ejection, at the umpire and/or managers discretion. Preferred additional discipline will be referred to the Commissioner.
2. Only managers and umpire will settle disputes. If they cannot agree the Commissioner or his designee will rule.
3. All bats are allowed, and balls will be 44 core 3.75 average.
4. Run through is allowed at all bases.
5. Infielders must stay off the infield and outfield grass until the ball is hit.
6. Outfielders must stay beyond the 150 foot marker until the ball is hit. The middle infielder must decide if he is going to play infield or outfield before the ball pitched. If he chooses to play outfield, then he must adhere to the 150 ft. rule.
7. Scoring is limited to 5 runs per inning, except for the 7th inning.
8. A walked batter must advance to 1st base.
9. Any batter may request a substitute runner. A substitute runner from home must run from at least six feet behind the front of home plate.
10. All players will be in the batting order and will play a minimum of every other inning in the field.
11. On windy days both managers may agree to calling strikes only.
12. Players needed to fill a team roster will be picked from the fence. First pick goes to the team that is lowest in the standings. Players will be selected off the fence in the order they arrived at the ballpark. Players picked off the fence will bat after all regular players have batted in the lineup.
13. The infield fly rule will be in effect for all games.
14. No new inning will start within 10 minutes of the next scheduled game time. If tied, log it as a tie.
15. The batter is out on any foul ball caught (no height limit).
16. A batter can be thrown out at first base from the outfield, unless the age of the batter is 80 or older.
17. BATTER/RUNNER REACHING FIRST BASE • §8.3(1) • The Batter/Runner failing to touch the portion of the double bag extending into foul territory (orange portion) was previously at risk to be put out for failing to do so, but only by an appeal play. The rule is amended to make this the umpire's call without an appeal and now conforms to the similar treatment governed by §8.8(2) for CROSSING OR TOUCHING HOME PLATE/MAT, which is not an appeal play. Please note a runner can touch the white bag on a play at first base in order to avoid a collision without penalty.
