

## LinkedIn Example Bug License Agreement

This License Agreement (the "Agreement") is a binding legal agreement between Licensees (as defined below) and LinkedIn Corporation ("LinkedIn"). By using the example bug content provided in the email to which this is attached ("Licensed Materials"), you agree to be bound by the terms of this Agreement. If you do not agree to these terms, do not use, and delete, the Licensed Materials.

**1. License.** Subject to the terms of this Agreement, LinkedIn hereby grants the main developers of PDFBox ("Licensees") a non-exclusive, non-transferable copyright license, for internal use only, to make a reasonable number of copies of the Licensed Materials for the sole purpose of fixing PDFBox (the "Purpose").

### **2. Restrictions and Intellectual Property.**

- a. You may not use, modify, copy, make derivative works of, publish, distribute, rent, lease, sell, sublicense, assign or otherwise transfer the Licensed Materials, except as expressly set forth above in Section 1. Licensees agree not to use Licensed Materials except for the Purpose.
- b. LinkedIn (and its licensors) retains its intellectual property rights in the Licensed Materials. Except as expressly set forth in Section 1, LinkedIn grants no licenses.

**3. Warranty Disclaimer.** LINKEDIN PROVIDES THE LICENSED MATERIALS ON AN "AS IS" AND "AS AVAILABLE" BASIS. LINKEDIN MAKES NO REPRESENTATION OR WARRANTY, WHETHER EXPRESS OR IMPLIED, ABOUT THE LICENSED MATERIALS, INCLUDING ANY REPRESENTATION THAT THE LICENSED MATERIALS WILL BE FREE OF ERRORS, BUGS OR INTERRUPTIONS, OR THAT THE LICENSED MATERIALS ARE ACCURATE, COMPLETE OR OTHERWISE VALID. TO THE FULLEST EXTENT PERMITTED BY LAW, LINKEDIN AND ITS AFFILIATES DISCLAIM ANY IMPLIED OR STATUTORY WARRANTY OR CONDITION, INCLUDING ANY IMPLIED WARRANTY OR CONDITION OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AVAILABILITY, SECURITY, TITLE AND/OR NON-INFRINGEMENT. **4. Limitation of Liability.** LINKEDIN SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, PUNITIVE, CONSEQUENTIAL OR EXEMPLARY DAMAGES, INCLUDING BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROFITS, GOODWILL, USE, DATA OR OTHER INTANGIBLE LOSSES . IN NO EVENT WILL LINKEDIN'S AGGREGATE LIABILITY TO YOU EXCEED \$100. THIS LIMITATION OF LIABILITY SHALL:

1. APPLY REGARDLESS OF WHETHER (A) YOU BASE YOUR CLAIM ON CONTRACT, TORT, STATUTE, OR ANY OTHER LEGAL THEORY, (B) WE KNEW OR SHOULD HAVE KNOWN ABOUT THE POSSIBILITY OF SUCH DAMAGES, OR (C) THE LIMITED REMEDIES PROVIDED IN THIS SECTION FAIL OF THEIR ESSENTIAL PURPOSE; AND
2. NOT APPLY TO ANY DAMAGE THAT LINKEDIN MAY CAUSE YOU INTENTIONALLY OR KNOWINGLY IN VIOLATION OF THESE TERMS OR APPLICABLE LAW, OR AS OTHERWISE MANDATED BY APPLICABLE LAW THAT CANNOT BE DISCLAIMED IN THESE TERMS.

**5. Termination.** This Agreement automatically terminates upon your breach of this Agreement or notice of termination by LinkedIn in its sole discretion for no reason or any reason. On termination, all licenses granted under this Agreement will terminate immediately and you will delete the Licensed Materials. Sections 2-6 of this Agreement survive any termination of this Agreement. LinkedIn may discontinue the availability of some or all of the Licensed Materials at any time for any reason.

**6. Miscellaneous.** This Agreement will be governed by and construed in accordance with the laws of the State of California without regard to conflict of laws principles. The exclusive forum for any disputes arising out of or relating to this Agreement shall be an appropriate federal or state court sitting in the County of Santa Clara, State of California. If LinkedIn does not act to enforce a breach of this Agreement, that does not mean that LinkedIn has waived its right to enforce this Agreement. The Agreement does not create a partnership, agency relationship, or joint venture between the parties. Neither party has the power or authority to bind the other or to create any obligation or responsibility on behalf of the other. You may not, without LinkedIn's prior written consent, assign or delegate any rights or obligations under these terms, including in connection with a change of control. Any purported assignment and delegation shall be ineffective. The Agreement shall bind and inure to the benefit of the parties, their respective successors and permitted assigns. If any provision of the Agreement is unenforceable, that provision will be modified to render it enforceable to the extent possible to give effect to the parties' intentions and the remaining provisions will not be affected. This Agreement is the only agreement between you and LinkedIn regarding the Licensed Materials, and supersedes all prior agreements relating to the Licensed Materials.
