



## Declaration regarding Conflicts of Interest and Financial Associations

### Eligibility Criteria and Conditions

To be eligible to become a Member Candidate, and ultimately a Director (if elected), an individual shall:

- consent to be a Nominee, a Candidate and if elected, a Director; and on the day the Election Period begins, meet the "Qualification" requirements defined in subsection 3.02 of [CIRA's By-law No. 1](#).
- A Director is expected to commit the time required to perform board and committee duties. The minimum time commitment is likely 10 to 15 hours per month and approximately 15 business days per year to attend Board and committee meetings.
- Directors must fulfill the requirements and responsibilities of their position, for example,
  - preparing for and attending board and committee meetings;
  - upholding their fiduciary obligations and working cooperatively and respectfully with other board members;
  - complying with legislation governing the corporation, the corporation's by-laws and policies, and all other applicable rules.
- Directors must sign an oath of office to adhere to CIRA's rules, regulations and policies prior to the commencement of their term of office as Director.

### Conflict of Interest Disclosure Statement

Directors must avoid conflicts between their self-interest and their duty to the corporation.
