INTERGOVERNMENTAL AGREEMENT BETWEEN UNITED STATES IMMIGRATION AND CUSTOMS ENFORCEMENT HOMELAND SECURITY INVESTIGATIONS HONOLULU AND COUNTY OF MAUI DEPARTMENT OF POLICE FOR REIMBURSEMENT OF JOINT OPERATIONS EXPENSES

#### **DESCRIPTION:**

The Committee is in receipt of the following:

- 1. County Communication 13-208, from the Chief of Police, transmitting a proposed bill to authorize the Mayor to enter into an intergovernmental agreement between the United States Immigration and Customs Enforcement Homeland Security Investigations Honolulu and the County of Maui Department of Police for the reimbursement of overtime expenses and other law enforcement expenses related to joint operations/task forces.
- 2. Correspondence dated July 11, 2013, from the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE UNITED STATES IMMIGRATION AND CUSTOMS ENFORCEMENT HOMELAND SECURITY INVESTIGATIONS HONOLULU AND THE COUNTY OF MAUI DEPARTMENT OF POLICE FOR THE REIMBURSEMENT OF JOINT OPERATIONS EXPENSES FROM THE TREASURY FORFEITURE FUND". The revised proposed bill incorporates nonsubstantive changes.
