# FG IV - Project Officer in support of the technical design of a Copernicus REDD+ Service

The vacancy is within the Bio-Economy Unit, (located in Ispra, Italy), which provides scientific support to EU policies related to the bio-economy such as the sustainable production as well as the use of biological resources, and which develops methods and models to monitor forest resources and carbon emissions and to improve our knowledge of biomass supply, demand and flows both at EU and global levels.

In particular the JRC will further develop reference methods for the assessment of forest cover changes in tropical regions from Earth Observation data.

We propose a challenging and stimulating position for a dynamic researcher in the field of tropical forest monitoring. The expected work is robustly rooted in science and highly policy-relevant.

The main tasks of the selected candidate will include supporting the following activities:

# • Support the work done by the JRC in the context of the monitoring of deforestation and forest degradation and look at forest regrowth issues.

- Interaction with national forest inventory or REDD services from a number of partners in Central and Eastern Africa countries, with the preparation of national case studies.
- Interaction with European project partners and stakeholders involved in EO forest monitoring.
- Interaction with international and regional institutional partners, such as UN-FAO and ICPAC.
- Produce scientific publications.

#### Qualifications:

The ideal candidate should have a PhD in forestry, agriculture or environmental science, or related field (or a University degree and 2 years of experience) and strong motivation to work in the interface between science and policy.

Work experience in the field of tropical forest monitoring from Earth Observation and in the analysis of forest resources and carbon cycle is required. Knowledge of IPCC methods for estimating REDD GHG emissions and removals is considered important.
