Freight charges on authorized returns must be prepaid and a restocking charge will be made except for returns resulting from shipping errors on our part or material proven to be defective.

CLAIMS: All claims for damage or shortage in transit shall be handled with the carrier by the consignee.

LIMITED GUARANTEE: The Harrington Corporation (Seller) guarantees to credit against invoice price or, at its option, to furnish, but not to install, replacement parts of like kind, F.O.B. Seller's manufacturing plant of origin, any item of its manufacture proved to be defective in material or workmanship within one (1) year from date of shipment provided Buyer (or Purchaser) gives immediate written notice of such alleged defect and, if required, returns defective item to Seller's Lynchburg, Virginia plant freight prepaid. Items or components not of Seller's manufacture are not included in the foregoing guarantee but are subject only to any warranty of their respective manufacturers. Seller shall not be liable for the cost of any repairs or work done or materials used by the Buyer because of defective or non-conforming items, unless authorized in writing by Seller.
