<b>Sponsorship</b> Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period <sup>3</sup> in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.	Not Applicable
<b>Contracts</b> Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest <sup>4</sup> ) and the Council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged. <b>Land</b> Any beneficial interest in land <sup>5</sup> which is within the area of the Council.	Nil
<b>Licences</b> Any licence (alone or jointly with others) to occupy land in the area of the Council for a month or longer.	Nil
<b>Corporate tenancies</b> Any tenancy where (to your knowledge)— (a) the landlord is the Council ; and (b) the tenant is a body in which you or your partner has a beneficial interest.	Nil
<b>Securities</b> Any beneficial interest in securities <sup>6</sup> of a body where— (a) that body (to your knowledge) has a place of business or land in the area of the Council ; and (b) either— (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class. <sup>6</sup> "securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
