CONDITIONS OF EMPLOYMENT:			

> One permanent full-time position. The incumbent of this position is subject to call back and/or standby work.

- If you are a male, born after December 31, 1959, and you want to be employed by the federal government, you must (subject to certain exemptions) be registered with the Selective Service System.
- In accordance with Chapter 12, Indian Health Manual, IHS Employee Immunization Program, selected candidate will be required to submit proof of immunity to the following diseases: Rubella and Measles.
- Before hiring, the IHS will ask you to complete a "Declaration for Federal Employment" and/or "Addendum to Declaration for Federal Employment Indian Health Service Child Care & Indian Child Care Worker Positions" to determine your suitability for federal employment, to authorize a background investigation, and to certify the accuracy of all information in your application. Under P.L. 101-630 Indian Child Protection Act, anyone who answers in the affirmative will be found ineligible and unsuitable for employment in the Indian Health Service. If you make a false statement in any part of your application, you may not be hired; you may be fired after you begin work; or you may be fined or jailed.

DUTIES AND RESPONSIBILITIES:

The incumbent answers telephones and greets patients with appropriate courtesy and records patient and providers request than informs the pharmacist of the request. Calls patients to the pharmacy consultation rooms when prescriptions are ready. Copies and staples patient education materials and organizes materials on patient information. Retrieves and returns medical records from the Medical Records Department as directed. Documents medications that are returned-to-stock in patients chart and on the electronic record as directed. Receives drug and supply orders and places sticker products on appropriate shelves. Sign and date invoices, photocopy invoices and file in proper notebooks and files. Notifies supervisor of any discrepancies between orders received and invoices. Responsible for bulk compounding and the packaging of bulk compound materials. Prepackages lancets and other supplies as directed by the supervising pharmacist and labels vials as appropriate. Reads individual prescriptions and determines type of medication, strength and dosage to be dispensed. Understands common medical and pharmaceutical abbreviations and terminology. Correlates instructions on the order with pharmacy policies to determine the qualities to be dispensed. Enters and prints prescription labels and places prescription labels on vials and applies appropriate supplemental labels. Accurately measures and pours liquid products into dispensing bottles. Reconstitutes oral antibiotics with distilled water as directed on the label taking into account the need for accuracy in mixing. Inspects all pharmaceutical and supplies for proper storage, expiration dates and removes all outdated stocks and fills out monthly drug storage area inspection reports. Knows the amount of each product expected to be maintained in the inventory and records twice daily the refrigerator temperatures in the pharmacy. Reports to the pharmacists the list of products that are expected to outdate within thirty days time. Cleans counting trays daily with isopropyl alcohol and work surfaces and returns supplies to the appropriate stock shelves. Performs any other duties necessary to maintain a clean pharmacy.

COMPETITIVE SERVICE AND EXCEPTED SERVICE QUALIFICATION REQUIREMENTS:

Candidates for GS-5 must have had 52 weeks of Specialized Experience equivalent to at least the GS-4 grade level *OR* successful completion of a full 4-year course of study leading to a bachelor's degree with major study in pharmacy, or that included at least 24 semester hours in pharmacy-related courses.

Specialized Experience: Qualifying specialized experience may have been gained in hospital pharmacies, retail pharmacies, or in pharmaceutical firms or laboratories. Experience must have provided a basic knowledge of:

- Pharmaceutical nomenclature;
- Characteristics, strengths, and dosage forms of pharmaceuticals;
- Pharmaceutical systems of weights and measures; and the
- Variety of procedures and techniques involved in the care, storage, repackaging, bulk compounding, and distribution of pharmaceuticals.

EVALUATION METHOD AND RANKING FACTORS: Evaluation will be made of the extent to which experience, education, training, self-development, performance appraisal, outside activities, and/or awards demonstrate that basically qualified candidates possess the Ranking Factors-KSA's described below. It is to the applicant's advantage to address the following KSA's on a separate sheet of paper.

- 1. Ability to label and fill prescriptions for final pharmacist review.
- 2. Knowledge of pharmacy packaging equipment, containers and proper labeling systems.
- 3. Knowledge of medical terminology.
- 4. Ability to communicate orally and in writing.

WHO MAY APPLY:

<u>Merit Promotion Plan (MPP) Candidates</u>: Applications will be accepted from status eligibles (e.g., reinstatement eligibles and current permanent employees in the competitive federal service) and from current permanent IHS employees in the Excepted Service who are entitled to Indian preference.

Excepted Service Examining Plan (ESEP) Candidates: Applications will be accepted from individuals entitled to Indian preference. Current permanent IHS Excepted Service employees and competitive service employees or reinstatement eligible entitled to Indian preference may also apply under the provision of the Indian Health Service Excepted Service Examining Plan.

Candidates <u>must indicate</u> whether their application is submitted under the IHS Excepted Service Examining Plan, the IHS Area Merit Promotion Plan, or both.

Non-Status Candidates: Applications will also be accepted from non-status candidates (individual who have never been employed by the federal government) and individuals eligible for non-competitive appointment (e.g., applicants eligible for appointment under the Veterans Readjustment Act, the severely handicapped, those with a 30% or more compensable service-connected disability).

Indian Preference: Indian Health Service is required by law to give absolute preference in employment to qualified Indian preference candidates.

Under the <u>Veterans Employment Opportunities Act (VEOA)</u>, veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 years or more of continuous active service may apply for <u>permanent</u> positions as an MPP candidate; however veterans' preference is not a factor in these appointments. Candidates must submit a copy of their DD-214 or other proof of eligibility.

<u>Reasonable Accommodations</u>: This agency provides reasonable accommodations to applicants with disabilities. The decision on granting reasonable accommodation will be made on a case-by-case basis.

<u>Career Transition Assistance Program (CTAP)/Interagency Career Transition Plan (ICTAP):</u> Surplus or displaced employees covered by the U.S. Department of Health and Human Services CTAP program or the ICTAP program for all agencies, may apply and will be given special selection priority if determined to be eligible and well qualified. <u>Well qualified</u> is defined as meeting all education, experience, knowledge's, skills and abilities (KSA's) with a score in the above average range of a four-level crediting plan for all KSA's. REQUIRED DOCUMENTATION:

- Verification of Indian Preference: Applicants who wish to receive Indian Preference MUST submit the BIA Form 4432, Verification of Indian Preference for Employment in BIA and IHS only. This certifies the applicant as an Indian as defined by the Indian Health Manual, Chapter 3, Indian Preference, dated March 14, 2001. Indian preference will not be given unless the BIA Form 4432 is attached to the application/Résumé.

- To substitute education for experience, where applicable, you *must* submit a copy of your transcripts by the closing date or ensure that your resume includes sufficient detail (i.e., required course title, credit hours and grades) to document that you have met the education requirements. *Official transcripts will be required prior to entry on duty.*

OTHER IMPORTANT INFORMATION:

Persons who submit incomplete applications will be given credit only for the information they provide and may not, therefore, receive full credit for their veteran preference determination, Indian preference, education, training and/or experience.

All material submitted for consideration under this announcement becomes the property of Division of Human Resources and is subject to verification. Therefore, careful attention should be given to the information provided. Fraudulent statements or any form of misrepresentation in the application process could result in loss of consideration for this position and/or a determination of unsuitability for federal employment.

Additional or alternate selections may be made from a promotion certificate within 90 days from the date the selection certificate was issued. The positions to be filled must have the same title, series, and grade, be in the same geographic location and have the same qualification requirements. However, if there are no qualified Indian preference candidates left on the certificate, the vacancy **must** be re-announced.

EQUAL EMPLOYMENT OPPORTUNITY: Except for Indian preference, consideration will be given without regard to any nonmerit factor such as race, color, religion, sex, national origin, partisan politics, physical or mental handicap, marital status, age, membership or non-membership in any employee organization, or sexual orientation.

Section 231 of the Crime Control Act 1990, Public Law 101-647, requires that employment applications for Federal child care positions contain a question asking whether the individual has ever been arrested for or charged with a crime involving a child and for the disposition of the arrest or charge.

Section 408 of the Miscellaneous Indian Legislation, Public Law 101-630, contains a related requirement for positions in the Department of Health and Human Services that involve regular contact with or control over Indian children.
