REPORT AND ORDER (Proceeding Terminated)

Adopted: December 13, 2002 Released: December 16, 2002

By the Assistant Chief, Audio Division:

- 1. The Audio Division has before it a February 8, 2002, *Notice of Proposed Rule Making¹* issued at the request of Cohanzick Broadcasting Corp. ("Cohanzick"), licensee of Station WSNJ-FM, Bridgeton, New Jersey. Cohanzick proposed to reallot Channel 299B from Bridgeton to Elmer, New Jersey, as that community's first local transmission service. During the comment period, Cohanzick and New Jersey Radio Partners, LLC ("NJRP"), jointly filed comments amending the original proposal and abandoning the Elmer reallotment. They now propose to substitute Channel 300A for Channel 299B at Bridgeton and reallot Channel 300A from Bridgeton to Pennsauken, New Jersey, as the community's first local aural transmission service, in lieu of the original proposal to reallot Channel 299B from Bridgeton to Elmer, New Jersey. For the reasons set forth below, we dismiss the Cohanzick petition and terminate this proceeding.
- 2. Cohanzick and NJRP argue that the Commission should entertain the amended proposal based on "changed circumstances." We decline to do so within the context of this proceeding. After the filing of the petition for rulemaking, Cohanzick and NJRP entered into an agreement for the sale of WSNJ-FM. The Pennsauken reallotment is a condition of closing under the agreement. Thus, the reallotment is based on the voluntary business decisions of Cohanzick and NJRP. The assignment application was filed more than one month prior to the release of the *Notice*. Cohanzick and NJRP could have sought to revise the initial Elmer petition to the release of the *Notice*, but did not do so. In this instance, we released a *Notice of Proposed Rule Making* setting forth a proposal that Cohanzick no longer had an intention to implement. In these circumstances, we will dismiss the original petition, terminate this proceeding and initiate a new docket seeking comment on the new proposal. A *Notice of Proposed Rule Making* in the new docket will be issued simultaneously with this dismissal. Cohanzick and NJRP's revised rulemaking proposal is substantially different from the original petition. In fairness to any interested parties, we will afford an opportunity to file comments and counterproposals in a new proceeding.

- 3. Accordingly, IT IS ORDERED That the petition for rulemaking filed by Cohanzick Broadcasting Corp. proposing to reallot Channel 299B from Bridgeton to Elmer, New Jersey, IS DISMISSED.
