

1 Overview

A Background

FY 2007 allocations of direct and guaranteed farm ownership (FO) and operating loans (OL) for individual States have been computed according to FmHA Instruction 1940-L. Individual State allocations are in Exhibit 1.

B Purpose

This notice:

- provides information on allocations available in all loan programs
- establishes the total FY 2007 funding levels available to each State
- outlines requirements for obtaining National Office reserve funds.

2 **Loan Programs Not Funded or Not Allocated to States**

A Programs Not Funded

The following FLP are not funded in FY 2007:

- Grazing Association
- Guaranteed Farm Ownership with Interest Assistance
- Irrigation and Drainage
- Direct Soil and Water
- Guaranteed Soil and Water
- Credit Sales of Acquired Properties
- Special Apple Loan Program.

B Programs Not Allocated to States

The following FLP are not allocated to States.

Emergency Loans - The FY 2007 appropriations bill (Pub. L. 110-5) does not provide funding authority. However, a carryover of unused funds from FY 2006 totaling \$115 million is available for use in FY 2007. Loans may be obligated as loans are approved in designated areas.

Indian Tribal Land Acquisition Loans - Control of funds is being retained in the National Office. States should request funds from the Director, LMD, by FAX on 202-690-1117. Funding authority for FY 2007 is \$2 million.

Guaranteed OL With Interest Assistance - Funding authority for FY 2007 is \$271.8 million. Because of the limited funds available in FY 2007, all funds will be retained in the National Office Reserve. Requests for reserve funds should be made according to subparagraph 4 A.

The FY 2007 appropriations bill establishes funding levels for the following programs:

- Direct OL (see subparagraph B)
- Guaranteed OL Unsubsidized (see subparagraph C)
- Direct FO (see subparagraph D)
- Guaranteed FO (see subparagraph E).

B Direct OL

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$1 million, \$500,000, \$1.5 million, and \$500,000, respectively.

An administrative allocation has been made to each State. Under the administrative allocation, each State received the same percentage of the FY 2007 initial allocation as they received of the initial FY 2006 allocation.

The FY 2007 appropriations bill provides funding authority of \$643.5 million. A carryover of unused funds from FY 2006 totaling \$1,578,000 is also available for use in FY 2007.

C Guaranteed OL Unsubsidized

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$400,000, \$400,000, \$1 million, and \$400,000, respectively.

An administrative allocation has been made to each State. Under the administrative allocation, each State received 95 percent of their average obligations for FY's 2006 and 2005.

Funding authority provided in the FY 2007 appropriations bill is \$1,138,500,000. A carryover of unused funds from FY 2006 totaling \$71.8 million is also available for use in FY 2007.

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$700,000, \$200,000, \$1 million, and \$200,000, respectively.

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$300,000, \$300,000, \$3 million, and \$300,000, respectively.

An administrative allocation has been made to each State. Under the administrative allocation, each State received 95 percent of their average obligations for FY's 2006 and 2005.

Funding authority provided in the FY 2007 appropriations bill is \$1,386,000,000. A carryover of unused funds from FY 2006 totaling \$19.847 million is also available for use in FY 2007.

4 State Office Action to Receive Reserve Funds

A Requesting Reserve Funds

State Offices may request reserve funds after allotments are used. Requests for reserve funds should be made by FAX on 202-690-1117.

Note: Applicants exercising their right to priority consideration under the *Pigford v. Johanns* class action must be indicated on the request for reserve funds.

Requests for reserve funds for loan programs should detail the following:

- name of the applicant
- amount of the loan
- category of the loan (non-beginning or beginning farmer, socially disadvantaged (SDA), or non-SDA)
- for direct loans, date of initial application
- for guaranteed loans, date of complete application.
