#### **SECTION I – Contractor's Report**

#### I.1. Summary and Highlights of Activities

#### A. Introduction

International Resources Group Ltd. (IRG) signed the contract with the U.S. Agency for International Development (USAID) on December 12, 2001 for Technical Assistance for Increased Private Sector Participation in Environmentally and Socially Sustainable Hydropower Development in Nepal. Primary objective of the contract is to provide technical assistance and associated training services to the Department of Electricity Development (DOED) of the Ministry of Water Resources (MOWR) and other agencies of the Government of Nepal (GON) to increase private sector participation in hydropower development, in support of USAID's Strategic Objective 4 (SO4).

The current contract is referred to as Private Sector Hydropower Development Project – 2 (PSHDP-2) to indicate continuation of USAID's technical assistance program under SO4 and to differentiate from earlier contract referred to as PSHDP.

The scope of work under PSHDP-2 comprises 26 activities to support SO4. A summary of major accomplishments during the reporting period is listed below. Intermediate results expected through PSHDP-2 to support SO4 are: (i) Improved enabling environment for equitable and sustainable hydropower development; and (ii) strengthened environmental and social assessment procedures with broadened stakeholder participation. Section I.2 provides details of the expected results and progress indicators under PSHDP-2. Section I.3 provides functional description of actions undertaken during the reporting period to achieve our goals. In Section I.4 we discuss our progress during the reporting period under each of the 26 contract activities. Project personnel, cost, and performance data is presented in Section I.5. Section II includes USAID Cognizant Technical Officer's (CTO) report covering the reporting period.

#### B. Summary of major accomplishments during reporting period

Activity milestones/events accomplished during the reporting period are listed below:

- Developed options for strengthening of Electricity Tariff Fixation Commission
  (ETFC) to address the issue of conflict of interest for NEA to take minority interest in
  private sector power development; options have been discussed with the GON
  agencies; selection of option for implementation is underway
- Prepared and discussed with GON agencies, a road map to strengthen and develop ETFC as Nepal Electricity Regulatory Commission (NERC) as envisaged in the Hydropower Development Policy 2001 (HDP 2001)
- Prepared and discussed with GON agencies, a road map to strengthen and develop DOED as the promotional body as envisaged in HDP 2001
- Conducted a preliminary due-diligence of laws and regulations of the power sector; developed and discussed options to legislate HDP 2001, address inconsistencies among power sector laws to facilitate large scale private investment in the sector, and to develop a NERC law

- Provided technical and logistical support to evaluate and select an Administrator for the Power Development Fund (PDF); assisted DOED to prepare for and successfully negotiate an Administration Agreement (AA) for the PDF Administrator (PDFA); AA was approved by the GON and concurred with by the world bank (WB)
- Provided technical and logistical support to the PDF Board created by the GON to manage the PDF
- Arranged and conducted out-of-country study tours in power sector regulation, attendance in international conferences, and out-of-country classroom training in general and project management and infrastructure project financing to senior GON officers from MOWR, DOED, WECS, Nepal Electricity Authority (NEA); DOED presented key observations and findings in a meeting at WECS
- Provided support to DOED to review financial and economic evaluation of Lower Arun, Kabeli, Singhati and Mewa Khola hydropower projects.
- Initiated development of a database system to monitor status and compliance of HEP licensing process and project operations
- Initiated regular discussions with independent power producers (IPPs) on issues in hydropower licensing and investment challenges in the sector; arranged a wellattended meeting of GON agencies, Independent Power Producers of Nepal (IPPAN), Small Hydropower Developers Association of Nepal (SHDAN) to explore overseas investment and support in equipment supply and O&M services
- Studied the power sector market in India and Nepal and prepared a baseline report on existing and proposed expansion plans in the two market; developed short-term and long-term strategy documents for Nepal's hydropower export to India
- Conducted Workshop to discuss Draft Manual on Conducting Public Hearings for Hydropower Development Projects on October 16, 2003
- Continued funding and technical support for training GON staff for Environmental Impact Assessment (EIA) training at SchEMS
- Developed a draft Public Outreach program for the power sector. The plan would be finalized in consultation with GON agencies and the USAID for implementation in 2004
- Completed prequalification of consultants to conduct feasibility studies and EIAs for small hydropower projects (5-10 MW)
- Prepared and issued a Request for Proposal (RFP) to the prequalified consultants for preparing feasibility studies and EIAs for two small hydropower projects under Activity 26
- C. Opportunities, Constraints, Issues, and Recommendations
- Break-down of interim truce with the insurgents on October 2003, slowed down potential investment activity and field work.
- Signing of the PDF and appointment of the PDF Board provided an impetus from private sector for development funding. However, delay in the PDF Board signing an agreement with the PDFA is causing investor sluggishness.
- Awarding subcontracts for two feasibility studies and EIAs were delayed because of longer than expected schedule for pre-qualification of consultants and the significantly different approach to selection of contractor(s) and preparation of the studies to address developer risks. The awards are expected to be made in February

- 2004. Nepal's consulting engineering industry has been very appreciative of our efforts in this regard. The delay is not likely to have any impact on our program.
- In order to facilitate better coordination of our program activities, we have initiated bi-weekly meetings with DOED.

#### I.2. Expected Results (Outputs and/or Indicators of results)

As a measure of performance under this contract to support SO4, the following intermediate results (IR) are monitored:

- 1. IR 4.1- Improved enabling environment for equitable and sustainable hydropower development
- 2. IR 4.2 Strengthened environmental and social assessment procedures with broadened stakeholder participation

Primary indicators used to assess the IRs under the contract are summarized below:

<u>Indicator SO 4.1</u> - Private financial commitments for hydropower projects, measured as cumulative investment amount in millions of US dollars.

<u>Indicator SO 4.2</u> - Number of private sector firms participating in projects of one megawatt or greater, measured as growth per year of investment in millions of US dollars.

The following secondary indicators supporting performance under SO 4.1 and SO 4.2 are monitored:

<u>Indicator I.R. 4.1.1</u> - Private sector projects progressing toward financial closure, measured as cumulative number of private sector projects progressing towards financial closure.

<u>Indicator I. R. 4.1.2</u> - Royalties distributed to affected communities according to policy, measured as the amount of royalties distributed to affected communities in millions of US dollars.

<u>Indicator I. R. 4.2.1</u> - Number of approved Environmental/Social Impact Assessments for hydropower proposals that meet or exceed international guidelines, measured as the number of EIA/SIA at or above international standards approved by DOED, MOWR, and the Ministry of Water Resources (MOPE) for private sector hydropower projects per year. <u>Indicator I.R. 4.2.2</u> - Public hearings for hydropower conducted with local stakeholders and affected communities, measured as the number of public hearings held for private sector hydropower projects per year.

<u>Indicator I. R. 4.2.3</u> - Number of professionals trained in reviewing Environmental/Social Impact Assessments, measured as the total number of professionals trained.

#### Analysis of Results

Although overall USAID targets in investments for the year have been met or exceeded, review of the type of investments for indicator IR 4.1 suggest a slowing down of new private sector (post-financial closure) investments and activities resulting from a soft global economy and particularly, the uncertain political situation in Nepal. The agreement for truce between the GON and the insurgents improved the political and security situation till October 2003 when the truce broke down. Further, recent public debate of issues of existing power purchase agreements (PPAs) between the NEA and the

IPPs and the GON handling of the Maoists insurgency is being closely watched by international community prior to making significant investments in the sector. Delay in the formation of the PDF Board and the Board's approval of the AA with the PDFA may also have contributed to the slowing down of overseas investment. Nevertheless, and on a positive note, a memorandum of understanding (MOU) to conclude a power purchase agreement was signed in November 2003 between a private sector developer and the Power Trade Corporation of India Ltd. (PTCIL), for the purchase of power from the 720 MW West Seti Project. The GON is committed to power sector reform and restructuring being planned under PSHDP-2 and the Asian Development Bank's (ADB) technical assistance program. The GON has continued with unbundling of the NEA and has initiated a program to encourage private cooperatives for power distribution in rural areas. These steps are expected to revive and increase the interest of overseas investors in Nepal's hydropower development.

Indicators for IR 4.1.1 shows a considerable increase in the number of survey license issued for private sector and studies conducted for small hydropower projects, particularly in rural electrification and distribution sub-sector. This is a clear indication of investor interest and confidence in the sector. There is an increased public awareness of the steady stream of royalty revenue to the GON and to affected local authorities. These two factors in conjunction with the West Seti MOU provide a strong indication of a possible turn around in private investment in the sector, provided the political situation improves. A significant increase in rural electrification and distribution system reinforcements would contribute to increased demand and would increase the need for new investments. Indicators for IR 4.2 also show a healthy increase in local capability to prepare EIA documents through increased documents being processed by the DOED.

Please include the following in Section 2 of the fourth Semi-Annual Report for the period July 1, 2003 to December 31, 2003:

IRG submitted a draft of its fourth Semi-Annual Performance Report for the period July 1, 2003 to December 31, 2003 on January 31, 3004. On review of this draft the CTO made a few comments and discussed certain aspects of the report with IRG's Chief of Party. After these discussions, it was agreed that the report would be slightly modified to incorporate CTO's remarks and the final version completed as of the date of this letter.

As highlighted in the report, good progress continued to be made with regard to work plan activities although the economic and political situation continues to deteriorate due to the Maoist insurgency. A considerable increase in the number of survey license issued to the private sector and studies conducted for small hydropower projects, particularly in rural electrification and distribution sub-sectors, was encouraging. This is a clear indication of investor interest and confidence in the sector. There is an increased public awareness of the steady stream of royalty revenue to the GON and to affected local communities. These two factors, in addition to the progress made with regard to the Power Development Fund, suggests a possible accelerated turn around in private investment in the sector when the political situation improves.

In general, the second part of this year's activities may be described as relevant, appropriate, productive and within schedule. The report accurately describes progress accomplished during the reporting period.
