ATF/BJA Police Executive Fellowship Program Projects Overview

The below section provides an overview of the projects that will be assigned to the selected fellows while working at ATF/BJA. Keep in mind that three (3) of the four (4) project overviews listed below are six months in duration and therefore, no rotational assignment to the partner agency (either ATF or BJA) is required.

National Gang Targeting Enforcement and Coordination Center (GangTECC) – 6 months

ATF/BJA is seeking an applicant to serve for six months at the National Gang Targeting Enforcement and Coordination Center (GangTECC) located in Arlington, Virginia. GangTECC is a national, multi-agency, anti-gang task force whose goal is to have the maximum national and local impact against America's most violent regional and national gangs. Staffed with investigators and intelligence analysts from ATF, BOP, DEA, FBI, ICE, USMS, NDIC, local law enforcement, and prosecutors from the Justice Department's Criminal Division; GangTECC and the National Gang Intelligence Center (NGIC) provide one stop shopping for gang investigators across the country. GangTECC and the NGIC allow police departments to tap into the nationwide databases of participating agencies, thereby providing access to related cases nationwide.

Specifically, the fellow assigned to this project will work directly with personnel assigned from the member agencies in the following areas:

- Assisting in the initiation of gang-related investigations and enhancing existing investigations and prosecutions.
- Aiding in the coordination, de-confliction, and effectiveness of gang-related initiatives, investigations and prosecutions.
- Developing an enhanced understanding of the national gang problem and proposing strategies to neutralize the most violent and significant threats.
- Coordinating with and supporting the National Gang Intelligence Center.

Bomb Arson Tracking System (BATS) – 6 months

ATF/BJA is seeking an applicant to develop a case study during a six month assignment to ATF Headquarters in Washington, D.C. The case study will focus on the development of a comprehensive arson, bombing and explosives incident collection plan to include the effective marketing and use of the Bomb Arson Tracking System (BATS). The United States Bomb Data Center (USBDC) oversees and controls access to the BATS program which enables first responders across the country to capture, store, and exchange real-time information related to arson and explosives incidents. Investigators can query nationwide incidents, follow and analyze trends, produce relevant reports, and use GIS (mapping) functionality to provide additional criminal analysis and assist in uncovering patterns and trends. BATS is a web-based application provided to state and local agencies free of charge and is designed for maximum usability across a wide range of participating agencies and is Section 508, 1194.21 (Software Applications and Operating Systems) compliant.

The fellow's main focus will be to identify gaps in the BATS comprehensive explosives data collection efforts. The task will include conducting a study to identify and recommend ways to encourage all law enforcement agencies involved in arson, suspicious fire, bombing, and explosives investigations to enter the information into the BATS.

Specifically, the fellow assigned to this project will work directly with colleagues from the intelligence field to complete the following:

- Review and analyze the BATS program.
- Identify best practices for marketing BATS to increase usage by state/locals

Bureau of Justice Assistance (BJA) – 6 months

ATF/BJA is seeking an applicant to serve for six months at the Bureau of Justice Assistance (BJA), located in Washington, D.C. During their time with BJA, the fellow will work with BJA executives and staff to assist with cutting edge training, technical assistance, implementation support, and policy leadership in support of state and local public safety agencies.
