Hawaii Chapter Wins Community Express Honors

Hectic holiday schedules make it difficult to manage and run a business and still find time to improve the business management skills needed, so this 24/7 internet based "campus" is a perfect solution. While more courses are designed to help small businesses grow, over 40 sessions are directed to start ups.

SBA and Nationwide Launch Small Business Disaster Preparedness Guide

The U.S. Small Business Administration and Nationwide Mutual Insurance Company have teamed up to launch a disaster planning guide for small business owners. The 10-page guide provides information business owners need to develop an effective plan to protect customers and employees in the event of a disaster. The guide also provides key disaster preparedness strategies to help small business owners identify potential hazards, create plans to remain in operation if the facility is unusable, and understand the limitations of their insurance coverage.

Hard copies of the guide will be distributed by SBA field offices, its resource partners around the country and disaster field offices as soon as they become available locally. Nationwide will provide additional copies to its agents for distribution also. The Medeiros were able to get a \$50,000 SBA Community Express loan, due to the excellent technical assistance from Hawaii SBDC Network, their good credit rating and a savvy business banker. The approval of their loan was relatively fast and the order for the big, blue tow truck was processed. XXX Towing was in business!

As if the sight of the shiny new truck with "XXX Towing" emblazoned on the cab door wasn't creating enough of a buzz around Hilo, Cate continues to offer additional guidance to Malcolm and Elena.

"The Community Express program and Constance really got XXX on the road. It was a great experience and has made a great difference for us starting out," said Medeiros. "I tell everyone I know that these programs are amazing!"

Are you starting a business and need funds? Do you need to expand or renovate your existing business? Looking for working capital? If you answer yes to any of the three questions, then you definitely want to come to SBA's Community Express Day to learn more about the loans. Community Express Loans for \$5,000 - \$50,000 with 7 or 10 year terms are available. Proceeds may be used for most business purposes.

Free, confidential consultations will be arranged with a top SBA Community Express lender, a technical assistance provider, or an SBA specialist to help determine your eligibility and provide information about the streamlined applications.

To expedite your SBA application, you should bring your current personal identification, General Excise Tax (GET) business license, the current credit score for each owner of the business, and your business banking account information. If you don't have your credit score, a free credit report can be found on line at www.annualcreditreport.com. Your credit score can be accessed at this site for a small fee.

Advance registration is highly recommended; walk-in clients will be assisted as time permits. Appointments are limited, so call SBA today to reserve a time!
