He was arrested by the Zhong Xiang Bureau of Public Security (*Zhong Xiang shi gong an ju*) in Hubei province on August 8th, 2001 and was sentenced to death in December, 2001 by the Middle Court of Jingmen City in Hubei province with the accusation of sabotaging the laws of the country, raping and assault with a cult. Now His whereabout is unknown.

Xu, Fu-ming, 26, lived in Yu Miao Village, Cheng Guan township, Tai Qian County, Henan Province. He was arrested on Aug. 8th, 2001, and he was sentenced to death in December, 2001 by the Middle Court of Jingmen City in Hubei province Now His whereabout is unknown

Hu, Yong, 25, lived in Group Six of Yin Qian Village, Leng Shui Township, Zhong Xiang City, Hubei Province. He was arrested on Oct 19th, 2001, he was sentenced to death in December, and 2001 by the Middle Court of Jingmen City in Hubei province Now His whereabout is unknown
