

## Cheyenne, Wyoming

The following profile contains information on demographics, political figures, programs, crime, drug use, drug trafficking, and enforcement statistics.

## Demographics<sup>1</sup>

- > Population (2000 Census): 53,011
- Race/Ethnicity: 81.4% white; 2.6% black/African American; 0.6% American Indian/Alaska Native; 1.0% Asian; 0.1% Native Hawaiian/Other Pacific Islander; 0.1% some other race; 1.6% two or more races; 12.5% Hispanic/Latino (of any race)
- The city of Cheyenne is located in Laramie County.

### **Programs/Initiatives**

- ➤ High Intensity Drug-Trafficking Area (HIDTA)<sup>6</sup>
  The Rocky Mountain HIDTA was designated in 1996 and includes counties in Colorado, Montana, Utah, and Wyoming (Albany, Campbell, Laramie, Natrona, Sweetwater and Uinta counties).
- ➤ Drug Abuse Resistence Education (DARE) Program
  As part of the Community Relations Detail of the Laramie County Sheriff's
  Department, the deputies of the D.A.R.E. Unit provide a unique and vital service to the
  children of Laramie County. Currently, eleven deputies are teaching the D.A.R.E.
  curriculum to 6th graders part-time in Laramie County schools and several private
  schools, reaching over 1,200 students annually.

### **Federal Funding**

- ➤ Drug-Free Communities Support Program<sup>7</sup>
  Since funding was first available through the Drug-Free Community Support Program in 1998, there have been no grantees in Cheyenne.
- ➤ FY 2001 Substance Abuse and Mental Health Services Administration Discretionary Funds awarded to Cheyenne grantees:<sup>8</sup>
  - Center for Mental Health Services
    - \$350,000 to the Wyoming Department of Health, Coalitions for Prevention;
    - \$100,000 to the Wyoming Department of Health, Data Infrastructure Grants;
    - \$60,000 to Uplift, Children's Services and Family Network
  - Center for Substance Abuse Prevention
    - \$3,020,000 to the Office of the Governor, State Incentive Cooperative Agreement
  - Center for Substance Abuse Treatment
    - \$500,000 to the Wyoming Department of Health, 2001 Earmarks

- ➤ Executive Office for Weed and Seed<sup>9</sup>
  Cheyenne has not been officially recognized as a Weed and Seed site.
- ➤ There were no Cheyenne recipients of the FY 2002 Community Oriented Policing Services (COPS) Methamphetamine Grant. <sup>10</sup>
- ➤ There were no Cheyenne recipients of the FY 2001 U.S. Department of Housing and Urban Development's Federally Assisted Low-Income Housing Drug Elimination Grant. 11
- Cheyenne did not receive any funding for the FY 2002 Office of Justice Programs Drug Court Grant. 12

## **Crime and Drug-Related Crime**

➤ During 2001, there were 514 adult drug-abuse violation arrests in Laramie County. <sup>13</sup>

➤ During 1999, the crime index total for Cheyenne was 2,302. <sup>14</sup> This number decreased to 2,182 during 2000. <sup>15</sup> During 2001, the crime index total for Cheyenne was 2,325. <sup>16</sup>

Methamphetamine related arrests accounted for 18% of all drug-related arrests during 1993. This percentage increased to 58% during 1998 and to 80% during 1999. 17

#### **Drugs**

Cocaine

Cocaine is available throughout Wyoming, particularly in urban areas such as Cheyenne, but to a lesser degree than methamphetamine. Crack cocaine is available on a limited basis in Cheyenne and sells for \$50-\$100 per gram and \$25-\$40 per rock. <sup>18</sup> Ounce quantities of cocaine are available in and around Cheyenne and Laramie. <sup>19</sup>

➤ Methamphetamine<sup>20</sup>

According to the DEA Cheyenne Resident Office during 2001, methamphetamine is increasingly being abused by teenagers in the State due to the drug's wide availability, low cost, and popularity.

➤ Club Drugs<sup>21</sup>

During March 2000, several drums of various sizes containing the GHB precursor GBL were seized by the Cheyenne Police Department and the Southeast Enforcement Team. The substance was discovered by a warehouse landlord after the drums were abandoned by the tenant. Ecstasy is beginning to appear as a drug of abuse in Cheyenne.

### Juveniles

➤ During 2001, there were 126 juvenile drug abuse violation arrests in Laramie County. <sup>22</sup>

➤ There were 170 total juvenile index offense arrests in Laramie County during 2001. <sup>23</sup>

#### Enforcement

As of October 31, 2001, there were 115 law enforcement employees in the city of Cheyenne; 88 officers and 27 civilians.<sup>24</sup>

## **Trafficking and Seizures**

- ➤ During 2002, the Cheyenne Department's Drug Unit investigated 12 clandestine labs within the city limits of Cheyenne compared to 3 labs investigated during 2001. <sup>25</sup>
- ➤ The DEA Cheyenne Resident Office reported in early 2001 that Mexican criminal groups were beginning to use commercial buses and private aircrafts to transport methamphetamine into Wyoming. <sup>26</sup>
- ➤ The Wyoming Division of Criminal Investigation conducted three investigations involving MDMA distribution in Cheyenne and Laramie between July and October 2000.<sup>27</sup>

#### Courts

➤ Drug Courts<sup>28</sup> As of January 2003, there was one drug court in Cheyenne that had been recently implemented.
