The Ministry is also responsible for monitoring phytosanitary aspects relating to the production, industrialization, marketing and transportation of plants and plant products and by-products.

There have been outbreaks of a pest complex in some municipalities in the State of Jalisco, affecting agave plantations, diagnosed by the National Phytosanitary Reference Centre of the General Directorate of Plant Health as Erwina carotovora and Fusarium oxysporum.

The aforementioned pests are transmitted by the agave propagative plant material and can go undetected during transportation and the establishment of new agave plantations in the DOT territory. Consequently, the proper application of phytosanitary measures during the production and marketing process is required.

The phytosanitary quality and health of agave propagative material plays a decisive role in the health of crops during the various phenological stages. Consequently, a registration and certification programme for agave is required to guarantee the health and origin of the product, with the primary aim of improving and encouraging the production and use of agave propagative material that is free of phytosanitary problems.

Only through a joint effort and the involvement of producers, laboratories, nursery owners, carriers, traders, the federal, State and municipal authorities and the general population, will it be possible to perform an effective phytosanitary control of the pests affecting agave and prevent their spread. This Ministry has decided to issue, as a matter of urgency, Mexican Official Standard NOM-EM-037-FITO-2002, Phytosanitary Specifications for the Production and Transportation of the Blue Variety of the Weber Tequila Agave.
