## **Executive Summary**

This report covers the third semi-annual period July– December 2007 for the Advancing Surveillance, Policies, Prevention, Care and Support to Fight HIV/AIDS (ASHA) Project in Nepal.

The ASHA Project is currently implemented by three major partners namely FHI as the prime, Constella Futures and Association of Medical Doctors of Asia (AMDA). The Project works through 48 local implementing agencies (IA) in close collaboration with National Center for AIDS and STD Control (NCASC). During this period ASHA Project signed 9 sub-agreements with IAs.

Key activities and achievements during this reporting period include the following:

- Provided technical assistance to government and other key stakeholders in the areas of HIV commodity security, voluntary counseling and testing (VCT), sexually transmitted infection (STI), prevention of mother-to-child transmission (PMTCT), the national review of the surveillance system, the national program review of community and home-based care services, laboratory services, United Nations General Assembly Special Session (UNGASS) reporting, and monitoring and evaluation (M&E).
- Conducted risk reduction activities and reached nearly 27,000 people among the most-at-risk populations (MARPs) in the Eastern, Central, Western, Mid-Western and Far-Western Regions along the main transport routes and in major cities. Nearly 60% of the MARPs reached during this reporting period were either Female Sex Workers (FSWs) or their clients.
- Made modifications in the IHS service delivery mechanism by having AMDA cover most of Eastern Terai region and the Central Terai region was handed over to local NGOs.
- Provided VCT services for injecting drug users (IDUs) in 3 sites.
- Provided STI diagnosis and treatment services at 27 sites
- Provided VCT and an Essential Package of Care (EPC) for people living with HIV/AIDS at 32 sites.
- Provided Community and Home-based Care (CHBC) services in 13 sites.
- Provided treatment for STIs to over 3,000 people (both new and old) from MARPs;
- Provided HIV counseling, testing and results to 7,800 people and palliative care to over 900 people.
- Secured consent from Government of Nepal and key stakeholders to use the GOALS model to plan resource allocation for HIV and AIDS in Nepal.
- Conducted National dissemination of CHBC assessment, and IBBS study findings.
- ASHA Project SRM Team Leader provided technical assistance to for estimation of HIV infections in Nepal for 2007 including support to a two-day workshop.
- Conducted District AIDS Co-ordination Committee (DACC) assessment.


Constraints faced during the reporting period include ongoing political instability; continuity of key senior government officials; supply of drugs to treat STIs and Opportunistic Infections (OI); absence of approved National DACC guidelines at the district level.

## I. Introduction

- Conducted risk reduction activities and reached nearly 27,000 people among the most-at-risk populations (MARPs) in the Eastern, Central, Western, Mid-Western and Far-Western Regions along the main transport routes and in major cities. Nearly 60% of the MARPs reached during this reporting period were either Female Sex Workers (FSWs) or their clients.

- Secured consent from Government of Nepal and key stakeholders to use the GOALS model to plan resource allocation for HIV and AIDS in Nepal.
- Conducted National dissemination of CHBC assessment, preliminary HIV estimation and IBBS study findings.
- Conducted District AIDS Co-ordination Committee (DACC) assessment.

#### Staff Development

ASHA Project staff completed their annual performance evaluation in September. Together with accomplishments over the past one year, the staff identified areas for professional development. In the past six months, ASHA Project staff participated in various professional development activities:

- 1 staff participated in one-day training on Impact on Income Tax by Finance Bill 2007 (ACE Information and Management Support Pvt Ltd).
- 1 staff participated in a 5-day Strategic Behavior Communication (SBC) global workshop organized by FHI in Bangkok.

#### **B.** Partnership Management and Development

The Program Management Meeting (PMM) between senior staff members from the ASHA Project partners, FHI Nepal, Constella Futures and AMDA Nepal continued on a regular basis during the reporting period to discuss and coordinate activities and partnership issues. All three partners jointly had an annual workplan development workshop where each partner and its staff members worked together to develop the individual and unit level workplan drawing from the approved ASHA Project workplan. This helped the partner organizations and their staff members to understand each other's work, learn about collaboration and partnership issues and identified areas where there needs to be greater coordination. All there partners were also present for the reporting out meeting where each unit and partner discussed the progress being made so far and areas requiring improvements. Each partner and unit also developed a way forward matrix from the issues that were identified as needing action. Staff from the Program Unit, Technical Unit and Policy Unit met weekly for Program/Technical Meetings to discuss program progress, updates and constraints. Presentations on new technical information were made during every alternate Program/Technical Meeting.

A total of 9 new subagreement awards (Table 5) were approved by USAID and signed with IAs during this reporting period. A complete list of all current IAs under the ASHA project with detailed descriptions of each award is given in Annex A. With these new subagreements, ASHA Project now works in 29 districts.

#### C. Coordination and Collaboration

The ASHA Project continues to collaborate very closely with national, regional as well as district level government structures and other key stakeholders including donors and the civil society. During this reporting period, several rounds of coordination meetings with NCASC, UNDP, the World Bank, UNICEF, NAP+N, Recovery Nepal, Zonal hospitals, District Public Health Office (DPHO) and other key stakeholders took place as required. ASHA Project also coordinates its activities through the national technical working groups and core groups.

At the regional and district levels, ASHA Project used its quarterly coordination meetings in all five regions as a forum to discuss program progress, program constraints and ways to improve regional coordination and collaboration by inviting all ASHA partners, district government officials, USAID representatives, USAID partners and other key donors/stakeholders. ASHA Project implementing partners continue to hold collaborative meetings with DPHO, DACC, Reproductive Health Coordination Committee (RHCC), service providers and stakeholders at the district level.

During this reporting period, FHI Nepal collaborated with the US Embassy, USAID/Nepal, UNICEF Nepal and National Association for People Living with HIV/AIDS in Nepal (NAP+N) to launch Universal Access to Children Affected by HIV and AIDS in Nepal (UCAAN) Partnership to support the Government of Nepal under the coordination of NCASC to mitigate the impact of HIV/AIDS on children and their families in Nepal. This partnership will work through the Children Affected By AIDS (CABA) National Technical Working Group and include multiple partners.

The ASHA Project coordinated with national and local stakeholders to observe National Condom Day and World AIDS Day (WAD) events The slogan for National Condom Day was "Proper use of condom for dual protection' while the slogan for World AIDS Day 2007 was "Take the Lead". Both events were commemorated by ASHA Project's implementing agencies through various awareness raising activities, rallies and street theatre with the objective to educate the general public about HIV and AIDS. The ASHA Project participated as the core committee member as well as a member of sub committee for IEC material development for WAD National Event.

The ASHA Project also coordinated with the USAID funded N'MARC Project (Nepal Social Marketing and Franchising for AIDS, Reproductive Health and Child Survival) to facilitate the presentation of the social marketing component of the N'MARC Project during the regional ASHA project quarterly coordination meeting in all regions.

#### **D.** Technical Assistance and International Travel

A list of all local consultants providing technical assistance during this period and their scopes of work are included in Annex B. During this reporting period, the ASHA Project mobilized assistance from 19 local consultants for areas including management of anti-retroviral therapy (ART) and OI, PMTCT, CHBC, STI case management, SBC, management information systems (MIS) and project management/ administration. The tasks carried out by these consultants include provision of technical assistance to IAs; conduct of national assessments; development of strategies, training curricula and Standard Operating Procedures (SOPs); provision of technical support for clinical services including ART; collecting data; development of financial management system; providing legal advice, translation; writing reports; and, editing.

FHI Asia Pacific Regional Office (APRO) provided the following management and technical assistance to the ASHA Project:

• Dr Jim Ross – management support for the ASHA Project and Acting Country Director while FHI/Nepal Country Director was on leave;

- Dr Dimitri Prybylski provided technical assistance to New Era and FHI staff on Respondent Driven Sampling Analysis Tool (RDSAT);
- Dr Motiur Rahman, who provided technical support for an assessment of existing facilities for external quality assurance (EQA) using Dried Blood Spot technology at the National Public Health Laboratory (NPHL) and an assessment of future possible space provided by NPHL for renovation and establishment of new HIV testing External Quality Assurance (EQA) laboratory; development of operating procedures essential for implementation of the Rapid HIV Testing EQA; and, preparation and outline of the training modules for "Laboratory quality and safety" and "DBS EQA roll out";
- Dr Penny Miller who supported QA/QI system development and its roll out.

In addition, Amrita Mathew (FHI/Cambodia) and Sudip Mahapatra (FHI/India) provided technical assistance on a data quality audit for ASHA Project implementing partners.

Dr Nalinee Sangrujee from Constella Futures visited Nepal to provide technical assistance to initiate the application of the GOALS model to examine the policy questions, convene stakeholders' meeting to introduce the GOALS model and discuss its application and usefulness of the results and to attend the stakeholders meeting and present the GOALS model.

International travel for ASHA Project staff during this reporting period included Jackie McPherson, ASHA Project Chief of Party who participated in the Regional Workshop on Leadership and Strategic Planning (funded through FHI core funding); Bharat Raj Gautam Senior M&E Officer who provided technical assistance to FHI Vietnam for Data Quality Assurance (funded through FHI headquarter funding); and, Pranab Rajbhandari, Communications Specialist who participated in SBC global workshop.

Details of all international travel are included in Annex C.

## **III.** Technical Program Elements (Progress and Results by Results Areas)

**Results** Area 1: Reduce transmission of HIV/AIDS epidemic through targeted prevention interventions within specific high-risk and vulnerable populations

- Conducted Safe Highways Program activities for HIV prevention to care along the East West Mahendra Highway in the *Terai* with 12 IAs in 22 districts.
- Conducted HIV prevention to care activities for Female Sex Workers (FSWs), their clients, Injecting Drug Users (IDUs) and PLHA with 8 IAs in Kathmandu Valley, Birgunj and Pokhara cities.
- Conducted HIV prevention to care activities in Far Western Nepal for migrants with 4 IAs in 2 districts. This program is closely linked with the DFID-funded Reaching Across Borders Project implemented in the Far West and India by FHI. Reaching Across Borders built upon the successful Safe Migration Initiative under the USAID-funded FHI/IMPACT Project and IAs from the ASHA Project also provide support to the ART clinical sites supported under DFID.
- Initiated Positive Prevention activities in 5 districts through 4 PLHA run implementing partners.

**Results Area 2: Build capacity of Government of Nepal and civil society to manage and implement HIV/AIDS activities and to inform policy formulation at national, local and community levels to reduce stigma and discrimination and enable access to services** 

#### **Building capacity of Government of Nepal**

The ASHA Project provides substantial technical assistance to the Government of Nepal, primarily through the NCASC and National Public Health Laboratory (NPHL). As the efforts towards mainstreaming HIV continues, it is expected that the ASHA Project will expand assistance to other ministries including Ministry of Home, Labor and Education. The following are specific activities completed during this reporting period:

- In collaboration with NPHL, organized a joint dissemination of the findings of the Dried Blood Spot (DBS) Technique for External Quality Assurance for HIV testing and developed an understanding with the major stakeholders on the way forward.
- Supported the development of National guidelines and training curriculum such as National VCT guideline revision (finalized), National adherence counseling curriculum (in the process of being reviewed by NCASC), National ART SOP development (in the process of being reviewed by NCASC) and National Logistic SOP.
- Actively participated in the National STI review, National VCT review, technical advisory group for development of National tool kit for prevention and control of HIV in sex work settings and National review of ART services. Technical Unit Head, CHBC Specialist, Laboratory Specialist and Technical Officer of the ASHA Project participated in VCT Site Assessment organized by NCASC under supplemental fund activities. VCT sites run by Government, UNDP and ASHA/FHI were reviewed using checklists developed by FHI and USAID for site assessment.
- Through the supplemental funding, ASHA Project provided logistic support to NCASC for the distribution of HIV commodities to different ART sites in the country. National site review of VCT sites, support to NCASC for the initiation of the ART services in new sites were also provided through the same mechanism.
- Conducted presentations on a variety of technical topics as outlined in Table 6.
- FHI/Nepal's Technical Unit Head participated in the program organized to clinically review and mentor government ART service sites. Laboratory Specialist of ASHA project participated in clinical review and mentoring of government ART service sites (Western Regional Hospital and Baglung District Hospital) in Kaski and Baglung districts. HIV related laboratory services, laboratory services for PMTCT, VCT and ART programs at the hospitals were observed during the visit. These teams used Clinical Facility and service Assessment Package, QA/QI tool kit developed by FHI and USAID during the visit to monitor the quality of services being provided.
- Signed agreement with Management Association of Nepal to integrate HIV/AIDS Activities in Ministries of Government of Nepal.
- The ASHA Project convened three Regional Consultation Meetings to share and get feedback on the preliminary finding of the assessment on DACC status.
- The ASHA Project, through Constella Futures, has continued to support enactment and implementation of the HIV and AIDS Bill and amendment proposal and a series of advocacy programs in regards to the endorsement of the HIV/AIDS bill has taken place.
- The ASHA Project, through Constella Futures, organized a stakeholders' meeting for the application of GOALS and a decision was made by NCASC to implement GOALS model for the costing of the National Action Plan (NAP).
- The ASHA Project conducted two orientation sessions to Nepal Police on post-exposure prophylaxis (PEP) of HIV. One hundred doctors and staff of Birendra Police Hospital participated in the orientation. PEP flow chart developed by the ASHA Project was introduced and distributed during the orientation.

- The ASHA Project facilitated a session on facts and figures about HIV/AIDS for the senior officials of Armed Police Force (APF). A consultation meeting followed the presentation to draft and develop HIV/AIDS curriculum and strategy for APF.
- The ASHA Project provided orientation on HIV/AIDS to the National Olympic Committee and National Sports Federations Representatives and to the members of Management Association of Nepal (MAN).
- The ASHA Project provided critical technical assistance and support to the National HIV/AIDS Program through participation in the following national technical working groups and core groups:
  - <u>National Logistics Core Group</u>: The ASHA Project Logistics Specialist as a member of this core group, contributed to the development of National Logistics SOP and national quantification of HIV commodities.
  - <u>National Laboratory Core Group</u>: The ASHA Project Laboratory Specialist and ASHA Project Technical Unit Leader participated in the VCT guideline development sub-committee and helped design HIV testing algorithm and made recommendations on test kits that can be used for HIV testing.
  - <u>National PMTCT Technical Working Group (TWG)</u>: The ASHA Project ART/OI Specialist reviewed draft National PMTCT Guidelines 2007 and submitted comments to PMTCT TWG for the finalization of the guidelines.
  - <u>National Pediatric Technical Working Group</u>: The ASHA Project provided significant technical assistance in the development of the National Guidelines on Pediatric HIV and AIDS, which were officially disseminated by NCASC during this reporting period. The process was coordinated by UNICEF Nepal.
  - <u>National VCT Technical Working Group:</u> The ASHA Project Technical Unit Head participated in ongoing meetings to contribute to the revision of the National VCT Guidelines.
  - <u>National OVC Technical Working Group:</u> The ASHA Project Deputy Director participated in two meetings of the OVC/CABA National Task Force. These meetings oriented the task force members on issues related to Children Affected by HIV AIDS (CABA) and developed plans for field visits by the Task Force members to four districts in order to understand the ituation of children affected by HIV/AIDS so that a response plan can be developed based on ground realities. The ASHA Project provided on-the-ground co-ordination support in Kailali district to facilitate this field visit.
  - <u>National ART Core Group:</u> The ASHA Project's ART/OI Specialist participated in National ART SOP Review Meeting and discussed the national ART documents.
- The ASHA Project, through Constella Future, has been supporting Armed Police Force to develop & institutionalize HIV/AIDS strategy and curriculum. The final draft of the curriculum has been submitted by the consultant. APF has allocated a room for the HIV cell.

### **Building Capacity of Civil Society**

To build capacity of civil society to effectively participate in the national HIV response and reduce stigma and discrimination, the ASHA Project conducted the following activities during this reporting period:

- Conducted regular monthly program and finance review meetings with all ASHA Project IAs.
- Assisted IAs in strengthening their financial systems through mobilization of an expert consultant.
- Conducted a sustainability assessment with Sahavagi (IA in the Central Region) and a process evaluation with Community Welfare Center (IA in Kathmandu.
- Signed agreements with Federation of Sexual and Gender Minorities for strengthening of MSM/MSW Network; Dristi Nepal Institutional for building capacity of NGO run by Former Female IDUs; Sneha Samaj for strengthening of National Network of Women PLHA in Nepal; and, Conscious Media Forum for strengthening journalists for effective and analytical writings towards HIV and AIDS.

- Supported strategic planning exercise for NAP+N and Recovery Nepal to build the capacity of the two networks and their network partners.
- Conducted ASHA Project Orientation for 13 ASHA Project IAs in Kathmandu.
- Conducted an interaction session on HIV/AIDS related stigma for 11 PLHA support groups in Eastern Region during a workshop on Treatment Preparedness in Dharan funded by Tides Foundation.
- Administered stigma and discrimination leadership contracts to support vulnerable women. In this regard, a national federation of women living with HIV or AIDS in Nepal has been formed and is working actively. Dristi Nepal is working actively in the issues related to female drug users.
- Strengthened the capacity of the media to contribute to effective National response through training and regular advocacy. The Conscious Media Forum organized a media walk in the far western region of Nepal where there are major issues related to migration and HIV/AIDS. Twenty local journalists participated and reported on the event. Dissemination of this report is planned for January.
- Sensitized VDC and district level leaders and line agency stakeholders on HIV and AIDS in selected priority district. The HIV/AIDS curriculum was endorsed by Local Development Training Academy (LDTA). A press briefing was organized by LDTA regarding the endorsement. Training of Trainers was provided for the trainers of LDTA. The curriculum was launched in their regional training centers.
- 503 individuals and 43 organizations received training in HIV related institutional capacity building during this year.

# **Results** Area 3: Improve planning, collection, analysis and use of strategic information by stakeholders to facilitate a more effective and targeted response to the HIV/AIDS epidemic

- Monitoring and Evaluation (M&E) training was conducted for three implementing partners in Western region to introduce M&E concepts and its importance in managing programs and to develop an M&E guideline. Another refresher workshop on monitoring, reporting system, process and tools was held in the Eastern region to re-orient the monitoring concepts and processes as well as to review the existing recording and reporting system along with tools being used by IAs.
- Orientation training was conducted for IAs on the FHI Management Information System (MIS) and mapping tools. Outreach educators and community mobilizers were involved in practical exercises and discussed operational definitions of the indicators.
- The ASHA Project Surveillance, Research and M&E Unit, with technical support from FHI/Cambodia and FHI/India, conducted a data quality audit (DQA) with 19 IAs to audit the quality of the data being reported. USAID/Nepal also participated in the process. The report of this DQA was shared with NCASC, UNAIDS, UNDP, USAID, and WHO. A separate presentation on the DQA findings was made during the Quarterly Coordination Meeting.
- FHI/Nepal's SRM Unit Team Leader facilitated the National Strategic Information Technical Working Group (SI-TWG) meeting, chaired by the NCASC Director, to review the National HIV/AIDS Surveillance System and planned IBBS studies for 2008. Study findings of HIV prevalence from 2007 rounds of Integrated Bio-Behavioral Surveys (IBBS) conducted by FHI/Nepal among IDUs in Kathmandu and Pokhara and among MSM in Kathmandu were shared among the SI-TWG members.
- Dimitri Prybylski, Senior Technical Officer trained FHI/Nepal and New ERA staff on the use of Respondent Driven Sampling Analysis Tool (RDSAT) for analyzing data collected in the 2007 rounds of IBBS among IDUs in Kathmandu and Pokhara and MSM in Kathmandu. Following this training, New ERA staff adopted RDSAT analysis technique and included these results in the IBBS reports.
- The ASHA Project's SRM Team Leader and MIS Program Officer attended United Nations General Assembly Special Session on HIV/AIDS (UNGASS) Indicators Consultative Meeting which was organized to share the data compiled by NCASC, with technical support from the SI-TWG, to a wider audience. The ASHA Project's SRM Team Leader made a presentation on the UNGASS data validation process. Altogether 50 people participated from various government organizations, NGOs

and donor agencies. At the end of the meeting NCASC formed a Task Force for further data collection and validation for UNGASS reporting.

- ASHA Project SRM Team Leader provided technical assistance to for estimation of HIV Infections in Nepal for 2007 including support to a two-day workshop. This workshop was jointly organized by NCASC, UNAIDS, WHO and FHI. SRM team leader continued to participate in several follow-up meetings organized by NCASC and UNAIDS in this regard.
- The ASHA Project provided technical assistance that ensured sufficient data and information on the HIV epidemic and key indicators to enable successful use of the GOALS resource allocation model.
- The ASHA Project revised Integrated Health Service (IHS) for MARPs to include feedback from users regarding usability of current forms; incorporation of recommendations made by DQA studies; and initiation of a process to integrate ASHA Project MIS with National HIV M&E Strategy and Plan requirements.
- The ASHA Project calculated key PMP indicators and shared with NCASC and USAID.
- The ASHA Project made presentations on the HIV Epidemic in Nepal: an update to a national forum that was discussing the GOALS Model; The HIV epidemic: Global and Nepal's scenario to staff members of MAN; The HIV Epidemic and Program Concerns to representatives from all IAs in Kathmandu, Government, UN and other key stake holders; The HIV epidemic in Nepal to VSO volunteers; Study area and sample size calculations for the upcoming IBBS among the wives on migrants in Western Nepal to SI-TWG members and members from key network organizations.

**Results** Area 4: Increase access to quality care, support and treatment services through public, private and non-governmental sources for PLHA and their families

- During this reporting period, major modifications were made in the service delivery mechanism of Integrated Health Services (IHS). AMDA phased out from the Central Terai region and the areas being covered by AMDA were handed over to SAHAVAGI and GWP, two local NGOs. Similarly, based on the recommendations of the experts to increase coverage, AMDA's service delivery in Eastern terai was modified to have five static sites instead of mobile clinics and the clinics are now headed by Health Assistants with technical expertise being part-time available from a physician doctor.
- ART/OI Specialist conducted supportive monitoring visits to three clinics offering the Essential Package of Care for PLHA in Kathmandu valley to provide on-site clinical mentoring.
- The ASHA Project field tested and finalized standard operating procedure (SOP) manual for CHBC, STI, VCT and ART. QA/QI tools for VCT review were developed, field tested and used in National VCT review. This tool includes checklists for VCT, Lab, CHBC, STI, EPC, and ART. Curriculum for laboratory training, CHBC refresher training and outline of STI refresher training curriculum were also developed.
- The ASHA Project continued to provide technical monitoring visits to ASHA IAs to monitor, supervise and support the quality of the laboratory services; STI and HIV clinical services; strategic behavioral communication activities; and CHBC activities. ASHA Project partner AMDA also provided supportive technical supervision to 10 IAs during this reporting period.
- Conducted one 10-day HIV Clinical Management Training Program in coordination with NCASC for a total of 19 participants.
- Conducted 6-day training on STI Case Management for 21 participants out of which five participants were from government health facilities. In addition, organized one three-day refresher training on STI Case Management for 13 participants to refresh the previously trained health care providers on STI Case Management National Guidelines.

- Conducted two, 3-day Laboratory Training on STI/VCT for 42 participants (government, UNDP and ASHA implementing partners) to train laboratory personnel on laboratory diagnosis of STI and HIV according to the National Guideline.
- Conducted three 3-day training on Universal Precautions/PEP for 73 participants (doctors, staff nurses, health assistants, lab personnel, counselors and clinical support staff) to train IHS clinical staff on practice of universal precautions and post exposure prophylaxis within their health facility.
- Conducted one 7-day National CHBC Training Program for 27 participants comprising of 24 support group members and three medical doctors from eight IAs. The training sessions were on home visit skills practice, sharing of CBHC activities, PMTCT and ART for children. In addition, two 4-day refresher trainings on CHBC were conducted for 44 participants.
- Conducted two 10-day trainings on VCT counseling for 38 participants from 20 organizations. Another five-day VCT counselor's refresher training was organized during this reporting period attended by 14 participants from 8 organizations. In addition, two five-day basic counseling skills training for community workers was conducted for 40 participants from ASHA IAs.
- Continued to provide clinical mentoring on OI case management to health providers from ASHA Project partners who provide health services for PLHA and on ART to staff from Seti and Mahakali Zonal Hospitals.
- Through a specialized organization, ASHA Project carried out monitoring of the HIV counseling services provided by ASHA Project-supported VCT sites being run by eight partners to assess quality of counseling and to provide feedback to the counselors and the implementing agencies.

# Results Area 5: Create linkages among stakeholders and support national coordination of Nepal's cross sectional HIV/AIDS program supported

- The ASHA Project conducted its Quarterly Coordination Meetings with its IAs and stakeholders in 4 different regions. The purpose of these meetings was to discuss and share program activities, coordination, collaboration, networking and cross cutting issues among government and non-governmental stakeholders to improve effective and coordinated response to HIV/AIDS.
- The new UNAIDS Country Coordinator was oriented about the ASHA Project by ASHA Project Chief of Party and Senior Policy Advisor.
- The ASHA Project Senior Policy Advisor briefed the Director, National Center for AIDS and STD Control (NCASC) on the progress of policy related activities under the ASHA Project. The DACC analysis report was also shared and discussed.
- Conducted regular coordination meetings with government and other collaborating agencies including WHO, UNAIDS and the NMARC Project.
- Continued to support the DACCs through local IAs including district level meetings and presentations of project activities to key district stakeholders. DACC members participated in ASHA-regional quarterly meetings and issues related to DACC improvements were shared.
- Partners like UNDP, government partners and regional entities were invited to and attended ASHA Project quarterly coordination meetings where ASHA Project progress and coordination issues were discussed.
- Coordinated field level logistics including communication with partners during visits from government and NCASC delegates. Example Children affected by HIV and AIDS assessment visit by NCASC to Kailali district.
- Held meetings with UNDP to coordinate mutual partner related issues as well as the renovation of NPHL.

#### **Other Supported Activities**

#### Universal Access for Children Affected by AIDS in Nepal (UCAAN) Launched

The US Embassy, USAID/Nepal, UNICEF Nepal, FHI Nepal and National Association for People Living with HIV/AIDS in Nepal (NAP+N) joined hands to launch UCAAN Partnership to support the Government of Nepal under the coordination of the National Centre for AIDS and STD Control to mitigate the impact of HIV/AIDS on children and their families in Nepal. The partnership, which has been made open to other key stakeholders, seeks protection, care and support for children affected by AIDS, with the goal of ensuring early entry into care and/or treatment and to increase access to comprehensive services for children throughout the country.

#### Distribution of Direct Relief International donations

FHI/Nepal completed the distribution of medical equipment and supplies to government and IAs received as donation from Direct Relief International (DRI).

#### Media coverage for the ASHA Project

ASHA Project's Chief of Party appeared on a popular talk show called *Bahas* (debate) along with Health Secretary and President of National Association for People Living with HIV/AIDS in Nepal. Communication Specialist talked about ASHA Project activities and the current HIV scenario in Metro FM and in the state owned television.

#### FHI Nepal's Associate Director recognized for excellence

FHI/Nepal's Associate Director for Finance and Administration, has been awarded the prestigious FHI Lynda Cole Award of Excellence for 2007. The Associate Director has been recognized as representing the attributes that were valued by Lynda and of having made major contributions to FHI and its mission.

## **IV. Monitoring and Evaluation Update**

ASHA Project OP indicators<sup>†</sup> and achievements for this reporting period are in Annex D. A summary of all trainings and workshops conducted for the period are summarized in Annex E. Highlights of achievements related to targets for this reporting period are as follows:

- Exceeded by 10% the target for the number of individuals reached through community outreach.
- Exceeded the target (45) for the number of USAID-assisted organizations providing HIV-related services.
- Exceeded by nearly double the target set for the number of individuals trained to promote HIV prevention.
- Exceeded the target for number of individuals trained to promote HIV/AIDS prevention through other behavior change beyond abstinence and/or being faithful. The excess was mainly contributed by refresher training of ICH PEs and counseling training to the community workers.
- Met the target for the number of individuals trained in HIV-related policy development target.
- Met 50% of the annual target for number of organizations provided with technical assistance for HIVrelated policy development.

- Exceeded by more than 24% number of people trained in reduction of HIV-related stigma and discrimination.
- Targets for number of individuals and organizations trained in strategic information (M&E, surveillance and tools) through USAID assistance have not been met but most of the training programs are planned for Jan Jun reporting period.
- Completed data collection among IDUs in Eastern and Western to Far-western *Terai* highway districts. Several rounds of dissemination have taken place for the IBBS. Final report being prepared.
- Targets for number of people living with HIV/AIDS reached with palliative care and support services at USAID-targeted service sites and to a greater extent for number of MARPs receiving STI treatment at USAID-assisted sites have not been met for this reporting period. This will be studied in depth during the subsequent reporting period.
- Exceeded the target on the number of individuals receiving VCT services.
- Exceeded the target of number of EPC and VCT sites providing services. The target for both was 30; the ASHA Project currently has 32 EPC and 32 VCT sites.
- Most training indicators are on course against the annual targets.

## V. Constraints

Major constraints experienced during this reporting period were:

- Ongoing political instability;
- Irregular supply of STI and OI drugs; and,
- Absence of approved National DACC guidelines at the district level.

The constraint related to STI and OI has been communicated to NCASC and has been raised in the technical working group for logistics. NCASC has responded very positively to this situation and a mechanism has been developed to tackle this situation. It is expected that the supply of STI and OI drugs will gradually improve.

The constraints contributed to the delays in some planned activities and also affected the number of clients accessing available services. As in the previous reporting period, the political instability and difficult security situation in the Eastern *Terai* led to continuous disruptions in program activities. Similarly, the IAs are still facing shortages of STI and OI drugs and their regular supply hasn't yet been systematized.
