The Grand Jury charges that:

COUNT 1

On or about March 18, 2008, in the Eastern District of Louisiana, the defendant, **ARISTIDES ZEPEDA YZAGUIRRE; a/k/a Emilio Jose Izaguirre Mayorsa; a/k/a Emilio Jose Mayorga; a/k/a Emilio Isaguirre**: did knowingly possess a counterfeited and falsely made Alien Registration Receipt Card, knowing it to have been counterfeited and falsely made; all in violation of Title 18, United States Code, Section 1546(a).

## COUNT 2

On or about July 28 , 2006, in the Eastern District of Louisiana, the defendant, **ARISTIDES ZEPEDA YZAGUIRRE; a/k/a Emilio Jose Izaguirre Mayorsa; a/k/a Emilio Jose Mayorga ;a/k/a Emilio Isaguirre;** in a matter within the jurisdiction of the United States Social Security Administration for the purpose of obtaining something of value and for other purposes, that is, to gain employment, knowingly, and with the intent to deceive, falsely represented in his Employment Eligibility Verification Form (I-9) that his Social Security number was XXX-XX-9275, when in fact, as the defendant well knew, Social Security account

number XXX-XX-9275 was not assigned to defendant; all in violation of Title 42, United States Code,
