# SUPPORTING STATEMENT MARINE FISHERIES INITIATIVE (MARFIN) RESEARCH AND DEVELOPMENT GRANTS AND COOPERATIVE AGREEMENTS APPLICATION OMB CONTROL NO. 0648-0175

#### A. JUSTIFICATION

### 1. Explain the circumstances that make the collection of information necessary.

The Marine Fisheries Initiative (MARFIN) Program has been funded since 1986 by Congress to develop, rejuvenate, and maintain Gulf of Mexico fisheries. Any citizen of the United States can apply for financial assistance to assist the Federal government (NOAA Fisheries) in meeting the goals and objectives of the MARFIN Program. Funds are available to assist persons in carrying out research and development projects which optimize the use of a U.S. Gulf of Mexico fishery involving the U.S. fishing industry (recreational or commercial) including, but not limited to, harvesting methods, economic analyses, processing, fish stock assessment, and fish stock enhancement. Funding recommendations are determined through a competitive peer review process. Information is a requirement for submitting an application. This allows the evaluation of individual proposals and determination of funding priorities. Each year MARFIN priorities and directions for submitting proposals are published in the Federal Register. MARFIN is managed by the Southeast Region of the National Oceanic and Atmospheric Administration (NOAA).

# 2. Explain how, by whom, how frequently, and for what purpose the information will be used.

The application provides information that will be used by the National Marine Fisheries Service to evaluate technical aspects of proposals and determine appropriateness for funding. If information is not provided, applications are not considered for funding. There are no direct impacts on Federal programs or policies if information is not collected. Grant funds would continue to be allocated using other than competitive processes.

In addition to standard Federal grant application requirements (e.g. the SF-424), the information requirements are as follows:

- A project summary and description detailing the problem to be addressed and what the project's goals are. Most of the information contained is required by OMB circulars; the exceptions are separately described below.
- A Project Budget form is substituted for the OMB Form 424A. This substitute form is necessary to eliminate some information that is unnecessary for the MARFIN competitive financial assistance program, and focuses the applicant to clearly document estimated costs of each proposed year of funding in such a way that reviewers and evaluators can easily assess the budget request.

- The semi-annual report: this is a progress report that is submitted to NMFS in order for NMFS to determine if research is being conducted properly. NMFS has the obligation to require that the money for the grant is being spent wisely. Through these reports we know what work is being done and what work is going to be conducted later.
- The annual (final) report: this is a report submitted annually and is a summation of the research work that was conducted for the <u>entire</u> year. It is the final report which describes the research that was conducted and specifies the results of that research.

# 3. <u>Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological techniques or other forms of information technology.</u>

No alternative methods to collect this information are as efficient as the current method. There is an initiative to approve receipt of electronic applications in the future. Once the electronic signature is approved, electronic applications will be accepted.

# 4. Describe efforts to identify duplication.

Since the MARFIN funds are made available to the Secretary of Commerce, no duplication of effort exists with other Federal government information collection efforts.

# 5. <u>If the collection of information involves small businesses or other small entities, describe</u> the methods used to minimize burden.

This information collection will not have a significant economic impact on a substantial number of small entities.

# 6. Describe the consequences to the Federal program or policy activities if the collection is not conducted or is conducted less frequently.

If information was not collected, grants could not be made. Applications and final reports are one-time processes. Semi-annual reports are needed to properly monitor activity.

# 7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with OMB guidelines.

This collection information is consistent with OMB guidelines except that 10 copies of each application are required. The competitive nature of the MARFIN program necessitates the review of each application by enough scientists (generally eight reviewers per application) to ensure non-biased evaluations can be garnered. The justification for this action is founded in the reduced processing time required for evaluating each application. The applicant (i.e. States, universities, corporations) benefit by the quicker "turn-around" time that results from the greater efficiency of the Southeast Region's Program Office in getting an application into the review process. More specifically, the applicant benefits by: notification of award disbursement in a

more timely fashion; and due to the seasonality of many of the fisheries for which we are providing research monies, the reduced funding cycle would allow more predictable start dates. The unique nature of many of the applications (color photographs, research reports, etc.) for the MARFIN program prohibits efficient duplication by our office, however the applicant can more effectively include these items, thereby enhancing application review.

We receive an average of 50 applications per year. An application is approximately 35 pages long and takes about ½ of a minute to xerox each one (½ minute times 10 copies = 5 minutes). If an applicant is submitting photographs or other special items as part of the application package, the copying time could be less.

    (C) any corporation, partnership, association, or other entity (including, but not limited to, any fishery development foundation or other private nonprofit corporation not located in Alaska), nonprofit or otherwise, if such entity is a citizen of the United States within the meaning of section 802 of title 46, Appendix, and for purposes of applying such section 802 with respect to this section -
    - (i) the term "State" as used therein includes any State referred to in paragraph (3),
    - (ii) citizens of the United States must own not less than 75 percent of the interest in the entity or, in the case of a nonprofit entity, exercise control in the entity that is determined by the Secretary to be the equivalent of such ownership, and
      - (iii) nationals of the United States and citizens of the Northern Mariana Islands shall be treated as citizens of the United States in meeting the ownership and control requirements referred to in clause (ii).
- o (2) The term "Secretary" means the Secretary of Commerce.
- O (3) The term "State" means any State, the District of Columbia, the Commonwealth of Puerto Rico, American Samoa, the Virgin Islands of the United States, Guam, the Northern Mariana Islands, and any other Commonwealth, territory, or possession of the United States.
- O (4) The term "United States fishery" means any fishery, including any tuna fishery, that is, or may be, engaged in by citizens or nationals of the United States or citizens of the Northern Mariana Islands.
- o (5) The term "citizen of the Northern Mariana Islands" means
  - (A) an individual who qualifies as such under section 8 of the Schedule on Transitional Matters attached to the Constitution of the Northern Mariana Islands; or

■ (B) a corporation, partnership, association, or other entity organized or existing under the laws of the Northern Mariana Islands, not less than 75 percent of the interest in which is owned by individuals referred to in subparagraph (A) or citizens or nationals of the United States, in cases in which "owned" is used in the same sense as in section 802 of title 46, Appendix.

# • (b) Transfer of funds

- O (1) The Secretary of Agriculture shall transfer to the Secretary each fiscal year, beginning with the fiscal year commencing July 1, 1954, and ending on June 30, 1957, from moneys made available to carry out the provisions of section 612c of title 7, an amount equal to 30 per centum of the gross receipts from duties collected under the customs laws on fishery products (including fish, shellfish, mollusks, crustacea, aquatic plants and animals, and any products thereof, including processed and manufactured products), which shall be maintained in a separate fund only for -
  - (A) use by the Secretary -
    - (i) to provide financial assistance for the purpose of carrying out fisheries research and development projects approved under subsection (c) of this section, [1]
    - (ii) to implement the national fisheries research and development program provided for under subsection (d) of this section;
    - (iii) to implement the Northwest Atlantic Ocean Fisheries Reinvestment Program established under section <u>1863</u> of title 16; and
      - (iv) to fund the Federal share of a fishing capacity reduction program established under section <u>1861a</u> of title 16; and
      - (B) the provision of moneys, subject to paragraph (2), to carry out the purposes of the Fisheries Promotion Fund established under section 208(a) [2] of the Fish and Seafood Promotion Act of 1986 (16 U.S.C. 4008(a)).
- O (2) There are transferred from the fund established under paragraph (1) to the Fisheries Promotion Fund referred to in paragraph (1)(B) \$750,000 in fiscal year 1987, \$3,000,000 in each of fiscal years 1988 and 1989, and \$2,000,000 in each of fiscal years 1990 and 1991.
- (c) Fisheries research and development projects
  - O (1) The Secretary shall make grants from the fund established under subsection (b) of this section to assist persons in carrying out research and development projects addressed to any aspect of United States fisheries, including, but not limited to, harvesting, processing, marketing, and associated infrastructures.
  - o (2) The Secretary shall -
    - (A) at least once each fiscal year, receive, during a 60-day

period specified by him, applications for grants under this subsection;

- (B) prescribe the form and manner in which applications for grants under this subsection must be made, including, but not limited to, the specification of the information which must accompany applications to ensure that the proposed projects comply with Federal law and can be evaluated in accordance with paragraph (3)(B); and (C) approve or disapprove each such application before the
  - (C) approve or disapprove each such application before the close of the 120th day after the last day of the 60-day period (specified under subparagraph (a)) in which the application was received.
- o (3) No application for a grant under this subsection may be approved unless the Secretary -
  - (A) is satisfied that the applicant has the requisite technical and financial capability to carry out the project; and (B) evaluates the proposed project as to -
    - (i) soundness of design,

      - (vi) such other criteria as the Secretary may require.
- o (4) Each grant made under this subsection shall be subject to such terms and conditions as the Secretary may require to protect the interests of the United States, including, but not limited to, the following:
  - (A) The recipient of the grant must keep such records as the Secretary shall require as being necessary or appropriate for disclosing the use made of grant funds and shall allow the Secretary and the Comptroller General of the United States, or any of their authorized representatives, access to such records for purposes of audit and examination.
  - (B) The amount of a grant may not be less than 50 percent of the estimated cost of the project.
  - (C) The recipient of the grant must submit to the Secretary periodic project status reports.

- (A) If the cost of a project will be shared by the grant recipient, the Secretary shall accept, as a part or all of that share, the value of in-kind contributions made by the recipient, or made available to, and applied by, the recipient, with respect to the project.

- (B) For purposes of subparagraph (A), in-kind contributions may be in the form of, but are not limited to, personal services rendered in carrying out functions related to, and permission to use real or personal property owned by others (for which consideration is not required) in carrying out the project. The Secretary shall establish (i) the training, experience, and other qualifications which shall be required in order for services to be considered as in-kind contributions; and (ii) the standards under which the Secretary will determine the value of in-kind contributions for purposes of subparagraph (A).
- (C) Any valuation determination made by the Secretary for purposes of this paragraph shall be conclusive.
- (d) National fisheries research and development program
  - o (1) The Secretary shall carry out a national program of research and development addressed to such aspects of United States fisheries (including, but not limited to, harvesting, processing, marketing, and associated infrastructures) if not adequately covered by projects assisted under subsection (c) of this section, as the Secretary deems appropriate.
  - O (2) The Secretary shall, after consultation with appropriate representatives of the fishing industry, submit to the Committee on Commerce, Science, and Transportation of the Senate and the Committee on Merchant Marine and Fisheries of the House of Representatives, an annual report, that must be submitted not later than 60 days before the close of each fiscal year, containing -
    - (A) the fisheries development goals and funding priorities under paragraph (1) for the next fiscal year;
    - (B) a description of all pending projects assisted under subsection (c) of this section or carried out under paragraph (1), in addition to -
      - (i) a list of those applications approved and those disapproved under subsection (c) of this section, and the total amount of grants made, for the current fiscal year, and (ii) a statement of the extent to which available funds were not obligated or expended by the Secretary for grants under subsection (c) of this section during the current fiscal year; and
        - (C) an assessment of each project assisted under subsection (c) of this section or carried out under paragraph (1) that was completed in the preceding fiscal year regarding the extent to which (i) the objectives of the project were attained, and (ii) the project contributed to fishery development.
- (e) Allocation of fund moneys
  - o (1) Notwithstanding any other provision of law, all moneys in the fund shall be used exclusively for the purpose of promoting United States fisheries in accordance with the provisions of this section, and no such moneys shall be transferred from the fund for any other purpose. With respect to any fiscal year, all moneys in the fund, including the sum of all unexpended moneys carried over into that fiscal year and all moneys transferred to the

fund under subsection (b) of this section or any other provision of law with respect to that fiscal year, shall be allocated as follows:

■ (A) the Secretary shall use no less than 60 per centum of such moneys to make direct industry assistance grants to develop the United States fisheries and to expand domestic and foreign markets for United States fishery products pursuant to subsection (c) of this section; and
(B) the Secretary shall use the balance of the moneys in the fund to finance those activities of the National Marine Fisheries Service which are directly related to development of the United

States fisheries pursuant to subsection (d) of this section.

o (2) The Secretary shall, consistent with the number of meritorious applications received with respect to any fiscal year, obligate or expend all of the moneys in the fund described in paragraph (1). Any such moneys which are not expended in a given fiscal year shall remain available for expenditure in accordance with this section without fiscal year limitation, except that the Secretary shall not obligate such moneys at a rate less than that necessary to prevent the balance of moneys in the fund from exceeding \$3,000,000 at the end of any fiscal year.

circumstances, discussed in the amendment below, that warrant exempting the Maritime Provinces from this investigation. In fact, the circumstances behind the original exemption of the Maritimes from the 1986 Memorandum of Understanding (1986 MOU) have not changed for the last 15 years. Even though the exemption of the Maritimes from the 1991 countervailing duty investigation was based on a separate legal requirement (see, Self-Initiation of Countervailing Duty Investigation: Certain Softwood Lumber Products from Canada, 56 FR 56055, 56058 (October 31, 1991) and Amendment to the Notice of Self-Initiation of Countervailing Duty Investigation: Certain Softwood Lumber Products from Canada, 56 FR 56058 (October 31, 1991)), the circumstances associated with the Maritime Provinces are substantially the same as they were at the time of the 1986 MOU. Those circumstances remained the same at the time of the 1991 countervailing duty investigation, the 1996 Softwood Lumber Agreement, and at present with respect to the current investigation. Accordingly, the Department is amending the Notice of Initiation to exempt the Maritime Provinces.

#### Amendment

The Notice of Initiation is amended to add the following paragraph entitled "Exemption of Maritime Provinces":

Exemption of Maritime Provinces

The lumber dispute between Canada and the United States has a long history. Throughout much of the history of this dispute, the Maritime Provinces have been exempt from the various actions taken, including the 1986 Memorandum of Understanding on Softwood Lumber, the interim measures taken pursuant to Section 301 of the Trade Act of 1974, the 1991 countervailing duty investigation, and the recently expired Softwood Lumber Agreement. All parties have generally recognized that there are unique circumstances associated with the Maritime Provinces and have supported those exemptions. That is equally true in the case now before us. In the petition, petitioners requested that softwood lumber production in the Maritime Provinces be exempt as it was in the 1991 countervailing duty investigation. Further, petitioners did not allege that any subsidies are received by producers in the Maritime Provinces. While the absence of allegations regarding specific regions of a country would not be sufficient by itself to warrant the exemption of those regions from an investigation, this factor, when

combined with all the other unique circumstances of the Maritimes, does contribute to our determination to exempt the Maritimes. The Government of Canada also supported exemption of the Maritime Provinces from the investigation given the absence of subsidy allegations.

In light of all of the unique circumstances in this case, we have determined that it is appropriate to exempt exports of certain softwood lumber products produced in the Maritime Provinces from this investigation. As in the earlier proceedings and agreements concerning softwood lumber, this exemption does not apply to certain softwood lumber products produced in the Maritime Provinces from Crown timber harvested in any other Province.

NOAA will only authorize the action if a NOAA-approved observer is carried on the vessel to certify the amount of unshucked shellfish harvested. This is required because of the difficulty in converted shucked weights into bushels.
