Report Highlights:

Existing EU decisions on the certification of a series of animal products have been amended to incorporate specific provisions for transshipments to and from Russia via the Community following the eastward expansion of the EU. The amendments include also the new specimen health certificates for transshipments through the expanded EU.

Includes PSD Changes: No Includes Trade Matrix: No Unscheduled Report Brussels USEU [BE2] [E3] These certificates become mandatory after January 1, 2005. So far, they have only been published in the official languages of the EU-15. We will send out an update when they become available in the languages of the acceding countries.

Furthermore a consolidated list of approved border inspection posts (BIPs) in the EU-25 has been published. This list provides also an overview of the type of products that each of those BIPs handles and also indicates which border inspection posts in Lithuania, Latvia and Poland have been designated for transit of consignments destined for Russia.
