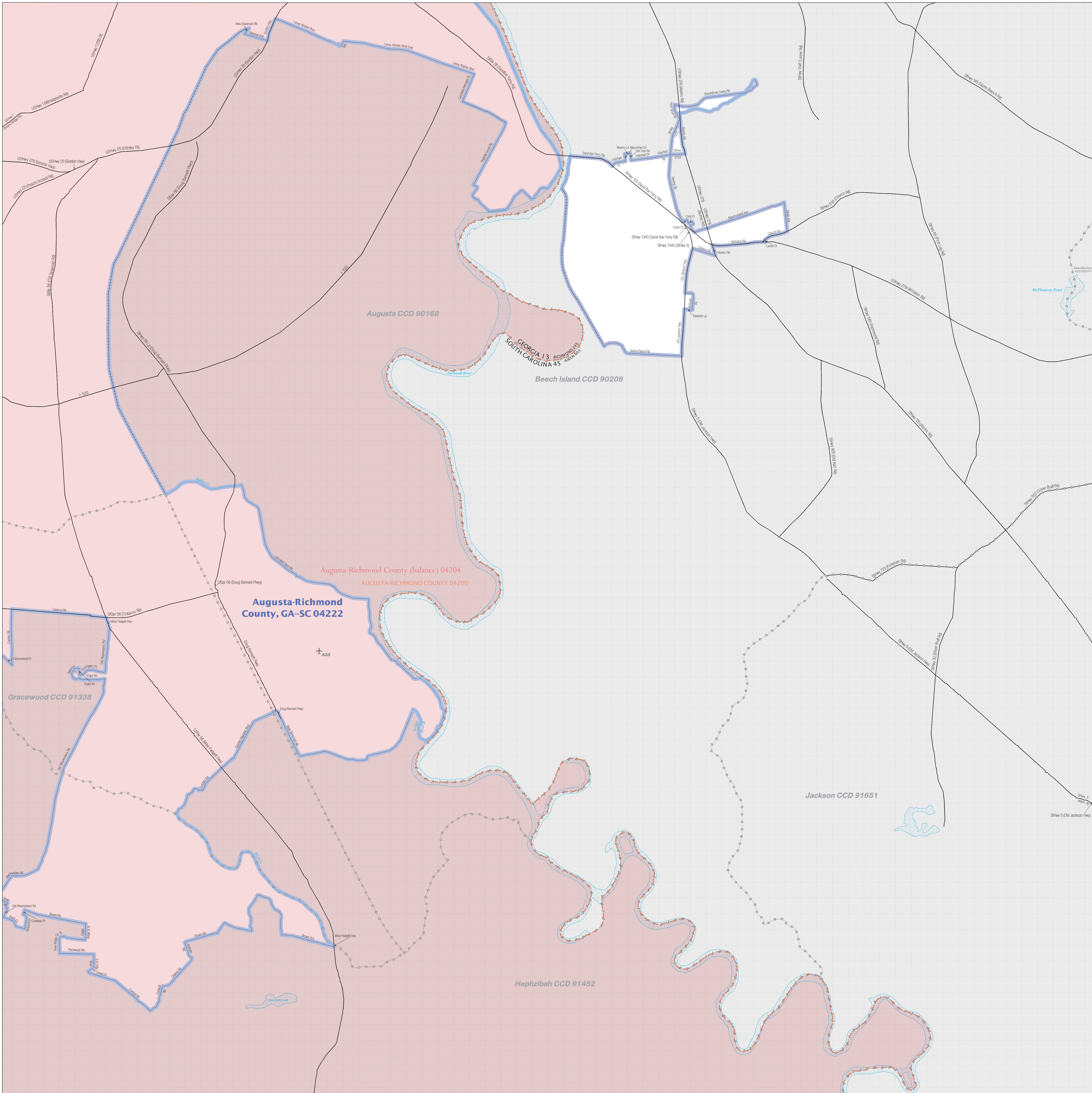


# URBANIZED AREA OUTLINE MAP (CENSUS 2000) Augusta-Richmond County, GA--SC

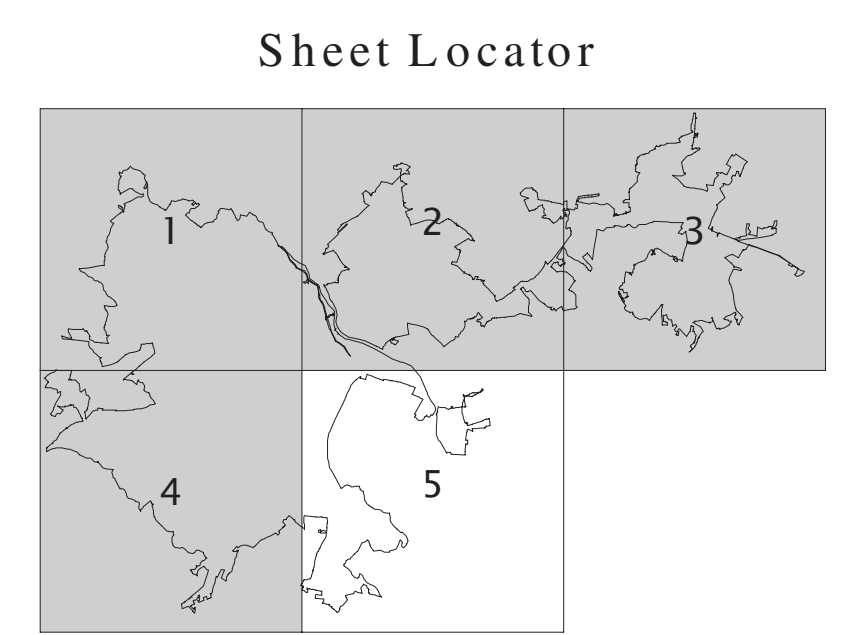
