Travel and Transportation Services

American Express Government travel cards are issued to authorized Federal Employees for use on official travel. This card is accepted by all the common airline carriers, various car rental companies, Amtrak, numerous hotels, and 117,000 ATM locations worldwide. GSA's travel card program covers both domestic and international travel and includes both individual and centrally billed accounts. It provides access to travelers' checks in seven currencies and offers government-specific management reports. Some of the benefits of this program include:

- Interest free accounts,
- Travelers Checks which are refunded at no cost to the traveler if lost or stolen,

Pilot Programs Flying High

The Services Acquisition Center currently has three pilot programs in the works. If these pilot programs prove to be as successful in saving time, money, and resources as our other programs, they will be made available on a much broader scale. The three pilot programs we are currently offering are Temporary Clerical Support Services, Temporary Professional Support Services, and Conference Planning Services. What is unique about the two temporary services is that they are available to all Federal agencies, but only in the Washington DC metropolitan area. If successful, the services will be expanded to other metropolitan areas across the United States. The Conference Planning Schedule offers the full gambit of conference services from the beginning stages of planning to the final thank you letters. Currently, this pilot program is only available to GSA, however, plans are in the works to expand this program to other Federal agencies. By incorporating pilot programs, we are able to identify and resolve implementation issues to ensure continued customer satisfaction. We like to think of this process as just another way we can provide you, our customer, with quality services. Below are brief descriptions of these programs.

Temporary Clerical and Temporary Professional Support Services

This financial service provides commercial credit cards and associated services to support official government purchases. Use of the program greatly streamlines payment procedures and reduces the administrative costs associated with traditional and emergency purchases of supplies and services. Right now, more than 264,000 government employees are using the program and have an IMPAC card for "on-the-spot" purchasing that saves money, time, and paperwork. It is easy to enroll in the program and agencies can designate cardholders spending limits, appropriate purchase categories, and agency operating procedures. Below are additional benefits of using this program:

- · Works like any commercial credit card
- Provides the ability to purchase supplies & services from a wide range of suppliers
- · Improves agency cash management
- Can be used to purchase items from GSA Advantage!, GSA's Electronic Shopping Service

Consumer and Commercial Credit Reporting Services

Auditing Services and Financial Management Services

Based on overwhelming requests from several customer agencies, the Services Acquisition Center is announcing the availability of new contracting services for Auditing and Financial Management Support. This multiple award schedule provides the Federal Community direct access to commercially available auditing and financial management services to assist agencies in performing their duties. Government officials, policy makers, and managers need reliable financial and performance information in order to achieve the goal of developing a more responsive and effective government. This schedule will provide agencies with a wide choice of vendors, services and prices to meet all of your auditing and financial needs.

The key benefit of this program is the direct access to specialized expertise agencies need but do not have on staff. The second benefit is that agencies will be able use this specialized expertise to assist with meeting the requirements of the Chief Financial Officers Act, Government Performance and Results Act, and various Office of Management and Budget mandates, circulars, and bulletins. Available services include but are not limited to: Financial Audits, Performance Audits, Accounting Services, and Financial Consulting.

Health Care Cost Recovery (HCCR)

Federal Departments and Agencies that provide health care services to Government beneficiaries have the responsibility to recover the cost when other entities are also providing coverage. Under this program, qualified vendors assist Federal departments and agencies with the recovery process. The vendors review HCCR related processes and procedures, identify and verify third party health insurance coverage, perform preliminary recovery activities, and provide various support services. Agencies may purchase a single service or contract out the entire administrative process. This program assists with the collection of funds to which the government is entitled.

Third Party Payment Systems

This service makes money management easier and more efficient for customer agencies. Agencies are able to eliminate the use of petty cash, and better account for various expenditures, by making reimbursements and/or payments using a non-treasury check. The check is processed via standard commercial banking procedures, and upon being cleared for payment, the agency reimburses the vendor for the value of the check. The program is ideal for agencies that have representatives in remote locations where merchants may not accept the IMPAC as a form of payment. The program offers the following benefits:

- Improves management control by creating an audit trail
- Enhances cash management by minimizing the need for cash authorized transactions
- Universal acceptance
- Timely reconciliation of agency accounts

The Next Generation of Fleet, Travel, and Purchase Payment Systems

This program will replace the current Government-wide Commercial Purchase Card Program (IMPAC), the Travel and Transportation Payment and Expense Control System (AMEX), and the U.S. Government Fleet Services Card (Wright Express). The contracts will be effective November 30, 1998, and the base period will be for five years with one five year option. Agencies will place task orders against this contract, and FSS will provide assistance as needed.

Key Selling Points of the program include:

- · Agency customization
- · Choice of vendors
- Streamlined procurement processes
- Enhanced competition
- Continual access to advances in technology

This unique program is being awarded under a master contract approach for the first time. GSA has historically awarded these contracts separately with each program area being awarded to only one vendor. The master contract concept offers enormous benefits over the previous procurement method. The new approach recognizes that one size does not fit all. Agencies have varying financial requirements and it is impossible to design one system that meets everyone's needs. Under this new approach, agencies will have a selection of vendors and services to choose from and the flexibility to tailor a program to meet their unique needs. Agencies will also have the ability to change vendors if they wish during the contract period. The structure of the master contract concept allows for continual access to advances in technology, which encourages competition within industry to develop program improvements and share these best practices with the Government.

Q: Is it possible for you to expedite my order?

A: Yes! More often than not it is possible to expedite an order. GSA vendors "do what it takes" to satisfy our customers. If you need to expedite an order call our Customer Service Team on (703) 305-7003.

Q: May I cancel an order I have already placed?

A: Yes if the vendor has not started production on the item or it hasn't already shipped. To successfully process a cancellation we need the request in writing faxed to us ASAP at (703) 305-6032. We then notify the vendor and take the necessary steps to cancel the order.

Q: HELP! How do I make sense out of this SF344?

A: Our Customer Service Technicians will gladly talk you through the process of correctly filling out all required information on your SF344.

Q: The "Ship to" address on my order is incorrect. How do I get this corrected?

A: When you notice this error please contact the National Furniture Center immediately. We will contact the vendor and provide them with the correct shipping information for your order.

Q: I received twice the amount of what I ordered. What do I do with the overage?

A: You need to call the GSA National Customer Service Center (NCSC) in Kansas City, MO. On (800) 488-3111. The NCSC technician will take the information concerning your overage. In most cases your account will be adjusted and arrangements made to pick up the overage.

Q: I want to buy some chairs for the office. How do I get a copy of the GSA Schedule for chairs?

A: You may want to establish a small library of the schedules you anticipate purchasing from in the next year or two. To do this contact the Centralized Mailing List Service (CMLS). The CMLS can be reached by calling (817) 334-5215 or by fax at (817) 334-5227. If you have an urgent need for a particular furniture schedule one of our technicians will gladly fax it to you. Just call (703) 305-7003 to get your request moving.

Note: For customers in the Washington, DC., Metro area, our Customer Resource Center (CRC) maintains a library of all furniture and furnishing schedules. GSA Advantage!™

Using Order History/ Status in GSA *Advantage!*[™]

The Order History functions in GSA *Advantage!* ™ have recently been enhanced to allow you to perform several different functions. You may obtain order/requisition status, report a problem, reorder, cancel an order, and/or view vendor and product detail. If you want to access Order History, we must first know who you are. Therefore, you must log on, the same way as you placed your original order i.e. .IM.P.A.C. credit card or Activity Address Code (AAC) + password. You must then go to the Main Menu and click on the Order History/Status button. Order History shows ALL the line items you ordered from GSA *Advantage!* ™ regardless of method of supply IMMEDIATELY after your order is successfully placed by clicking on the Check Out button.

Searching:

You may search Order History by:

- -- Clicking on all Advantage! orders
- -- Entering the Advantage! session number
- -- Entering the purchase order number
- -- Entering the requisition number
- -- Entering a date range

Functions:

- -- <u>Cancel Item</u>: provides the ability to cancel 7-14 day items, not yet shipped. If the item is a GSA National Stock Number (NSN) and has been shipped, the item may not be cancelled. Simply mark the item in the space provided and click on SUB-MIT. You may also cancel schedule items; however, you are advised to call the vendor directly to determine shipment status since GSA does not receive status from vendors. The name and phone number of the schedule vendor is provided on the GSA *Advantage*!TM Order Summary and can also be obtained by clicking on the vendor name. Customer Supply Centers (CSC) 1-3 day items CANNOT BE CANCELLED because they are sent to the CSC for processing immediately after input.
- -- Reorder: provides the option to immediately re-order the item (with refreshed pricing information). Simply indicate quantity in the space provided and click on SUBMIT.

- -- <u>Status</u>: provides status for items purchased with status code explanations (See the status definitions referenced in this article)
- -- <u>Problem Reporting</u>: provides users the ability to report a 7-14 day item problem to the National Customer Service Center (NCSC). 1-3 day order problems are reported directly to the supporting Customer Supply Center.
- -- <u>Product Details</u>: Links are available which display vendor and product details.

Status:

If you place orders through GSA *Advantage!*TM, you should only access status through ORDER HISTORY. This is the only source of status for 1-3 day (CSC) items.

There are several words used to provide status for items ordered through GSA *Advantage!*TM. For NSN items, status is normally provided by the next day if the order was placed prior to 6 p.m. Eastern Time. Schedule items will always appear as "posted" or "canceled" since GSA does not receive any further status from the vendor.

Status Definitions:

- -- <u>Posted</u>: Your order has been sent to the schedule vendor. Additional status must be obtained by contacting the vendor directly.
- -- Pending: Each 7-14 day GSA Advantage! requisition is uploaded daily to GSA's internal supply system for fulfillment and will display the status Pending until the requisition is processed. The same is true of 1-3 day items, except these are sent to the CSC within an hour after the order is successfully placed in GSA Advantage!
- -- <u>Waiting</u>: The requisition/document number has been sent to GSA's internal supply system and Advantage!‰ Advantage! is awaiting acknowledgment of receipt.
- -- <u>Normal</u>: The 7-14 day requisition is being processed. Click on NORMAL to view expanded status information, which includes the estimated shipping date.

- -- <u>Shipped</u>: The 7-14 day requisition has been fulfilled and shipped to you. Click on SHIPPED to view expanded status information, which includes the date the requisition was shipped and the mode of shipment.
- -- <u>Rejected</u>: The 7-14 day requisition was rejected by GSA. Click on REJECTED to reveal why the requisition was rejected. The status codes explaining why the requisition was rejected are identical to the codes used in the FEDSTRIP process
- -- <u>Canceled</u>: For 7-14 day delivery items, the requisition/purchase order has been canceled, either by you or GSA. To review why the requisition was canceled, click on CANCELED. The status codes explaining why the requisition was canceled are identical to the codes used in the FEDSTRIP process. For 1-3 day delivery items, CANCELED indicates that the CSC is out of stock and you should order at a later date. For Federal Supply Schedule purchase orders, CANCELED indicates that the purchase order has been canceled by you and the vendor has been notified.

- -- <u>Confirmed</u>: The 1-3 day document number has been received by the CSC and the order is being shipped.
- -- <u>Suspended</u>: The 7-14 day requisition was suspended by GSA. Click on SUSPENDED to reveal why. Reference the FEDSTRIP codes.
- -- <u>Direct Ship</u>: The delivery order was issued by GSA to the vendor for direct shipment to you.

FEDSTRIP codes are available in the Fedstrip Operating Guide (FOG) and the Customer Assistance Guide. Call GSA's Centralized Mailing List Service (CMLS) at (817) 334-5215 to order these publications.

Comprehensive Guideline for Procurement of Products Containing Recovered Materials (CPG).

The U.S. Environmental Protection Agency (EPA) has added envelopes of DuPont Tyvek[®] to its Comprehensive Procurement Guidelines and accompanying Recovered Materials Advisory Notice, known as the "CPG" and "RMAN," making them the best performing envelope in the plastic envelope category designated in the Environmental Purchase Preference Program of the Federal government.

The rule making published in the Federal Register November 13, 1997, specifically designates plastic envelopes manufactured from DuPont Tyvek[®] "or equal" as an item whose procurement will carry out the objectives of section 6002 of RCRA. All TyvekTM envelopes are made with 25 percent post-consumer-recycled content (PCR), are 100 percent recyclable. DuPont has put in place the infrastructure to recycle Tyvek[®] at more than 70 sites throughout North America that recycle flexible HDPE, identified with an HDPE resin code Number 2.

The EPA's Comprehensive Guideline for Procurement of Products Containing Recovered Materials (CPG) is designed to foster markets for materials recovered from the solid waste stream by using government purchasing power -- as the nation's single larg-

est consumer of products and service -- to stimulate the use of these materials in the manufacture of new products.

The CPG implements a section of the Resource Conservation and Recovery Act (RCRA) that requires EPA to designate items that are produced with recovered materials and to recommend practices for the procurement of designated items by Federal or state procuring agencies. Once EPA designates an item, RCRA requires any procuring agency using Federally-appropriated funds to buy that item to purchase it with the highest percent of recovered materials practicable.

On November 7, 1996, the EPA proposed and published in the Federal Register to add 13 new items to its Comprehensive Guideline for Procurement of Products Containing Recovered Materials, which had been first issued May 1, 1995. The amended CPG, known as CPG II, and related Recovered Materials Advisory Notice (RMAN II) bring to 31 the total number of recovered content items designated for procurement in CPG I and CPG II. CPG I had designated 19 items in seven product categories containing recovered content that government procuring agencies are required to purchase.

Earlier, on October 20, 1993, President Clinton had issued Executive Order 12873, "Federal Acquisition, Recycling, and Waste Prevention," that directs federal agencies to give preferential purchase consideration to recycled and environmentally preferable products and services. Officials at the Office of the Federal Environmental Executive recently promulgated the goal of the Executive Order: "To establish the United States Government as a leader, both domestically and internationally, in waste reduction, source separation, and the procurement of recycled content products."

The EPA's proposed CPG II rule making issued in 1996 noted that the most common government use of Tyvek[®] envelopes was by "express mail, insurance, bank, legal, medical and international mail industries in heavy-duty, security-related and other specialized mailing applications." These and other new envelope designs and applications for Tyvek[®] were highlighted recently at the DuPont Tyvek[®] and several government booths at the National Marketplace for the Environment. Inter-Agency Transportation Management System (ITMS)

In 1997, GSA implemented the Inter-Agency Transportation Management System (ITMS). ITMS replaced GSA's previous automated rate and routing system commonly referred to as Muffin or ARFARS. ITMS is a PC-based system using CD-ROM technology and will run on a user's own computer or from an office's Local Area Network (LAN). Federal agencies (for freight, only those offices/locations that have entered into funding agreements with GSA for the payment of freight services provided) can now access discounted rate offers and related accessorial service charges via cost comparisons for both freight (domestic, less-than-truckload and truckload shipments moving via closed van) and household goods (intrastate, interstate, and international) shipments via ITMS. In addition to rate and routing information, ITMS also provides users with reporting functions. Reports can be created for a specific carrier, combination of carriers, or all carriers by transportation and/or accessorial service offers for all general, alternating, and non-alternating rate offers by specific or all origins and destinations. For household goods, reports can also be created to show percentages offered for storage-in-transit, unaccompanied air baggage, and privately owned vehicles in addition to a carrier's approved scope of operations. All reports can be imported into a spreadsheet application for statistical studies. ITMS can also provide the user with the ability to view/print carrier information to include such things, if available, as carrier name, Standard Carrier Alpha Code (SCAC), mailing address, point of contact, phone/facsimile numbers, and an e-mail address. ITMS is distributed on a semi-annual basis and each distribution of ITMS is scheduled to contain increased functionality. Any questions regarding ITMS should be directed to the Agency's GSA National Account Manager.

Freight Management Program Standard Tender of Service (STOS)

GSA's Standard Tender of Service (STOS) for General Freight serves as the base document for the transportation of freight-all-kinds (FAK) shipments by those Federal civilian agencies that participate (have entered into funding agreements with GSA for the payment of services provided) in GSA's Freight Management Program.

The STOS comprises the following three parts:

- -- GSA General Freight Tender of Service No. 1-F (establishes such provisions as carrier approval requirements, solicitation and submission of rate offer procedures, performance requirements, service standards, and nonuse procedures).
- -- GSA National Rules Tender No. 100-D (replaces all carrier and bureau rules and accessorial tariffs).
- -- GSA Baseline Rate Publication No. 1000-D (replaces all carrier and bureau line haul tariffs).

The Freight Management Program has agreements with more than 300 carriers approved to haul government freight shipments. Rate offers for the transportation of FAK shipments solicited and accepted in accordance with the STOS provide participating Federal agencies with the most economical and responsive transportation rates and services. In addition to assisting participating Federal agencies with the transport of their FAK shipments, GSA will also help those agencies with all other freight-related shipments and/or questions. Federal agencies should contact their GSA National Account Manager for additional information on GSA's Freight Management Program.

Centralized Household Goods Traffic Management Program

GSA/FSS Transportation Management Program Office has arrangements with more than 300 household goods common carriers both large and small for the shipment of household goods worldwide associated with work-required relocation of Federal employees. Federal agencies are provided a list of these carriers to use when selecting a carrier to handle its employee relocations based on the level of past Federal customer satisfaction and the carrier's offered discount.

Basic carrier performance requirements and program standards are published in the GSA Household Goods Tender of Service (TOS) Agreement. Further information about arranging and managing a household-goods move is contained in the GSA Publication 1993 Edition, Agency Guide: Shipping Your Household Goods. Relocating employees may also review the GSA Publication 1995 Edition, Employee Guide: Shipping Your Household Goods.






