The shadow of Freud looms large over our cultural consciousness, even though orthodox medical psychiatrists have long moved beyond him. This course will explore how, where and in what contexts Freud evolved his formulations of mental function, how they spread (or did not spread) beyond Freud's own circle and how his theories have been interpreted by his followers and opponents over the years. We shall pay particular attention to debates within late-nineteenth-century psychiatry, neurology and racial biology that shaped Freud's thought and investigate how he sought to resolve them through psychoanalytic theory. Another major theme of the module will be the history of the psychoanalytic *movement*. Through a study of some of the important schools and factions – such as those founded by Carl Gustav Jung, Alfred Adler or Melanie Klein – emerging from classical psychoanalysis, we shall map the ways in which these divisions, although weakening the Freudian denomination, widened the cultural scope of dynamic psychology. Finally, we shall examine the curious fate that befell psychoanalysis in the later decades of the twentieth century, when its decline within medicine was almost as speedy as its rise to prominence in academic and humanistic discourse.

The module will be taught through weekly 2-hour seminars, held every **Tuesday**, commencing on **11 January 2005**.

Except for the introductory session, each class will start with a 10-15 minute student presentation on assigned texts.

Assessment: Assessment will be on the basis of one essay (4000-5000 words) on a title to be decided in consultation with the instructor, to be submitted (*with the School's cover sheet and signed plagiarism statement, available from the School of History office*) to the **Postgraduate Administrator** in the History Office by **9 May 2005**.

Virtually all of Freud's writings are available in the *Standard Edition of the Complete Psychological Works of Sigmund Freud*, edited by James Strachey and published in 24 volumes. Birkbeck Library owns a complete set and various odd volumes in addition; it is recommended that you use this resource as far as possible and read some of Freud's major works in full. For those seriously short of time, however, abridged extracts of many important texts are available in the single-volume *Freud Reader* edited by Peter Gay (1989).




