

#### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's Canteen.
- Any US Citizen

# **MAJOR DUTIES:**

The incumbent performs Vascular and Non Vascular Interventional Procedures of the head, neck spine, chest and body. These exams are performed with and the use of contrast materials. The purpose of these exams is to achieve diagnostic studies to bring about proper diagnosis, and potentially treat diagnosed diseases. Schedules exams in a manner so as to optimize the time to do the exams while maintaining flexibility for emergency cases. Confers with radiologists to determine requirement of non-standard exams. Performs neuroangiography, including spine, head and neck studies utilizing highly sophisticated x-ray equipment such as computerized fluoroscopy, pressure injectors, parallelogram biplane imaging, patient monitors, etc. Performs peripheral and visceral angiography of the abdominal systems and extremities. These angiographic studies include renal, hepatic, mesenteric, aortic, femoral, etc. (The exams involve the use of highly sophisticated x-ray equipment such as computerized fluoroscopy, pressure injectors, biplane imaging, patient monitors, etc.) Performs most exams utilizing surgical sterile techniques. Works with the radiologist as a member of the surgical/radiographic team. Prepares contrast materials that are used in angiography and other exams. Practices radiation safety in order to reduce exposure to patients, staff and self. Performs reconstructions of angiographic studies when requested or when part of a standard procedure. Maintains records and files of exams performed on patients. Properly identifies patient images. Responsible to explain exams to competent patients so that patients understand what is to be done as well as what hazards, if any, are possible. Responsible for stocking and inventory of all angiography supplies and related materials. Performs irregular hour emergency scans on standby, 24 hours per day, coverage. Continually reviews new developments in the field of angiography.

## **QUALIFICATION REQUIREMENTS:**

<u>Eligibility</u>: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G25) for GS-0647 series applies and may be reviewed in the Human Resources Management Service Office.

#### **Basic Requirements:**

- Citizenship: Citizen of the United States
- Certification: All applicants must be certified in general radiologic technology by the American Registry of Radiologic Technology (ARRT) (R).
- Experience or Education: Completion of a full-time training course of at least 24 months duration (or the equivalent) in a post-high school diagnostic radiologic technology program, evidenced by a certificate or an associate's degree, accredited by the Joint Review Committee on Education in Radiologic Technology (JRCERT), and certification by the American Registry of Radiologic Technologists (ARRT) in radiology. Public Law 97-35, the Consumer-Patient Radiation Health and Safety Act of 1981, requires that persons who administer radiologic procedures meet the credentialing standards in 42 CFR Part 75, Standards for the Accreditation of Educational

Programs and the Credentialing of Radiographic Personnel. Essentially, they must have successfully completed an educational program that meets or exceeds the standards described in that regulation, and is accredited by an organization recognized by the Department of Education, and be certified as radiographers in their field.

Specialized Experience: Cardiovascular-interventional technologists (CV) use specialized equipment to perform diagnostic angiographic procedures and complex vascular and nonvascular interventional and therapeutic procedures. This specialty requires additional knowledge of vascular systems and major vessel anatomy. The technologist must be knowledgeable in the specialized equipment employed for digital subtraction systems and interventional procedures. The technologist administers contrast media under the supervision of the staff radiologist and confers with the radiologist to establish requirements with reference to contrast agents, vital signs, medications, and physiologic monitoring to perform procedures. CV technologists must be knowledgeable in Computerized Radiography (CR) and Picture Archiving and Communications Systems (PACS). Completion of 1 year of experience equivalent to the next lower grade level directly related to the position being filled, and must fully meet the KSAs at that level. In addition, the candidate must demonstrate the following technical KSAs and demonstrate the potential to acquire the assignment specific KSAs designated by an asterisk (\*)

## BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs))

Applicants must demonstrate through their experience or education that they possess the following published KSAs (from VA Handbook 5005) for the grade at which they wish to apply (and grades below that grade if applicable):

#### GS-8:

- 1. Ability to check system for operation and assess acceptable performance based on established guidelines.
- 2. Knowledge of calibration parameters and the ability to make adjustments as needed;
- 3. Knowledge of patient's clinical record, diagnosis, and laboratory results.
- 4. Ability to monitor patient's physiologic changes during the procedure and keep the radiologist informed;
- 5. Skill in using tact, diplomacy, and courtesy in dealings with the customer base, patients, staff, family, visitors, and volunteers
- 6. Knowledge of anatomy and physiology, and cross-sectional anatomy, recognizing unusual images, and determining proper positioning to best demonstrate areas of interest.

#### GS-9:

- \*1. Ability to balance the needs of the patients and staff while still performing complex scans and procedures.
- Skill to demonstrate appropriate techniques to gather relevant information from the medical record, significant others, and health care providers.
- \*3. Ability to assess factors that may contraindicate the procedure.
- 4. Knowledge of basic first aid and basic life support practices related to radiography.
- 5. Knowledge of physical assessment, aseptic techniques, intravenous skills, and universal precautions.
- Knowledge in pre-procedural, procedural, and post-procedural care of patients.

## **CONDITIONS OF EMPLOYMENT:**

This is an Excepted Appointment. Excepted service positions have been excepted from the requirements of the competitive service by law, Executive Order, or by OPM regulation (5 USC 2103 and 5 CFR part 213). Public law No. 108-170 converts this occupational series from the competitive civil service to the Hybrid Title 38 employment system.

Applicants without prior federal service will be appointed at step one of the grade

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

All information submitted to this VA Medical Center is subject to verification by VetPro.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
