1. Duneier, Mitchell.

Sidewalk / McMitchell Duneier ; with photographs by Ovie Carter ; and an afterword by Hakim Hasan. Farrar, Straus and Giroux, 2001. 383 p. 305.568 DUN

Duneier offers a vibrant portrait of a community in the shadows of public life. A white, middle-class sociologist whose Slim's Table won plaudits for its nuanced portrait of urban black men, Duneier infiltrated a stretch of lower Sixth Avenue frequented by scavengers, panhandlers and vendors of used and discounted books and magazines. As participant-observer, he spent months working the vendors' tables, gaining impressive access and insight. He suggests, contrary to Christopher Jencks in *The Homeless*, that many choose to sleep on the sidewalk even if they have money for a room. He not only observes but experiences arbitrary displays of authority by the police, who tell him to stop selling books and magazines one Christmas. Duneier adroitly explains how disparate policies -- such as pressure on the homeless at Penn Station and a law that exempts vendors of written matter from licensing - have redefined life and business conditions in the city streets. He further argues that, despite the apparent disorder created by the vendors, the sidewalk creates an opportunity for income, respect and social support. In a retort to the influential "broken windows" theory behind community policing, he concludes that policy makers must do better to distinguish between inanimate signs of decline, such as graffiti, and the vendors or panhandlers who strive for better lives. The dozens of photos interspersed throughout - by Chicago Tribune photographer Carter, a previous collaborator with the author - add depth to a book that achieves a remarkably intimate perspective on life on the margins of New York City. The central part of the book addresses the question of divided representation – the tension between the instrumental and the communicative roles of architecture – in the period of the baroque, when architectural thinking was seriously challenged by the emergence of modern science. Vesely sees the restoration of this communicative role of architecture as the key to the restoration of architecture as the topological and corporeal foundation of culture; what the book is to our literacy, he argues, architecture is to culture as a whole. 3. Encyclopedia of early cinema / edited by Richard Abel. Routledge, 2005. 791 p. REF 791.4309 ENC

For the purposes of this work, "early" cinema is defined as the period from the mid-1890s to the 1910s, although some entries cover earlier and later years. The scope is international, with some attention being paid – however briefly – to the development of cinema throughout the world, including the African colonies of the great powers. Editor Abel presents nearly 1000 alphabetically arranged entries written by experts from the United States and Europe; a useful thematic index draws similar topics and concepts together, among them "Cultural Contexts" (e.g., advertising, modes of reception, world's fairs), audiences/spectatorship, "Social Contexts" (e.g., imperialism, race), technology, developments in film style, and the topic with the largest number of entries, key figures of the various national cinemas (e.g., Sarah Bernhardt). 4. Film and television after 9/11 / edited by Wheeler Winston Dixon. Southern Illinois University Press, ©2004. 262 p. 791.43 FIL

In *Film and Television after 9/11*, twelve distinguished scholars and critics discuss the production, reception, and distribution of Hollywood and foreign films after the terrorist attacks of September 11, 2001, and examine how movies have changed to reflect the new world circumstances. While some contemporary films offer escapism, the bulk of mainstream American cinema since 9/11 seems centered on the desire to replicate the idea of the "just war," in which military reprisals and escalation of warfare appear to be both inevitable and justified. Films such as *Black Hawk Down, Collateral Damage*, and *We Were Soldiers* reflect a renewed audience appetite for narratives of conflict, reminiscent of the wave of filmmaking that surrounded American involvement in World War II. The attacks on the World Trade Center and the Pentagon have galvanized the American public into a call for action, and film critics wonder

how this will play out in the months and years to come. How will American films shape the perspectives of other nations? What sort of dialogue do post-9/11 films establish? How to now review the films of shared cinematic past in light of these recent events? And how to replay the events of the 1940s and 1950s, albeit in a hyperstylized, MTV-edited format? With an introduction by editor Wheeler Winston Dixon and original essays by leading cinema scholars, this book offers critical insights into these and other concerns. Open wide : how Hollywood box office became a national obsession / Dade Hayes and Jonathan Bing. Miramax Books/Hyperion, ©2004.

Ever since multinational corporations gobbled up independent studios, Hollywood's main concern is a film's bottom line rather than its art. Increasingly, the intense focus has been on the picture's first weekend of release, during which box office receipts are considered a make-or-break situation. Variety's Dade and Bing track three much-hyped films Terminator 3, Legally Blonde 2, and the animated feature Sinbad through their feverish marketing campaigns and openings. Somewhat surprisingly, the makers of the first two films granted cooperation; DreamWorks, the producer of Sinbad, declined (nonetheless, the authors succeed admirably in tracking its progress). With many hundreds of millions of dollars at stake, intense marketing attention was given to previews (mostly for those under 21), meetings with theater operators, and film festivals. Ultimately, each movie turned out to be somewhat of a disappointment, but this book is a major success. Kenneth King is one of America's most inventive postmodern choreographers. His dancing has always reflected his interest in language and technology, combining movement with film, machines, lighting and words both spoken and written. King is also conversant in philosophy, and some of his most influential dances have been dedicated to and in dialogue with the work of such philosophers as Susanne K. Langer, Edmund Husserl and Friedrich Nietzsche. Since the 1960s, he has performed his dance to texts both spoken and prerecorded – texts intended to stand separately as literary works. *Writing in Motion* spans more than thirty years and is collected here for the first time. It includes essays, performance scripts of King's own work, art criticism, philosophy and cultural commentary. Dense with movement, these writings explode and reconfigure the familiar, crack syntax open, and invent startling new words. Dancing, to King, is "writing in space," and writing is a dance of ideas. The remaining chapters examine the great number of styles shown in those movies and take the reader up to the final triumph of modernist architecture in the aftermath of the Second World War. Roughly covering the period 1915 to 1955, the heyday of constructed studio sets, Ramirez explores the use of architectural elements in Hollywood film, paying particular attention to the stylistic interchanges between film and the more permanent built word. One oft-heard comment about Welch's generally praised (and bestselling) 2001 memoir, Jack: Straight from the Gut, was that the book skimped on useful business advice. The respected but controversial former chief of General Electric pays readers back double here. Written with Welch's wife, a onetime editor of the Harvard Business Review, the book delivers a brilliant career's worth of consistently astute (and often iconoclastic) business wisdom and knowledge from the man Fortune magazine called "the manager of the century." Welch knows what he's talking about, and here offers an admirably concise primer on how to do business that's a paragon of tough common sense. From practices he employed at GE (e.g., the much-debated differentiation, which includes winnowing 10% of the workforce at regular intervals), to the personal qualities that lead to success (to Welch, candor is essential), to advice on job hunting and how to work with a bad boss, to ways to maximize the budget process (divorce it from performance rewards), Welch comments frankly and by myriad example, with a common touch that will draw readers in ("that was hardly the first time I'd gotten my clock cleaned by the press"). He explains upfront that the book arose as an attempt to codify his beliefs, in response to the many questions he's received at numerous public appearances since he retired from GE in 2001; as such the book has a somewhat lumpy feel, like an overstuffed bag of presents. Congress, the Press, and Political Accountability is the first large-scale examination of how local media outlets cover members of the United States Congress. Using three samples of local newspapers from across the country, Arnold analyzes all coverage over a two-year period – every news story, editorial, opinion column, letter, and list. The results show enormous variation in coverage. Some newspapers cover legislators frequently, thoroughly, and accessibly. Others – some of them famous for their national coverage – largely ignore local representatives. The analysis also confirms that only those

Although Walter Lippman captured the essence of the media's powerful influence early in the last century with his phrase, "the world outside and the pictures in our heads," a detailed, empirical elaboration of this agenda-setting role of the mass media did not begin until the final quarter of the 20th century. In this comprehensive book, Maxwell McCombs, one of the founding fathers of agenda-setting tradition of research, synthesizes the hundreds of scientific studies carried out on this central role of the mass media in the shaping of public opinion. In *The Digital Sublime* Vincent Mosco goes beyond the usual stories of technological breakthrough and economic meltdown to explore the myths constructed around the new digital technology and why we feel compelled to believe in them. He tells us that what kept enthusiastic investors in the dotcom era bidding up stocks even after the crash had begun was not willful ignorance of the laws of economics but belief in the myth that cyberspace was opening up a new world. Myths are not just falsehoods that can be disproved, Mosco points out, but stories that lift us out of the banality of everyday life into the possibility of the sublime. He argues that if we take what we know about cyberspace and

situate it within what we know about culture – specifically the central post-Cold War myths of the end of history, geography, and politics – we will add to our knowledge about the digital world; we need to see it "with both eyes" – that is, to understand it both culturally and materially. After examining the myths of cyberspace and going back in history to look at the similar mythic pronouncements prompted by past technological advances – the telephone, the radio, and television, among others – Mosco takes us to Ground Zero. In the final chapter he considers the twin towers of the World Trade Center – icons of communication, information, and trade – and their part in the politics, economics, and myths of cyberspace. Since 1965 an increasing preoccupation with money has resulted in the inversion of its role in higher education, from a practical means to an end that crowds out all others. No longer do students and parents choose the best

education that "money can buy." Instead, they are faced with choosing which college or university will "buy them more money." This comes as no real surprise, as the cost of attending a four-year college has doubled since 1985. Yet the question persists: at what real cost are we sending our students to college? James Engell and coauthor Anthony Dangerfield explore the answer to this question in *Saving Higher Education in the Age of Money*. In their analysis of admission practices, institutional rankings, salaries, hiring practices, scholarships, student attitudes, tuition costs, research programs, library budgets, and class barriers, Engell and Dangerfield expose the major changes that the Age of Money has wrought in higher education while also offering a practical method of understanding and prioritizing the various elements involved in choosing the right school. An agency with almost unparalleled power, the Food & Drug Administration (FDA) is both widely celebrated and widely reviled. Paradoxically, its authority is tenuous. In the face of unremitting attacks, it must labor for its own survival while championing consumer safety. Businesses accuse the FDA of delaying the development and availability of life-saving products, while consumers accuse it of colluding with businesses and failing to protect against predatory industry practices. Drawing on extensive research and more than 200 interviews, Hilts, a veteran, award-winning science writer, effectively debunks common criticisms of the FDA. He offers an important perspective on the agency's long history of glorious victory and deadly failure while providing profound insight into issues emerging at the intersection of science, business, and ethics. It is strange, however, that Hilts does not discuss several recent FDA controversies, for example, the furiously disputed safety of the artificial sweetener, aspartame, and of food irradiation, both FDA-approved. Still, those who ponder the mysteries of human nature that too often lead to the sacrifice of human safety for economic gain will find much of value here. Cohen brings together seminal research essays on international political economy published in academic journals since the birth of the field in the early 1970s. He begins with 4 papers from international political economy pioneers Susan Strange, Robert Gilpin, Peter J. Katzenstein, and Peter Gourevitch. Eight papers then look at issues of systemic transformations and system governance. The remaining eight papers address the two most central issue-areas of the world economy, international trade and international money and finance. Specific topics include embedded liberalism and international regimes, transactions and change; state power and the structure of international trade; the legalization of international monetary affairs; democracies, autocracies, and international trade negotiations; capital mobility and state autonomy; and the politics of national economic policies in a world of global finance. In this landmark work, a Nobel Prize winning economist develops a new way of understanding the process by which economies change. Douglass North inspired a revolution in economic history a generation ago by demonstrating that economic performance is determined largely by the kind and quality of institutions that support markets. So from page one, it's clear that this account will break little new ground regarding the most vital aspect of Ronald Reagan's life: his political evolution and rise to power. Colacello's chief interest is family gossip and the Reagans' interactions with the world's social elites: the aging Duke and Duchess of Windsor, Frank Sinatra, Malcolm Forbes, and Lee and Walter Annenberg, among many others. Throughout the book, vast political generalizations dovetail with energetic name-dropping and a recitation of the Reagans' social calendar. Colacello also focuses on the Reagans' relationships with their children, and some of these details are quite interesting: during the 1970s, Ron Jr. could be heard by neighbors in Pacific Palisades screaming at his mother: "Leave me alone!... All I want is to be left alone." On the political side, Colacello provides a

readable but not incisive chronicle of well-known events, almost always adopting Nancy Reagan's point of view vis-a-vis her husband's assistants, associates, allies and enemies (the author had Nancy's cooperation). He's also moved by the need to wean Americans from "the wrong energy sources controlled by the wrong people," a principle that influences not just his environmental views but his attacks on corporate subsidies and, perhaps, his goal of elevating Middle Eastern economies through trade in products other than petroleum. "Hard America" is characterized by competition and accountability, while "Soft America" attempts to protect its citizens through government regulation and other social safety nets. While Barone's book is not without its political overtones – he identifies Hard America with the political right and Soft America with the left – his book should

not be seen as the latest installment in the conservative-liberal cultural wars. Rather, Barone provides a deeper look at the way in which ordinary people live and work and the meaning behind the decisions they make. His concrete historical examples highlight the advantages and disadvantages of Hard and Soft America, creating a compelling picture of two very different ways of looking at the world, without degenerating into mudslinging or name-calling,. Although Barone, a conservative, clearly favors Hard America, he appreciates the necessary difficulty that comes with balancing the two Americas. He concedes that a society without some softness would be a cruel one, but warns that "Americans have the luxury of keeping parts of their society Soft only if they keep enough of it Hard." Despite his conservatism, Barone (*The New Americans*) writes with moderation and insight. In this examination of white and Mexican-American girls coming of age in California's Central Valley, Julie Bettie turns class theory on its head and offers new tools for understanding the ways in which class identity is constructed and, at times, fails to be constructed in relationship to color, ethnicity, gender, and sexuality. Documenting the categories of subculture and style that high school students use to explain class and racial/ethnic differences among themselves, Bettie depicts the complex identity performances of contemporary girls. The title, *Women Without Class*, refers at once to young working-class women who have little cultural capital to enable class mobility, to the fact that class analysis and social theory has remained insufficiently transformed by feminist and ethnic studies, and to the fact that some feminist analysis has itself been complicit in the failure to theorize women as class subjects. Ever since the cloning of Dolly in 1997, critics have warned that human society has begun sliding down the slippery slope to post-humanity. In a rather repetitious and bland look at the moral questions arising out of biotechnologies such as cloning and stem cell technology, Smith (The Culture of Death: The Assault on Medical Ethics in America) does offer some helpful insight into the practices themselves. Much like Leon Kass, the chairman of the President's Council on Bioethics, and Francis Fukuyama (Our Posthuman Future), Smith argues that any medical or scientific development that diminishes human dignity - "the intrinsic worthiness of embodied human life" - ought to be avoided, regardless of the good it promises. Smith contends that the technologies are not in and of themselves pernicious; rather, the political, ideological and entrepreneurial promotion of any scientific advance, he asserts, can lead us to ignore its dangers (for instance, producing a hybrid pig-human embryo). Smith opposes human reproductive cloning and embryonic stem cell technology. On the other hand, he argues that some advances, such as adult stem cell technology and umbilical cord blood/stem cell technology (which has been used to treat sickle-cell anemia), should be embraced. Along the way, Smith makes some mistakes - Joseph Fletcher, for example, is not the "patriarch of bioethics" - and his case has been stated better and more forcefully by others, notably Kass.
