This new regulation allows for the irradiation of seed for sprouting, but does not require a statement on the sprout packaging to the effect that the seed has been irradiated.

It is the position of the International Sprout Growers Association that this regulation is potentially hugely damaging to our industry.

The consumers of our products are still largely "health food" oriented people who are eating sprouts for the nutritional benefits of the food. Demographically, these same consumers tend to be the people who are averse to any form of irradiation of food. When word gets out that the seeds from which the sprouts are made may be irradiated and they will have no way of knowing which ones have been and which ones have not been, the level of trust in the product will inevitably drop. This could cost the industry millions of dollars in lost sales.

It is our opinion that the level of trust in the regulatory decisions of the FDA will also drop. Consumers who dislike irradiation, for whatever reason, are adamant that they have a right to know which foods have been treated., It is unlikely that these consumers will want to stop eating a food that they value. They have the right to know that the sprouts they are buying have not been manufactured from irradiated seeds.
