Message from the Commissioner

I am pleased to introduce our Special Native Language Edition of the ANA Messenger. The recently passed Esther Martinez Native Languages Preservation Act has brought a new focus to preserving our Native Languages. Esther Martinez, or Blue Water as she was also known, has been described as a "National Treasure." To me that seems to be an understatement. From her time at boarding school, where she, like many others, was forced to use English and forego her Native language, she made the conscious decision to keep her Tewa language alive. She then proceeded to spend her 90 plus years teaching us all the stories of her people, even translating those stories so that non-speakers would be able to understand them. It has been said that "with a loss of a language we lose a window to culture." Esther Martinez knew it wasn't just a window to our culture; rather, it is the primary foundation of our culture.

ANA is thrilled to see the renewed focus on language and cultural preservation. Currently, ANA provides 60% of our language funding to Tribes and 40% to community non-profit organizations in the continental U.S., Alaska, Hawaii, Guam, American Samoa, and the Northern Marianna Islands. Over the last eight years (FY 2000 - FY 2007), ANA has funded 254 projects totaling \$56 Million, or an average of 59 projects and \$7 Million per year.

Over the past several years, ANA has dedicated increased funding to the Native Language Preservation and Maintenance Program. In FY 2007, ANA added a third category to the language program focused on language project implementation. In FY 2008, ANA added a fourth language category for language immersion projects. The addition of this fourth category creates the opportunity for Tribes and Native non-profit organizations to conceivably receive up to 9 years of funding at a total of \$1.75 Million, which is an additional 3 years of funding and access to an additional \$750,000.

With the daily passing of our elders, we are losing the sole speakers of our Native languages. In so doing, we lose our ability to identify something by its proper name and to understand the meaning of things from the heart. We in ANA are proud to support and contribute to the success of our grantees. Together, we are making a difference in the lives of our Native children, families and communities.

ANA Language Program

ANA provides project funding to eligible applicants for the purpose of assisting Native Americans to assure the survival and continuing vitality of their languages. The Esther Martinez Act (PL109-394) was enacted in Dec 2006 and amends the Native American Languages Act of 1992 (PL102-408) to authorize three-year grants for educational Native American language nests, survival schools, and restoration programs. To implement the statutory requirements of both the Esther Martinez and the Language Preservation and Maintenance Acts, ANA has expanded the Native Language Preservation and Maintenance Program in the FY 2008 Program Announcement.

The addition of Category IV creates the opportunity for Tribes and Native non-profit organizations to conceivably receive up to <u>9 years of funding</u> at a <u>total of \$1.75 Million</u>, which is an additional 3 years of funding and access to an additional \$750,000 dollars.

^{*}Language Nest Projects are defined by statute as site-based educational programs that provide Native Language for at least 10 children under the age of 7 for an average of at least 500 hours per year per student; provide language classes for parents and ensure that a Native American language is the dominant medium of instruction.

^{*}Language Survival School Projects as defined by statute are site-based educational programs for school age students that provide an average of 500 hours of Native language instruction through the use of one or more Native American languages for at least 15 students for whom a Native American language school is their principle place of instruction; develop instructional courses and materials for Native American languages and for instruction through the use of Native American languages; provide for teacher training; work toward a goal of all students achieving fluency in a Native American language and academic proficiency in mathematics, reading, science; and is located in areas that have high numbers or percentages of Native American students.



Language Project Impact Visits

Annually, ANA conducts impact visits on ANA funded projects. The purpose of impact visits is threefold: 1) to assess the impact of ANA funding on Native American communities; 2) to learn more about the successes and challenges of ANA grantees to improve ANA service delivery; and 3) to increase transparency and share the grantee's unique stories. Twenty language projects were evaluated in 2007. Ninety percent of these projects demonstrated success in meeting project objectives.

Immersion

Currently ANA has 46 language projects for a total of \$5.7 million in funding for FY 2007. Of these projects 5 are Language I, 23 are Language II and 18 are Language III.


18 of these 46 projects, or 39%, have immersion project components.

Historical Language Funding

Over the last eight years (FY 2000 - FY 2007), ANA has funded 254 projects totaling \$56 Million, or an average of 59 projects and \$7 Million per year.


ANA has received 859 language applications in the same eight year period, requesting \$97 Million. ANA funded approximately 30% of the language applications received.

In an analysis of language funding over the past ten years, Commissioner Stamps has increased ANA language funding by an average of 7 Million Dollars since being appointed in December 2003.


