Brief Abstract

DESCRIPTION

This measure is used to assess the percentage of pediatric acute gastroenteritis patients with documentation of hydration status.

RATIONALE

According to the American Academy of Pediatrics (AAP) and the U.S. Centers for Disease Control and Prevention (CDC), successful implementation of oral rehydration therapy (ORT) starts with the evaluation of the child's degree of dehydration.

Certain signs and symptoms can quantify the extent of a patient's dehydration. Clinical examination of the child provides an opportunity for physical assessment,

including vital signs, degree of dehydration, a more detailed history, and for providing instructions to the caregivers.

Determining the level of hydration in a child with acute gastroenteritis provides the basis for beginning appropriate oral rehydration therapy, along with assisting the provider in determining the severity of the condition and whether of not the child's condition can be safely managed at home by the parent/caregiver.
