NMFS ANNOUNCES THE AVAILABLITY OF THE DRAFT AMENDMENT 2 TO THE CONOSLIDATED HIGHLY MIGRATORY SPECIES FISHERY MANAGEMENT PLAN AND ITS PROPOSED RULE FOR MANAGEMENT OF ATLANTIC SHARK FISHERIES

The National Marine Fisheries Service (NMFS) is currently amending the Consolidated Highly Migratory Species (HMS) Fishery Management Plan (FMP) and proposing a range of management measures that will affect commercial and recreational shark fishermen and dealers. Recent (2005-2006) stock assessments determined sandbar and dusky sharks to be overfished with overfishing occurring and porbeagle sharks to be overfished. This current rulemaking would rebuild overfished shark stocks and stop overfishing. **UPDATE: The proposed rule for this action published in the Federal Register on July 27, 2007 (72 FR 41392), and is on the HMS Management Division's webpage at http://www.nmfs.noaa.gov/sfa/hms.**

NMFS will hold numerous public hearings for this rulemaking along the Atlantic Coast, including the Caribbean and Gulf of Mexico regions, in August through October 2007. During these hearings, NMFS will receive public feedback on the proposed management measures. The management measures include, but are not limited to:

- Initiating rebuilding plans for sandbar, dusky, and porbeagle sharks;
- Removing seasonal trimesters and regions;
- Prohibiting retention of porbeagle sharks by commercial and recreational fishermen;
- Implementing eight marine protected areas as requested by the South Atlantic Fishery Management Council;
- Reducing quotas and retention limits consistent with the stock assessments;
- Establishing a shark research fishery that would meet the research objectives of the Agency and allow data collection programs;
- Allowing limited landings of sandbar sharks within a shark research fishery and landings of other shark species both inside and outside a shark research fishery; and
- Modifying recreational measures so that recreational fishermen can only land shark species that are easy to identify, therefore, reducing fishing mortality of sharks under rebuilding plans

The locations of public hearings are listed in the Table 1. NMFS will also be presenting Amendment 2 to the Consolidated HMS FMP at five Fishery Management Councils and Atlantic States Marine Fisheries Commission summer meetings.
