The increasing integration of the global economy has brought with it an increase in the sale and re-sale of U.S. goods, services, and technologies. It is becoming more and more difficult to know which products are subject to U.S. regulation, which regulations apply, and how to ensure that you are operating within the law.

If your business is involved in international trade, it is cogent upon you to be aware of national, European Union as well as U.S. export regulations. Neglecting export and re-export regulations can lead to fines, the exclusion from trade with American goods, even criminal prosecution.

Speakers

Hillary Hess, Director of the Regulatory Policy Division (RPD), Office of Exporter Services. Hillary Hess develops and implements changes to the Export Administration Regulations (EAR) in coordination with other export control offices and agencies. She was involved in the regulatory reform project that revised the EAR in 1996. She has been at the Bureau of Industry and Security (formerly the Bureau of Export Administration) since 1988.

Kirsten Mortimer is the Director of the Bureau of Industry and Security's (BIS) Outreach and Educational Services Division (OESD) which is the focal point for BIS's outreach to the business community in the eastern region of the United States, providing guidance on export control policies and procedures through export counseling and outreach activities. OESD plans and conducts seminars, conferences, webinars, and other outreach efforts to help exporters understand and comply with the Export Administration Regulations (EAR).

Lieutenant Colonel Scott Dullea assumed the duties as Chief, Office of Defense Cooperation - Vienna on 1 July 2007. In this position, he represents not only the US Embassy in Vienna, but also the Commander of the US European Command. LTC Dullea is a graduate of the US Army Airborne and Ranger Schools, the Foreign Area Officer Training Program at the George C. Marshall Center for European Security Studies, the Swiss Military Academy's *Diplomlehrgang*, and the Defense Institute of Security Assistance Management.

James Plitt, Immigration and Customs Attache, Department of Homeland Security, U.S. Embassy in Vienna, with operational responsibility for Austria, Czech Republic, Slovakia, Hungary, Romania, Slovenia, Bulgaria, Bosnia-Herzegovina, Croatia, Serbia Montenegro, Albania and Macedonia. Conducts criminal investigations in concert with foreign law enforcement partners. Mr. Plitt also served as a Division Director at ICE Headquarters and Director of Cyber Investigations in ICE Headquarters in Washington, DC.

Helmut Krehlik, Head of the Department Export Controls and Import Licensing, Austrian Ministry of Commerce and Labour. Mr. Krehlik and his staff are responsible for the formulation of export control legislation and as well as the licensing process for both dual-use and military goods, including embargoes, and national authority of the Chemical Weapons Convention in Austria.
