

NOTICE OF FEDERAL BAR EXAMINATION SEMINAR

On **Wednesday, May 23, 2007**, between 9:00 a.m. and 11:45 a.m., the John W. Peck Cincinnati-Northern Kentucky Chapter of the Federal Bar Association, in cooperation with the Cincinnati Bar Association, will present a seminar to prepare attorneys for the examination for admission to practice before the United States District Court for the Southern District of Ohio. The seminar will discuss the subject matter of the examination, practice in the Southern District, and counsel's obligations as a practitioner before the Court. 2½ hours of CLE credit in Ohio is pending. You may pre-register for the seminar by completing and returning the tear-off sheet below with your check. You may also register at the door between 8:30 and 9:00 a.m. on the day of the seminar, space permitting. Appropriate business attire is required, and no beverages are permitted in the Courtroom.

You must apply separately to take the June 5, 2007 examination at the Clerk's Office. Return the application to take the examination directly to the Clerk's Office.

Admission to the seminar is \$100. Members of the Federal Bar Association pay \$75 with a current membership number. Membership applications will be available at the seminar, and the \$25 differential will be refunded to applicants who subsequently demonstrate membership in the FBA.

The seminar will be held on the 8th floor in Courtroom 810 of the Potter Stewart United States Courthouse, Fifth and Walnut Streets, Downtown Cincinnati.
