#### USDA's National Organic Program (NOP)

The Organic Foods Production Act (OFPA) was passed by Congress in 1990. The OFPA required the U.S. Department of Agriculture (USDA) to develop national standards for organically produced agricultural products to assure consumers that agricultural products marketed as organic meet consistent, uniform standards. Regulations require that agricultural products labeled as organic originate from farms or handling operations that are certified by a State or private entity that has been accredited by the USDA. The NOP is a marketing program within the USDA Agricultural Marketing Service. Neither the OFPA nor the NOP regulations address food safety or nutrition.

NOP regulations prohibit the use of genetic engineering, ionizing radiation, and synthetic substances in organic production and handling. As a general rule, all natural (non-synthetic) substances are allowed. There is a national list of Allowed Synthetic and Prohibited Non-Synthetic Substances, a section in the regulations, contains the specific exceptions to the rule.

More consumers are looking to purchase organically grown or produced dairy products, vegetables, fruits, etc. If you are currently providing organic products or are interested in getting started in organic farming you can obtain the information you need from the USDA at www.usda.gov, or contact Rick Macsuga at the CT Department of Agriculture at (860) 713-2500.

#### 2008 Crop Year Wool, Mohair, and Unshorn Pelt Marketing Assistance Loan (MAL) and LDP Policy

The Consolidated Appropriations Act, 2008—was signed by the President on December 26, 2007. This act authorizes MAL and LDP programs for 2008 crops of graded and ungraded wool, mohair, and unshorn pelts through March 15, 2008.

<u>Note</u>: The 2008 crop year wool and mohair loan rates will remain unchanged from the 2007 crop loan rates. Graded Wool: \$1.00/lb., Ungraded Wool: \$.40/lb., Mohair \$4.20/lb. Please contact us at (860) 774-8397, ext. 1, for more information.


## Connecticut Renewable Energy Incentive Program

CT Clean Energy Fund (CCEF) offers rebates for CT residents who install solar electric (photovoltaic) systems on their homes. The incentives are available through Solar Works Inc., designated as an approved installer by CCEF. They also have an on-site Renewable DG Program providing financial support to stimulate demand for behind-the-meter installations of CT commercial, industrial and institutional buildings.

- The program offers grants to buy down the cost of solar electric generating systems;
- Grant amount for a given project will be limited up to \$4 million;
- Grant request must be made through an application process with CCEF Board;
- The Energy Policy Act of 2005 established a 30% investment tax credit;
- To be eligible for the tax credit the system must be placed into service before December 31, 2008
