ENFORCEMENT PROCEEDINGS

SEC CHARGES TWO MORE CENTRAL MAINE POWER EMPLOYEES WITH INSIDER TRADING THROUGH 401(k) PLAN

On April 23, the Commission filed injunctive actions against Robert K. Gasper and James D. Fairfield for illegal insider trading in the common stock of CMP Group, Inc. The complaint alleges that Gasper and Fairfield, former employees of Central Maine Power Company, a subsidiary of CMP, invested all of the assets in their 401(k) plans in a CMP stock fund on June 14, 1999. The next day, CMP publicly announced its plan to merge with Energy East Corporation. Gasper, who invested \$336,528, made an illegal profit of \$88,604 and Fairfield, who invested \$304,556, made an illegal profit of \$80,186.

The Commission's complaint alleges that Gasper first learned about the planned merger in late April or early May 1999, when Energy East was conducting due diligence. Gasper was asked to retrieve information for a "top secret" project and, by his own admission, correctly concluded that someone was "looking at the company." On the day of Gasper's trade, Gasper's supervisor scheduled a highly unusual meeting for 4:01 p.m. After learning of the meeting, Gasper concluded that a buyout announcement was imminent and executed his trade.

The complaint also alleges that Gasper tipped Fairfield. On the day of their trades, Fairfield telephoned Gasper shortly before the close of the market. Gasper informed Fairfield of the unusual 4:01 p.m. meeting, stated that the acquisition of CMP might be announced, and told Fairfield that he was going to transfer all of his 401(k) assets to the CMP stock fund. Minutes after the conversation, Fairfield executed his trade. The complaint also alleges that during the week prior to the announcement, Fairfield's supervisor cautioned Fairfield about trading in CMP stock.

Simultaneously with the filing of the complaint, Gasper and Fairfield, without admitting or denying the Commission's allegations, consented to the entry of a judgment permanently enjoining them from violating Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. Gasper and Fairfield also consented to an entry of a judgment requiring disgorgement of their trading profits, but a portion was waived due to inability to pay. Accordingly, Gasper agreed to pay \$65,000 and Fairfield agreed to pay \$30,000. [SEC v. Robert K. Gasper and James D. Fairfield, Civil Action No. 01-81-B, USDC, D. Maine] (LR-16972)

INVESTMENT COMPANY ACT RELEASES

WELLS FARGO FUNDS TRUST, ET AL.

An order has been issued on an application filed by Wells Fargo Funds Trust, et al., exempting applicants from Section 15(f)(1)(A) of the Investment Company Act. The order permits a registered investment company not to reconstitute its board of trustees following an acquisition of substantially all of the assets of three series of another registered investment company. SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the Philadelphia Stock Exchange to amend Phlx Rule 237 relating to decimal reporting, calculation methodology, and an expansion of the securities eligible for eVWAP trading (SR-Phlx-2001-10) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of April 23. (Rel. 34-44203)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted (SR-ISE-01-02) by the International Securities Exchange to prohibit anticipatory hedging activity. Publication of the order in the Federal Register is expected during the week of April 23. (Rel. 34-44208)

PROPOSED RULE CHANGES

The American Stock Exchange filed a proposed rule change (SR-Amex-2001-14) relating to members' written proposals to list equity option classes. Publication of the proposal is expected in the Federal Register during the week of April 23. (Rel. 34-44211)

The Options Clearing Corporation filed a proposed rule change (SR-OCC-2001-05) to allow OCC to clear and settle security futures for any national securities exchange registered under Section 6(a) or 15A(a) of the Exchange Act or any "designated contract market" (as that term is used in the Commodity Exchange Act) that is registered as a national securities exchange under Section 6(g) of the Exchange Act. Publication of the proposal is expected in the Federal Register during the week of April 23. (Rel. 34-44212)

DELISTING GRANTED

An order has been issued granting the application of the American Stock Exchange to strike from listing and registration the Common Stock, \$0.01 par value, of Avenue Entertainment Group, Inc., effective at the opening of business on April 25, 2001. (Rel. 34-44215)
