The United States Department of Agriculture, Soil Conservation Service and the Jasper-Pulaski State Nursery of the Indiana Department of Natural Resources announce the release of 'Affinity' Northern white cedar, Thuja occidentalis L.

'Affinity' Northern white cedar is an intermediate tree, growing to 25 meters in height, with a narrow pyramidal to oblong crown and a long tapering bole supported by a shallow, wide-spreading root system. The leaves are yellow-green and persistent, on leading shoots 0.6 centimeters long, glandular, and long-pointed, and on lateral branches scale-like and flattened, 0.3 centimeters long, obscurely glandular pitted, with the foliage sprays often fanlike. Cones are from 0.3 to 1.3 centimeters in length, erect and oblong. Seeds are released in fall, but the cones often persist through winter. Bark is from 0.3 to 1.3 centimeters thick, reddish to grayish brown and fibrous.

'Affinity' is a multiple use plant intended for use in field and farmstead windbreaks and as a screen or border planting in recreational and urban development. 'Affinity' shows promise for use as a windbreak on organic soils. In much of its range, Northern white cedar is an important source of winter browse. In all, 84 wildlife species (47 birds, 34 mammals, and 3 herpitiles) were identified as using the various developmental stages of the Northern white cedar community.

'Affinity' Northern white cedar is a relatively fast-growing compact, upright tree with good seeding vigor. It was collected at the Jasper-Pulaski State Nursery in Medaryville, Indiana. 'Affinity' has been evaluated at the Rose Lake Plant Material Center and in extensive field plantings throughout the Great Lakes Region. Northern white cedar is a native species and is widespread throughout this region.

performance has been very good and indicates that 'Affinity' should be adapted throughout the Great Lakes Region in plant hardiness zones 3, 4, and 5. Northern white cedar grows naturally in wet sites and on poorly drained soils but is also adapted to well-drained sandy loams.

'Affinity' is released as an open-pollinated seed propagated cultivar. Approximately 184,000 to 567,000 seeds are produced per pound. A seed orchard for 'Affinity' is established at the USDA Soil Conservation Service Rose Lake Plant Materials Center in East Lansing, Michigan. Seed and foundation 2-0 nursery stock will be maintained as 'breeders' material for distribution to public and commercial nurserymen.

DATA TO SUPPORT RELEASE OF 'AFFINITY' NORTHERN WHITE CEDAR

Cultivar : 'Affinity'

Accession No.: PI 477011, Mich-1468

Common Name: Northern white cedar

Scientific Name: Thuja occidentalis L. Symbol: THOC2

<u>Description</u>: 'Affinity' Northern white cedar is an intermediate tree, growing to 25 meters in height, with a narrow pyramidal to oblong crown and a long, tapering bole supported by a shallow, wide-spreading root system. Leaves are yellow-green and persistent, on leading shoots 0.6 cm. long, glandular, and long-pointed, and on lateral branchlets scalelike and flattened, 0.3 cm. long, obscurely glandular-pitted, with the foliage sprays often fanlike. Cones are from 0.3-1.3 cm. in length, erect and oblong. Seeds are released in fall, but the cones often persist through winter. There are from 184,000 to 567,000 seeds per pound. Bark is from 0.3-1.3 cm. thick, reddish to grayish brown and fibrous.

<u>Origin</u>: 'Affinity' is a relatively fast-growing compact, upright tree with good seeding vigor. It was originally collected at the Jasper-Pulaski State Nursery in Medaryville, Indiana.

<u>Uses</u>: 'Affinity' is a multiple use plant intended for use in field and farmstead windbreaks and as a screen or border planting in recreational and urban development. 'Affinity' shows promise for use as a windbreak on organic soils. In much of its range, Northern white cedar is an important source of winter browse. In all, eighty-four wildlife species (47 birds, 34 mammals, and 3 herpitiles) were identified as using the various developmental stages of the Northern white cedar community.

<u>Performance</u>: A comparative evaluation (Project 26A060K) was established at the Rose Lake Plant Materials Center in 1980. Ten plants per accession for ten accessions were randomized and planted in along, single row to account for soil changes, slope and exposure. The three most promising accessions from the evaluation were 9005060, provided by the Wisconsin Department of Natural Resources (DNR), 9019783, from a commercial nursery, and 'Affinity' (477011) from the Indiana DNR. It was decided in 1987 to continue final evaluations leading to release of one of the three.

Concurrently, with on Center evaluations, field plantings were carried out with 9005060 and 'Affinity', the two most promising accessions for which a dependable seed source was identified. Overall, 'Affinity' was found to be superior to 9005060 in nearly 40 field plantings in Michigan, Indiana, and Wisconsin and was chosen for release.

'Affinity' compared most favorably to a number of similarly used species in various field plantings including silky dogwood (Cornus amomum), autumn olive (Elaeagnus umbellata), Sargent crabapple (Malus sargentii), Manchurian crabapple (Malus baccata v. mandshurica), amur maple (Acer ginnala), and others.

Adaptation: 'Affinity' should prove adapted throughout the Great Lakes region within the zone of natural occurrence for Northern white cedar. Thus, 'Affinity' should be adapted to plant hardiness zones 3, 4, and 5.

<u>Soils</u>: 'Affinity' Northern white cedar grows naturally in wet sites and on poorly drained soils but is also adapted to well-drained sandy loams.

Propagation: 'Affinity' is a seed propagated cultivar. Seedlings are easily grown by sowing untreated, cleaned seed in the fall. Average seedbed density should be about 530 seedlings per square meter. Sowing depth should vary between 0.3 to 0.8 centimeters. Half shade over the seed beds is recommended during the first growing season. Cones may be picked by hand or they may be flailed or stripped onto a sheet of canvas, burlap or plastic. Seeds should be collected between mid-September to late October. Kiln drying is needed to extract seed from large quantities of cones. Seeds of Northern white cedar have been opened by exposing them for 4 hours in an internal-fan type kiln to a temperature of 45 C and a relative humidity of 38%. Small quantities of cones can be opened by drying at room temperature for a longer time. After cones have been opened, seeds may be shaken out in a mechanical cone shaker and separated from the cone scales by fanning. Seeds should not be dewinged.

Method of Establishment: 'Affinity' Northern white cedar can be successfully established using 3-0 planting stock by following the normal planting procedures for bare-root trees. Weed, grass, and deer and rodent control is necessary for good establishment and uniform growth. This can be obtained through cultivation, mowing, and after the establishment year, application of approved herbicides. Spacing for windbreak planting is 183-305 cm (6-10 ft.).

Disease, Insect and, Animal Damage: No serious disease or insect damage has been observed to limit 'Affinity' Northern white cedar's growth. Deer browse and rodent damage have been observed in some plantings.

Sources of Seed and Planting Stock: The USDA, Soil Conservation Service, Rose Lake Plant Materials Center, 7472 Stoll Road, East Lansing, Michigan 48823, will maintain breeder seed and foundation stock of 'Affinity' Northern white cedar. Breeder seed and foundation stock will be made available for distribution to public and commercial nurseryman.
