And keep watching this space.



MOL Increased for Law Enforcement, Security Equipment

Under Schedule 84 VI A, Law Enforcement and Security Equipment, the Maximum Order Limitation (MOL) has been increased to \$3,000,000 for Special Item Number 426-4K, Metal and Bomb Detection Equipment including Airport Security. Due to the urgent requirement for placing security equipment (walk-through metal detectors and X-ray units) in Federal buildings and installations, increasing the MOL enables ordering agencies to expedite the procurement process by placing one order for all facilities under that agency's jurisdiction. Placing Orders Via Retail On-Line Customer Sales (ROCS)

The Office of Distribution Management (FS) had hoped to offer an Internet version of ROCS this Spring, but like many other agencies, we've had to redirect scarce resources. In our case this means focusing on enhancements to GSA Advantage!, which should soon provide an Internet replacement capability for ROCS customers. In the meantime, customers may continue to place CSC orders via their desktop computer using ROCS.

We are dedicated to being your most responsive and cost-effective source of supply, with ordering options by telephone, mail, fax, and ROCS - and we'll keep you posted on when we add our Internet connection.

GSA Creates Separate Policy Office

Areas Affected Include Personal and Real Property, Information Technology

GSA has separated the policy-making functions from operations in personal property, real property, and information technology, and put them into a new GSA organization called the Office of Policy, Planning, and Evaluation (OPPE). This has been done in response to a National Performance Review initiative, because it makes sense. The purpose is to make sure that governmentwide policy is developed from a governmentwide perspective, considering the needs of everyand avoiding involved appearance of potential conflict with GSA operations.

OPPE's primary direction is to work with all stakeholders, inside and outside the Federal Government, using collaborative processes to promote Federal economy and efficiency by developing guidance and facilitating operations. What does this mean? OPPE is going to ask everyone involved to participate in working out legislative proposals, regulations, and guidance, so that these policies will work as well as possible. This policy-making model has worked well in several areas already, and OPPE is putting it into practice in all of its assigned areas. OPPE is also creating ways of developing and

publicizing policy through the Internet and other electronic means.

One excellent example is the forthcoming changes in the travel regulations. An interagency committee spent over a year reviewing the travel rules and identified a long list of improvements. GSA is now issuing the actual regulations, and Congress will shortly begin to consider legislative changes. These changes will make travel much easier and more efficient for travelers, budget, and administrative personnel.

OPPE is now responsible for government-wide policy, legislative, and regulatory issues previously managed by GSA's Federal Supply Service (FSS) as follows:

For personal property, this includes government-wide policy and regulations for utilization, donation, and sales, plus most government-wide regulations concerning supply and logistics. Operation of the utilization, donation, and sales programs remains with FSS.

For vehicles, this includes governmentwide policy, regulations, safety, and energy conservation issues, and the Interagency Motor Equipment Management Committee. All matters involving the operation of the Interagency Fleet Management System remain with FSS.

For aircraft, this includes all functions previously performed within the FSS Office of Transportation and Property Management.

For travel and transportation, this includes government-wide policies, procedures, and regulations concerning: Transportation audits and payments; Bulk and small package freight; Household goods shipment; Mail; and Travel, including developing per diem rates.

Management of the actual operations and contracts in all of these areas except mail remains with FSS.

Policy-making responsibilities have also been reassigned to OPPE from the Public Buildings Service, the Information Technology Service, and various other parts of GSA.

Property Management

Federal Disposal System (FEDS): Computer & Software Requirements

Interest in the Federal Disposal System (FEDS) is accelerating at a rapid pace. There are currently over 1,200 Federal and state agency users with access codes and passwords needed to access the property management system. Accordingly, we are being asked questions on connectivity and system requirements for hardware and software on a daily basis. The most frequently asked questions, with answers, are printed below:

1. How powerful must my computer be to access FEDS?

--- The size of your computer will depend on the type of communication software being used. If you are using DOS programs, such as Procomm+, A 286 personal computer (PC) is sufficient. However, if you are using a Windows program to communicate with FEDS, a 486 PC with a minimum of 4 megabytes of RAM is recommended.

2. What size modem should I use?

-- Modems should have a BAUD rate between 9600 bits per second (bps) and 28.8K-bps. Anything below a 9600 BAUD rate will be annoyingly slow.

3. What protocol settings should I use to configure my communications software?

-- Protocol settings for the communication software are determined by the modem settings established at the receiving end by GSA. These settings are as follows:

Data Bits: 8 Stop Bits: 1 Parity: None Duplex: Full Don't let the parity designation "O" mislead you. The letter "O" means "odd" parity--not "zero" or "none".

4. <u>How should I input the phone number of the asynchronous terminal server to call up FEDS?</u>

-- Federal activities can now dial an 800 number to access the data base containing the nationwide inventory of excess and surplus personal property. The toll free number is 1-800-319-5260. Precede the 10-digit telephone number, including area code, with a "1." Do not separate the parts of the telephone number with a dash or hyphen. Do not use commas in the dial string unless you need to wait for a dial tone in the normal course of dialing the phone number. If you need to use commas, as is the case with credit card dialing, use one comma for every 3 seconds of pause required to get the dial tone.

5. What kind of communications software do I need?

-- Any communications software with a VT 100 emulation package should work. Procomm+ is a common communications package used, and it is available in both the DOS and windows versions. A VT 100 package is also available in Windows 3.1.

6. <u>Must my computer be an IBM compatible, or can</u> I use a Macintosh?

-- Any computer using a VT 100 emulation package can access FEDS.

Reporting Property To GSA

Are you tripping over office furniture, office machines, and other items no longer needed to conduct your day-to-day business?

Why use your limited funds to pay storage costs on property you are not using now and will probably not use in the future?

To obtain GSA assistance, excess property should be reported to GSA on a Standard Form (SF) 120, at least 60 days prior to required removal date.

Direct Transfers

Your Federal neighbor in the next office may be able to use your excess property!

A direct transfer can be made between Federal agencies with a minumum amount of paperwork. Based on the original acquisition cost of the property involved, a Standard Form (SF) 122, completed by the receiving agency, may be the only form needed.

Acquiring Excess Property Through GSA

Budgetary restraints have given new importance to excess property. Make your dollars go farther by remembering: excess property is your FIRST source of supply.

Call about our new Electronic Screening. Property located in all areas of the country is now listed on the computer and is available.

If you have new Property Officers, or Property Custodians, GSA will provide guidance in all areas of Property Management.

GSA PREFERS RE-REFINED OIL USED IN THEIR VEHICLES!

Do you service GSA vehicles under a cross-service agreement? If so, do you use re-refined oil in the oil changes? In a 1995 letter signed by Lester Gray, Jr., Director, Fleet Management Division for GSA, it states that re-refined oil should be used in Interagency Fleet Management System (IFMS) vehicles when available. This GSA letter specifies that the use of re-refined oil is contingent upon the oil meeting current American Petroleum Institute (API) performance classifications, having the proper grade (i.e., 10W-30 etc.), and having pricing equal to or less than the virgin equivalent.

In complying with the requirements of section 6002 of the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act (RCRA) 42 U.S.C. 6962, Defense Supply Center Richmond (DSCR) awarded a contract for SAE 10W-30 engine oil in accordance with Commercial Item Description (CID) A-A-52039. This engine oil, which is intended for use in administrative type commercial vehicles, contains a 25% minimum re-refined base stock and meets the API SH performance category and the International Lubricant Standardization and Approval Committee (ILSAC) GF-1 Standard. In order to provide the Services with an added level of confidence, all technical data submitted in support of the CID requirements have been reviewed by the U.S. Army Tank-Automotive and Armaments Command, Mobility Technology Center- Belvoir, prior to contract award. Furthermore, the U.S. Army Petroleum Center has endorsed the use of this engine oil as a suitable substitute to engine oil containing virgin base stock and meeting the same CID requirements.

In addition to GSA and the Army Petroleum Center, there are other advocates for the use of re-refined engine oil. As stated in a message from Marine Corps Headquarters, re-refined motor oil meeting the API SH performance classification and ILSAC GF-1 Standard shall be the preferred motor oil for garrison mobile equipment and shall be used in place of virgin motor oil.

Also in support of the use of re-refined oil, the Air Force, Army, and Department of the Interior have all sent out messages regarding the availability of re-refined oil from DSCR. The United States Postal Service has already been a satisfied user of re-refined oil, winning the Presidential Closing the Circle Award for their progress in implementing the use of re-refined motor oil in their fleet. Copies of these messages are available on request.

Re-refined oil may be ordered via MILSTRIP/FEDSTRIP requisitions. This product is available in a box of 12 one-quart bottles (BX), a five gallon container (CO), or a 55 gallon drum (DR) under the following National Stock Numbers (NSNs). Look at the great FY 96 prices!

By requisitioning re-refined oil from DSCR, procuring agencies that purchase \$10,000 or more of lubricating oil during a fiscal year, such as GSA, can avoid the costs associated with establish-

ing their own affirmative procurement program. This affirmative procurement program must meet the requirements of section 6002(i) of RCRA, and include a preference program; a promotion program; procedures for obtaining estimates and certification of recovered materials content and for verifying the estimates and certifications; and an annual review and monitoring program. As a free service to DSCR customers, to meet their annual review and monitoring requirement, both the total quantity of lubricating

oil requisitioned, and the quantity of lubricating oil containing rerefined oil can be provided on request.

DLA to Provide Disposal Support to GSA

DLA and the General Services Administration (GSA) have signed a Memorandum of Understanding (MOU) which establishes policies and procedures for the DLA to provide support to GSA for disposing of Federal excess and surplus property. The agreement, signed by Maj. General William P. Hallin, Deputy Director of Material Management at DLA, and Frank P. Pugliese, Jr., Commissioner of GSA's Federal Supply Service, became effective as of January 26, 1996.

Under the provisions of this MOU, DOD standard turn-in procedures (outlined in DOD 4000.25.M.I and DOD 4160.21.M) will be used and the Defense Reutilization and Marketing Offices (DRMOs) will be reimbursed for their services. When turning in excess property, the Federal civil agencies (FCA) will be responsible for delivering the property to the DRMOs; DLA personnel will not pick up property at the holding installation. In addition, the FCA is required to have a valid FEDSTRIP number.

DRMOs reserve the right to return any turn-in for cause such as incorrect documentation, heavy DRMO workload or property not normally accepted.

Once DRMS has accepted accountability of the turned-in property, it will be screened by the same method as all other DOD excess property with one exception.

Property will not be made available to those special program organizations who, because of enabling legislation, may only obtain DOD excess. Such activities include Humanitarian Assistance Programs, Regional Logistical Support Offices and Service Educational Activities.

Please note that DRMOs will not accept, and the Federal civil agencies should not turn in, the following types of property:

Arms, ammunition, explosives, dangerous articles, hazardous property; Federal Supply Class 6505 (drugs, biological and reagents); Subsistence items; Trash and waste material which DLA would have to pay to dispose of; Classified property; Other types of property as agreed to by DLA and the civil agencies.

Mail Management

July 1 the Date For Major Mailing Changes

For those of us in the mailing industry, the ancient Chinese curse has come true -- We do live in interesting times. Postal Classification Reform took effect on July 1. Are you ready?

But let's back up a minute and recap how we got to this day.

Several years ago, the United States Postal Service (USPS) decided to examine the very basis of the way they do business with their customers. Scores of meetings produced a new classification scheme for mail -- First Class is still First Class but Second has become "Periodicals," and Third/Fourth are now known as "Standard," with other changes to follow for Express Mail, Priority Mail, special services, and the non-profit rate categories.

But the major change is the rationale for giving mailers rate incentives (read: postage discounts) for presorting and barcoding mail. While it used to be that the lion's share of the discount was for presorting, now the emphasis is on automation, especially on the ability of an address to receive a delivery point barcode.

It's really quite simple to understand. USPS processes and delivers 580 million pieces of mail each day. The only way to do this is to rely on high speed, automated equipment to sort as much of this mail as possible and these machines, in turn, rely on mail having delivery point barcodes.

And, to get to the real bottom line of all of this, delivery point barcodes rely on machineable mail pieces with readable addresses that contain all the complete and accurate information necessary to obtain the correct delivery point barcodes. To ensure this, USPS is requiring mailers to take certain steps, such as using the National Change of Address (NCOA) System, endorsing mail for Address Correction Requested, or participating in Address Change Service.

But now, in addition to having a correct barcode, in order to qualify for a discount postage rate, a mail piece must also be prepared for presort according to new regulations. After July 1, there is no rate incentive for nonpresort, barcoded mail.

It's true that if you're paying 32 cents now, life won't necessarily change for you after July 1, except, of course, with deeper discounts for automation mail, people will start asking more frequently why your agency isn't taking advantage of the opportunity to save money and get better service at the same time.

You say you don't know how to get started? There are places to get help. Your first stop should be the local USPS Business Center. USPS is conducting 5,000 classes nationwide to educate customers about the changes. Make sure you're one of those customers.

Postal Customer Councils are also offering training sessions and with them comes the opportunity to network with other mailers in your area who are facing the same challenges you are.

Work with your Account Representative and read trade journals and magazines. Attend the National Postal Forum or MAILCOM in the Fall, if possible.

And, if you're already working with a contractor for third-party worksharing, that contractor should be working with you to improve your addressing, enhancing the qualifying rate for your mail and thus increasing your savings and their profit.

Most importantly, don't overlook the resources in your own chain of command. Your agency mail managers have been planning how your organization as a whole can meet the challenges of Classification Reform and can help you with your individual situations.

Yes, we live in interesting times.

And as long as we're in the mailing industry, we'll never be bored!


