Report Highlights:

Imports of tobacco are expected to decline approximately 29 percent, from 44,347 MT in CY01 to 31,400 MT in CY02. New government excise and prices structures have forced cigarette prices to increase, resulting in declining cigarette consumption from 199 billion sticks in CY01 to 180 billion sticks in CY02. Post estimates cigarette production to decline from 199.3 billion sticks in CY01 to 178.3 billion sticks in CY02. Post estimates dry tobacco leaf production in CY01 is 146,100 MT and 144,700 MT in CY02.

SITUATION AND OUTLOOK

Unmanufactured Tobacco

Production

There has not been any significant expansion in Indonesia's tobacco crop in 2002. Special partnership projects exist between large cigarette companies and small farmers in Lombok, which have resulted in higher quality tobacco. In these projects, large cigarette manufacturers provide farmers with high quality seeds, fertilizer/pesticide, and technical assistant on farming practices, post harvest and the curing processes. Farmers then sell their tobacco leaves back to the companies at a set price. In other cases, tobacco leaves are sold by small farmers to traders/middlemen in the form of cut tobacco leaves. Traders/middlemen cure the leaves for 2 to 3 days before reselling them to cigarette companies. In Java, where large cigarette manufacturers are concentrated, farmers sell their crops directly to cigarette companies for use after being aged for 1.5 years. Indonesia's total production in CY01 (January-December) reached 172,200 MT farm sales weight or 146,100 MT dry weight basis. Due to low farmgate prices for tobacco leaves and high production costs, yields have declined from an average of 840 kilogram/ha in CY01 to 830 kilogram/ha in CY02. As a result, Post forecasts tobacco production to decline to 170,150 MT farm sales weight or 144,700 MT dry weight basis in CY02. Industry sources report that current domestic tobacco leaf quality is good, as dry weather conditions during the harvest (August-October) were favorable for Indonesia's tobacco crop. Compared to imported tobacco leaves, local tobacco leaves have higher sugar, tar (27.2 mg to 44.8 mg) and nicotine content (2.4 mg up to 6.6 mg) per cigarette stick.

Consumption

Industry sources indicate that tobacco leaves command nearly 60 percent of the total raw material used for cloves cigarettes. Post revised total tobacco leaf consumption figures for CY00 to 170,540 MT, to reflect the actual excise tax paid by cigarette producers. Estimates of tobacco leaf consumption in CY01 have been lowered to 166,125 MT, in line with official excise statistics and the decrease in cigarette production. Post's forecast for CY02 tobacco leaf consumption is 155,140 MT, as industry anticipates further declines in cigarette production, due to the GOI's new price and excise taxes structure (see Policy Section), which will cause retail cigarette prices to increase. As a result, import volumes are expected to decline from 44,347 MT in CY01 to 31,400 MT in CY02. Tobacco leaf consumption is primarily price driven in relation to Indonesian consumers purchasing power for cigarettes.

Prices

While the cost of domestic tobacco production is approximately Rp. 30,000/kg (US\$ 3.37/kg using Rp. 8,900/US\$1 exchange rate), current farmgate prices for tobacco leaves range from Rp. 20,000 (US\$ 2.24/kg) to Rp. 25,000/kg (US\$ 2.80/kg), compared to imported tobacco leaf prices from China - US\$2 - \$3/kg (66 percent

of market share), Zimbabwe - US\$5/kg (7 percent of market share), and USA - US\$8 - \$9/kg (5 percent of market share).

Manufactured Tobacco

Indonesia's manufactured tobacco industry produces several types of tobacco products, with clove cigarettes ("kretek") and white cigarettes dominating the market (approximately 90 percent of total production). It is estimated that Indonesia's manufactured tobacco industry has a labor force of nearly 5 million people–from tobacco farmers, cigarette company employees, clove farmers to street vendors.

Production

Hand-rolled clove (kretek) cigarettes, known as Sigaret Kretek Tangan (SKT), production decreased by less than 1 percent in CY01, while the machine-rolled kretek cigarettes (SKM - Sigaret Kretek Mesin) decreased by 8 percent. Based on official excise tapes that were purchased by the manufacturers, the estimates for clove or "kretek" cigarette productions (for hand-rolled or SKT and machine-made or SKM) in CY00 and CY01 are 207.6 billion sticks and 197.9 billion sticks respectively, and estimates for CY02 are 178.2 billion sticks, down almost 10 percent from previous year.

The government added a company classification of a "very-small" for the hand-rolled clove cigarette industry as many of them produce much smaller numbers of cigarettes (maximum production is 6 million per annum) but employ a large number of workers. The minimum retail price for the hand-rolled clove cigarettes is set at Rp. 175/stick and maximum Rp. 220/stick and they are subject to a 4 percent excise tariff.

With 12 member companies in Indonesia, the white cigarette industry association (GAPRINDO-Gabungan Produsen Rokok Putih Indonesia) indicated that their market share for manufactured cigarettes in CY00 and CY01 was around 10 percent, compared to 22 years ago (1980), when they can produced 33.5 million sticks and enjoyed a market share of approximately 40 percent. The loss in market share for white cigarettes is due to their higher retail price and an ongoing shift in consumer preference for clove cigarettes. The "kretek" cigarette manufacturing industry also continues to pick up market share because of it's aggressive marketing and advertisement strategies to sell it's product as "modern and trendy".

Based on GOI excise revenues for cigarettes, Post revised total cigarette production in CY00 to 232.7 billion sticks, CY01 to 221.3 billion sticks, and for CY02 estimates have been revised downward to 200 billion sticks, reflecting nearly a 10 percent decline in sales. Industry sources indicate that there was a major decline in the SKM market by almost 10 billion sticks in CY01. Sales have continued to decline, due to increasing prices set by the government for excise revenues and minimum retail price structures.

Consumption

The major consumers of the cigarette's in Indonesia are the middle-lower income population which make up nearly 35 percent of the population (approximately 212 million people in 2002). The purchasing power of this group has slightly declined, due to GOI increased utilities costs, consumers have less money to spend on luxury items like cigarettes. In addition, increases in cigarette prices will also reduce domestic cigarette consumption. As a result, total cigarette consumption (kretek and white cigarettes) in CY01 was 199 billion sticks, and the forecast for CY01 is expected to decline another 10 percent to approximately 180 billion sticks.

Price

Cigarette prices are set according to a government regulation which is based on the company classification (see table of Minister of Finance Decree No. 121/KM.4/2002 - dated: January 31, 2002). The government revises this regulation each year, in an attempt to increase revenue from excise taxes. For CY 2002, the target revenues continue to increase to Rp. 22.3 trillion (US\$ 2.5 billion using Rp. 8,900/US\$1 exchange rate), compared to Rp. 17.1 (US\$ 1.9 billion) in CY01.

Policy

The government excise tax regulation imposes a minimum retail price and excise structure for all cigarettes (please refer to Table 15: "Classification of Tobacco Product Manufacturers"), effective as of December 1, 2001.

With Ministry of Finance decree No. 597/KMK.04/2001, the government set classifications of cigarette manufacturers into three main classes: large companies with annual production volume of more than two billion sticks; medium companies with production ranging between 500 million to 2 billion sticks; and, small companies with total production less than 500 million sticks per annum. Other than white cigarette (Sigaret Putih Mesin or SPM) and machine-made clove cigarette (Sigarete Kretek Mesin or SKM), other tobacco products have additional classifications, for companies with an annual production volume not more than 6 million sticks including hand-rolled clove cigarette (Sigaret Kretek Tangan or SKT), corn-husked wrapped clove cigarette (Klobot or KLB), and incense clove cigarette (Kelembak or KLM) and companies with production less than 3 million sticks per annum for cigars (CRT-cerutu). This classification will determine the level of excise and the minimum retail price of the product.

The revenue from cigarette excise was targeted to reach Rp. 22.3 trillion in 2002, and is planned to be increased by 24 percent to Rp. 27.6 trillion in 2003. According to Post sources, the target for 2002 is not likely to be reached due to the decline in sales, as retail prices increased.

The GOI has requirements for lower nicotine and tar content of cigarettes. Government regulation No. 38/2000 dated June 7, 2000, which would be effective in 2007 for machine-made white cigarettes (SPM) and machine-

made clove cigarettes (SKM) and effective in 2010 for hand-rolled clove cigarettes (SKT), requires that nicotine and tar content per stick of cigarette be lowered to 1.5 mg and 20 mg respectively.
