## COMMANDANT INSTRUCTION **5527.2**

- Subj: INVESTIGATIONS INTO ADULT PRIVATE CONSENSUAL SEXUAL MISCONDUCT
- Reff: (a) Title 10, United States Code, Sections 801-940 (Uniform Code of Military Justice, Articles 1-140)) (b) INVESTIGATIVE ASSISTANCE ((COMDTINST 5520,5(series)))
- 11 <u>PURPOSE</u>. This Instruction establishes policy regarding the initiation of criminal investigations into sexual misconduct, as defined herein. It provides that, as a matter of investigative priorities and resource limitations, **U. S.** Coast Guard Investigations (**CGI**) will normally refer allegations involving only adult private consensual sexual misconduct to the service member's commanding officer for appropriate disposition. It also provides that **CGI** may return a request for a criminal investigation to the commanding officer if **CGI** has independently determined that the request lacks credible information or is not in keeping with established policy.
- 2. <u>ACTION</u>. District Commanders (**Ole**/**oii**/**dii**) shall ensure their staff and special agents are thoroughly versed in the contents of this Instruction and that investigative procedures detailed herein are implemented.
- 3. <u>DISCUSSION</u>. On **28** February **1994**, the Secretary of Defense implemented new regulations on homosexual conduct in the Armed Forces of the United States of America. On **15** March **1994**, the Secretary of Transportation directed the Coast Guard implement regulations paralleling those issued by the Department of Defense. Relative to criminal investigations, the new regulations state that **"no**
