Area Command Team (Zimmerman) is assigned to manage incident prioritization and resource allocation for fires burning in southwest Montana.

**Black Cat**, Southwestern Land Office, Montana DNR. IMT 1 (Martin). Started on private land five miles northeast of Frenchtown, MT. Hardwood timber, logging slash and grass. Surface runs with isolated torching. Community of Evaro, Highway 93, railroad infrastructure and power transmission lines threatened. Evacuations in effect.

**Jocko Lakes**, Flathead Agency, BIA. IMT 1 (Wilcock and Hoff). Twenty-six miles northeast of Missoula, MT. Timber with dead and down lodgepole pine. Creeping and smoldering with single tree torching. Numerous structures threatened. Evacuations in effect. Precipitation over the fire area occurred yesterday.

**Sawmill Complex** (four fires), Lolo NF. IMT 2 (McNitt). Twenty-two miles southeast of Missoula, MT. Timber and grass. Active ground fire with single tree torching. Numerous structures threatened.

**Rombo Mountain**, Bitterroot NF. IMT 1 (Quesinberry). Eighteen miles south of Darby, MT. Bug-killed timber. Minimal fire activity. Structures threatened. Precipitation occurred over the fire area yesterday.

**Bitterroot Fire Use Complex** (13 fires), Bitterroot NF. FUMT (Perkins). Fifteen miles west of Darby, MT. Timber and grass. Creeping, smoldering and backing fire.

**Rat Creek**, Beaverhead/Deerlodge NF. IMT 2 (Kaage). IMT is also managing Pattengail Creek fire. Twenty-five miles west of Wisdom, MT. Timber. Creeping and smoldering. Structures, historic and cultural sites threatened.

**Pattengail Creek**, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber with dead and down fuels. Backing fire with creeping and smoldering. Residences threatened.

Conger Creek, Lolo NF. Twenty miles north of Ovando, MT. Timber. Creeping and smoldering.

**Chippy Creek**, Northwestern Land Office, Montana DNR. IMT 1 (Bennett). Forty-two miles southwest of Kalispell, MT. Timber, dead and down lodgepole pine and logging slash. Minimal fire behavior. Residences threatened. Evacuations in effect.

**WH Complex** (2 fires), Gallatin NF. IMT 1 (Stanich). Twenty-seven miles south of Livingston, MT. Timber. Creeping and smoldering. Structures threatened. Evacuations in effect. Precipitation occurred over the fire area yesterday.

**Rattlesnake**, Nez Perce NF. IMT 2 (Kusicko). Twenty-five miles south of Elk City, ID. Timber and grass. Minimal fire activity. Community of Concord, ranches and recreation sites threatened. Precipitation occurred over the fire area yesterday.

**Brush Creek**, Flathead NF. Florida IMT 2 (Hill). Twenty-five miles west of Whitefish, MT. Timber with heavy dead and down fuels. Creeping and single tree torching. Structures threatened.

**Skyland,** Flathead NF. IMT 2 (Heintz). Thirty-two miles east of Kalispell, MT. Timber and grass. Creeping and smoldering with isolated torching. Structures threatened. Precipitation occurred over the fire area yesterday.

**Fool Creek**, Lewis and Clark NF. FUMT (Lineback). FUMT also managing the Ahorn fire. Thirty miles northwest of Choteau, MT. Timber and snags. Minimal fire activity. Precipitation occurred over the fire area yesterday.

**Bridge**, Clearwater NF. Forty-five miles southwest of Missoula, MT. Timber and brush. No further information received.

**Ahorn**, Lewis and Clark NF. Thirty miles west of Augusta, MT. Timber. Creeping and smoldering. Structures threatened. Light precipitation occurred over the fire area yesterday.

**Last Day**, Charles M. Russell NWR. Thirty five miles north of Winnett, MT. Timber and grass. Creeping and smoldering. Reduction in acreage due to more accurate mapping.

Columbine 1, Yellowstone NP. Fifty-three miles west of Cody, WY. Timber. Creeping and smoldering.

Meriwether, Helena NF. Thirty-four miles northwest of Helena, MT. Timber, brush and grass. Smoldering.
