ORDER REVOKING FOREIGN CERTIFICATES

By Order 2008-8-24, issued August 25, 2008, we revoked the Section 41102 interstate certificates of public convenience and necessity issued to Custom Air Transport, Inc., by Order 95-12-15 and Order 97-10-1.

By this order, we are revoking the company's companion foreign certificate authority. Instead of repeating our findings and conclusions in Order 2008-8-25, we incorporate them here by reference.

ACCORDINGLY,

- 1. We revoke the certificates of public convenience and necessity issued to Custom Air Transport, Inc., by Order 97-10-22 and Order 2007-7-4, authorizing it to engage in foreign air transportation.
- 2. Unless disapproved by the President of the United States under section 41307 of Title 49 of the United States Code, this order shall become effective on the 61st day after its submission for section 41307 review or upon the date of receipt of advice from the President or his designee under Executive Order 12597 and implementing regulations that he or she does not intend to disapprove the Department's order under that section, whichever occurs earlier.¹

¹ This order was submitted for section 41307 review on August 25, 2008. The 61st day is October 27, 2008. Since the President or his designee did not disapprove this order before that date, it became effective on October 27, 2008.
