To vote for presidential electors to be selected by candidates for president and vice-president whose names are not printed on the ballot, write the persons' names in the appropriate blank spaces and darken the oval  at the left of the names of the candidates.

To vote for a person whose name is printed on the ballot, darken the oval  to the left of the person's name. To vote for a person whose name is not printed on the ballot, write the person's name in the blank space and darken the oval  to the left.
